

**SPECIAL MEETING MINUTES**

**August 22, 2017**

The special meeting of the Board of Trustees of Challis Joint School District No. 181 was held at Challis Idaho at the Challis Middle School Board room at 12:00 p.m. on the 22nd day of August, 2017 as provided in Sections 33-510 and 74-206 et seq Idaho code.

Trish Farr moved to approve Salmon River Propane as low bidder for propane at .95/gallon, \$40.00/hr. for labor plus parts, and no charge for tank rentals. Jim Chamberlain seconded the motion. Vote 4-0 Motion carries. The Board received one bid for fuel and diesel fuel. Bid was received from Kimble Oil. Janiel Parkinson moved to approve Kimble Oil as low bidder at \$2.129/gal. for fuel, \$2.209/gal. for diesel fuel and \$2.17/gal. for Patterson fuel. Trish Farr seconded the motion. Vote 4-0 Motion carries. The Board received only one bid for garbage service from Blue Mountain Refuse. The bid submitted was for \$1241.00/month with a \$200.00/month donation back to the District, no charge for the football field garbage pick-up and a \$48.00 will call for Stanley school. Trish Farr moved to approve Blue Mountain Refuse bid for garbage service for the 2017-2018 school year. Jim Chamberlain seconded the motion. Vote 4-0 Motion carries. Tom Coates from Salmon River Propane presented the Board with a check for the District for the Salmon River Propane Educational Program in the amount of \$587.63. The Board thanked Mr. Coates.
