#### **PART 1 – PROJECT INTRODUCTION**

Faribault Public Schools, in partnership with Trust for Public Land (TPL), is seeking proposals from qualified and licensed design and construction firms capable of providing professional services, including schematic design, design development, construction documents, and turn-key construction of a nature-based, park-like schoolyard improvement project at Jefferson Elementary School in Faribault, MN.

#### GOAL AND OBJECTIVES

Faribault Public Schools, in partnership with Trust for Public Land (TPL), intends to build a 'Community Schoolyard.' A Community Schoolyard is an outdoor school space reimagined to address health, equity, and climate issues.

- Park-like Places: Community Schoolyards function like parks. They are packed with natural features, community gathering spaces, art, water management features, play and athletics, and outdoor learning facilities.
- Designed by the Community: Community Schoolyards are designed by the community, for the community, through a dynamic participatory design process.
- Designed with Intention: Community Schoolyards are designed in a manner that improves health, combats inequities, mitigates the impacts of climate change, and enhances learning.
- Welcoming to Everyone: Community Schoolyards are shared spaces that are open, accessible, and welcoming to the public.

#### SCOPE OF WORK

This RFP intends to identify qualified design and construction firms capable of designing and constructing a safe, accessible, innovative, easy-to-maintain, nature-based schoolyard space. The Scope of Services as outlined in this RFP may not include all services required to complete the Project. The Vendor shall be responsible for determining the extent of information needed to reach proper project completion.

Selected Vendor will be responsible for the design, provision, and installation of a new Community Schoolyard. Vendors are encouraged to be creative in their designs, maximize the role of unstructured play, and incorporate nature in their proposals.

Vendors should base their schoolyard design on meeting all accessibility and safety standards as well as the guidelines and specifications listed in this RFP. Quality of design, play value, learning value, environmental value, cost, and appropriateness to location and target demographic must be considered in the schoolyard's design.

#### BUDGET AND FUNDING

Funding is made possible through the support of the Legislative-Citizen Commission on Minnesota's Resources (LCCMR) through funding from the Environment and Natural Resources Trust Fund (ENRTF). Currently, the project budget is \$150,000. This includes all design, demolition/removal, freight, tax, installation, capital costs, and all other associated improvements.

Money from the ENRTF may be spent for:

- Enhancement of public education, awareness, and understanding necessary for the protection, conservation, restoration, and enhancement of air, land, water, forests, fish, wildlife, and other natural resources;
- Capital projects for the preservation and protection of unique natural resources;
- Activities that preserve or enhance fish, wildlife, land, air, water, and other natural resources that otherwise may be substantially impaired or destroyed in any area of the State;

Therefore, the focus of this schoolyard improvement project should be the improvement, enhancement, and incorporation of natural resources and outdoor education into the schoolyard. Additional details are provided in Part 2 of this RFP.

The Vendor must provide a design at all phases included in this Project, which should be built into the budget, including a 15% contingency. Cost considerations shall be used by the Vendor as a design management tool during design and at each of the design phases. All cost estimates shall be based on the Vendor's knowledge of recent similar work and the current local market. If the Vendor proposes a streamlined, cost-effective process, we may consider adjustments to the Project approach and phasing.

Trust for Public Land and school partners are actively fundraising for this Project. If additional funding is secured, the project budget may increase but is not anticipated to exceed an additional \$300,000. Based on funding availability, the team may consider expanded project scope. The following options for additional amenities shall be considered:

- Traditional playground equipment
- Sports, games, and turf (soccer is a community priority)

- Shade structure(s)
- Additional landscaping
- Public art
- Accessibility improvements

#### **SELECTION**

The design-build firm will be selected by the Faribault Public School Board, following a recommendation by a review team consisting of staff from Jefferson Elementary, Faribault Public Schools administration, and Trust for Public Land. Firms will be judged based on items including but not limited to:

- Project understanding
- Project approach, design, and creativity
- Past experience and references
- Propose timeline
- Purchase price/budget
- Warranty and warranty service history
- Non Warranty and non-warranty service history

Faribault Public Schools is not committed to entering into an agreement or Contract regarding the scope of services included in the proposal request. Faribault Public Schools reserves the right to reject any and/or all proposals and to discontinue contract negotiations at any time without bias. Faribault Public Schools is not financially responsible for any costs incurred in the preparation of a proposal.

#### PROJECT PARTNER

Trust for Public Land (TPL), a national nonprofit, conserves land for people to enjoy as parks, gardens, and other natural places, ensuring livable communities and healthy environments for generations to come. Founded in 1972, our work grows from the belief that no American should live more than a 10-minute walk from an outdoor space to play, learn, grow, or experience nature. Today there is only one park for every 14,000 people in America, and as a result, an entire generation is growing up disconnected from nature and the outdoors. Trust for Public Land's Community Powered Parks program focuses on creating multi-benefit urban parks and green spaces in underserved communities.

For more than 25 years, and in communities across the country, TPL has partnered with schools to reimagine their outdoor spaces. TPL has completed 280 schoolyard projects around the country. In Minnesota, Jefferson Elementary and Brooklyn Center Elementary in Brooklyn Center, MN are the first two pilot sites of a growing statewide schoolyards program.

TPL is collaborating on this Project with the Faribault School District. The selected firm will be contracted directly by the School District, however, funds are being provided to the School as a sub-grant from TPL. Trust for Public Land will be closely involved with the Project providing engagement, communication, design, project management, and fundraising support. Faribault School District and Trust for Public Land are independent entities, and nothing in this RFP is intended or shall be deemed to create an association, joint venture, agency or employer-and-employee relationship between the two entities.

#### PART 2 – PROJECT BACKGROUND

#### PROJECT HISTORY

In the fall of 2021, Jefferson Elementary School staff applied to TPL's schoolyard support program. The competitive program, funded through support from the Minnesota Environment and Natural Resources Trust Fund (ENRTF), is intended to launch the pilot phase of the Minnesota Community Schoolyards program. Nine schools applied to the program, and Jefferson Elementary was selected.

Jefferson Elementary, as a community school, is well-aligned with the goals of the Community Schoolyard program. The School's front playground has reached its useful lifespan and requires replacement. Partners identified opportunities to improve the design, programming, and maintenance of the schoolyard to include community preferences better; address health, equity, and climate; and continue to serve as a recreational and educational hub of the community.

Thanks to existing funding, Faribault Public Schools pursued some outdoor improvements at Jefferson Elementary during the summer of 2022. In coordination with the City of Faribault, the school district undertook improvements to the School's parking and site circulation. Referred to as Project 1, this effort included the extension of Home Place through to 10<sup>th</sup> Street

SW, safety improvements to the intersection of Home Place and 10<sup>th</sup> St SW, parking improvements, landscaping, a new sidewalk, and improved parent/guardian drop-off and pick-up.

Project 2, funded through state environmental dollars, will improve portions of the front playground. Designs may consider potential improvements to the back playground if funding is available. This Project should focus on the following:

- Nature play
- Outdoor classroom/reading room and/or seating area
- Landscaping, particularly tree canopy improvement and habitat
- Hardscape removal
- Water management
- Educational signage and nature-centered art

Project 3 will consist of a more traditional playground, sports, and games improvement project and will take place when funding is available. Like Project 2, the focus of Project 3 will be the improvement of the front playground; however, some minor improvements may occur in the back playground. Project 2 improvements shall be designed to not interfere with and allow for the construction of Phase 3 with minimal, if any, disruptions.

Jefferson Park, owned and operated by the city, which sits adjacent to the School, is not included in this or any planned projects.

- Project 1 Completed Site Circulation and Parking
- Project 2 Schoolyard Natural Improvements and Outdoor Learning
- Project 3 Future Schoolyard Playground

#### **COMMUNITY-POWERED DESIGN**

Central to the Community Schoolyards program is the engagement and education of students, teachers, parents, and community members. Community Schoolyards are designed by the community, for the community, through a dynamic participatory design process centered on relationships, learning, and lived experiences. Community Schoolyards succeed with a robust, inclusive, and ongoing community engagement process. Projects involve the entire school community, from students and neighbors to staff and parents. Students play an active role in the Project by integrating schoolyard design, programming, and stewardship into school activities. And by engaging the broader community, the program can galvanize support, build momentum, and support long-term sustainability.

The "Student Leader Class" integrates the schoolyard project into classroom learning and activities for a 10-12 week period. Participating students explore topics related to health, equity, climate, and community; identify existing schoolyard issue areas; and share their vision and ideas for the future. At Jefferson Elementary in the Spring of 2022, the entire 3<sup>rd</sup>-grade class participated in this program. In the 2022-2023 school year, those students, now 4<sup>th</sup> graders, should be engaged in further planning, design, and celebration.

#### SCHOOLYARD QUALITIES AND BASIC REQUIREMENTS

The Community Schoolyard design should:

- Focus on improving, enhancing, and incorporating natural resources and outdoor education into the schoolyard
- Highly-durable and easy-to-maintain
- Unique, creative, and encouraging exploration, social and emotional learning, and physical skill-building. It is desired to have a variety of activities with a blend of challenge, risk, fun, and reward
- Orient towards younger students, specifically kindergarten through 2<sup>nd</sup> grade
- Allow supervision to be accomplished with ease. Signage should be included to inform users, supervisors, and parents of age-appropriate activities and the importance of proper supervision
- Assume no or minor grade changes will be made. Consideration of grade changes may be made to accommodate safety, stormwater management, or creative design. Additionally, it should be assumed there will be no drainage system below the schoolyard.
- Consider health and safety, including toxic chemicals, and should be in full compliance with the American Society for Testing and Materials (ASTM) and Consumer Product Safety Commission (CPSC) guidelines
- Must meet or exceed all local, State, Federal rules and regulations, including the Americans with Disabilities Act (ADA)

#### PROJECT OVERVIEW

Location: Jefferson Elementary School

Address: 922 Home Place, Faribault, Minnesota 55021

Grades: K-5

Enrollment: About 425 School Demographics:

81% of the student body is a person of color. The largest racial/ethnic groups are East African, Central American, and European/Caucasian.

82% of the student body receives free or reduced lunch

#### Community Demographics:

Approximately 1,980 people live within a 10-minute walk of the School. Of those, 23% are people of color, and 39% are low-income.

Statewide Assessment Ranking\*: 230 out of 2,641 school facilities

\*In 2020, using health, equity, climate, and park need data, TPL analyzed every school facility in Minnesota to better understand which schools would benefit most from park-like, accessible and welcoming schoolyard spaces. Data informed the creation of an index, which ranked schools relative to each other. The highest-ranking School is considered the highest-need School. Jefferson Elementary ranked in the top 10% of highest-need schools. #### Play Area 1 - Front Schoolyard

Overview: The front schoolyard includes a large grass play space, mulched traditional playground space, a small paved area adjacent to the school building, and a grass area with some tree canopy. The site is fenced along 10<sup>th</sup> Avenue. The front schoolyard is the older of the two playgrounds, built over 25 years ago. Most equipment is past its useful life and in need of replacement. Due to limited funding for Project 2, equipment replacement will likely be deferred until Project 3. In the summer of 2022, a significant renovation of the School's site circulation, parking, and pick up/drop off was completed. This slightly increased the area for play, improved stormwater management, and addressed safety concerns (Project 1).

Primary user: Ages 4-8

Maximum users at one time: 90 students

<u>Issues:</u> Beyond outdated play equipment, the front schoolyard faces stormwater/ponding issues, wear and tear on the open field, a lack of shade, and safety concerns along 10<sup>th</sup> Avenue.

<u>Preferred Design Features:</u> The front schoolyard will incorporate a mix of traditional and nature-based play features, separated into 'rooms' to accommodate different play styles, learning, relaxation, and recovery. The primary user group is children from kindergarten through second grade; however, the space should be designed as welcoming and accommodating to all and in a manner that will attract users both during and after regular school hours. Because current funding is limited, and improvements may need to take place over time, the schoolyard should be designed in a manner that utilizes some of the existing play equipment – for the time being – and in a manner in which future replacement would cause minimal disruption to improvements made during this phase. The emphasis of enhancements for this Project should be on the eastern half of the project playground.

#### Play Area 2 – Back Schoolyard

Overview: The back schoolyard includes a paved area for basketball and games, a mulched traditional playground space, a grassy forested area, and a large athletic field. Play equipment in the back schoolyard is approximately 15 years old. Within the last few years, an area to the north was renovated to better accommodate bus drop-off/pick-up.

Primary user: Ages 9-12

Maximum users at one time: 90 students

<u>Issues:</u> The back schoolyard has fewer issues but does lack sufficient shade and has some water ponding issues to the immediate west of the playground.

<u>Preferred Design Features</u>: Minimal, if any, improvements are anticipated in the back schoolyard. The addition of trees would be considered. If designers determine the best location for an outdoor classroom is the back schoolyard, project partners would be open to its consideration.

Applicants are strongly encouraged to review the Appendix for additional information and reference documents.

#### PART 3 – SCOPE OF SERVICES, QUALIFICATIONS, CAPACITY

#### **GENERAL**

The Vendor will furnish all labor, design services, engineering, construction, construction management, surveying, permitting, inspections, administration, materials, equipment, services, transportation, insurance and daily expenses to meet the requirements of this scope of work and specifications. Prices shall be inclusive of all costs.

The Project will be delivered in six (6) phases, two of which are complete. Respondents to this RFP should expect to deliver phases 3-6.

Phase 1 – Project Kick-off

Phase 2 – Concept Design

Phase 3 – Design Development

Phase 4 – Construction Documentation

Phase 5 – Site Preparation and Construction Administration

Phase 6 – Project Close-out and Stewardship

Faribault Public Schools and Trust for Public Land, with the support of the National Park Service, have completed Project 2 – Phase 1 and Phase 2.

Construction of Project 2 is scheduled to begin following the end of this school year in June 2023 and commence before the beginning of the next school year in September 2023. Phases 3-5 should plan according to that timeline.

#### Phase 1 – Project Kick-off

Regarding Project 1, the District's Vendor on the Project helped secure pertinent background information and site survey. The design of Project 1 helped to inform Project 2, including the available site area size, shape, and level of improvement. The completion of Project 1 slightly increased the size of the front playground and entryway.

#### **Phase 2 – Concept Planning**

This phase included the development of a Concept Plan, translating and articulating the vision for the schoolyard, and engaging students and the community. The plan, included later in this RFP, underwent review and comments by School District staff, teachers, students, and TPL.

The Concept Plan should be considered guidance for Project 2 and Project 3. The Vendor shall recommend and make any adjustments necessary to the design and phasing of work to meet project target costs. Cost estimates should outline specific costs for Project 2 and include general cost estimates for Project 3.

#### Phase 3 – Design Development

#### Key Deliverables:

- a. Draft Design Development Package
- b. Final Design Development Package
- c. Updated Cost Estimate

The design development phase involves the ongoing development and refinement of the approved Concept Plan. The Design Development package shall be developed in sufficient detail to ensure that the scope is fully met and the baseline schedule and costs are known with a high degree of certainty. The packages will include drawings and specifications progressed to 60% construction documentation. The draft package shall be submitted to the School District and TPL for review and comments. The Vendor shall integrate all comments from the School District and TPL into the final package.

The Design Development Phase shall conclude when the Vendor has obtained approval of the final design development package from the School District, City of Faribault, and any other approving authorities.

#### **Phase 4 – Construction Documentation**

Key deliverables

- a. Draft 90% Construction Documentation Package
- b. Final 90% Construction Documentation Package
- c. 100% Construction Documentation Package
- d. Final Cost Estimate
- e. Project Manual

This phase involves the preparation of a complete construction documentation package to the full extent of the scope area, suitable for construction. The three major submissions in this phase include a draft 90% Construction Documentation package for review by the School District and TPL; a final 90% package, which shall incorporate all School District and TPL comments on the draft package, and be reviewed and approved by School District, TPL, City of Faribault, and other necessary approval agencies; and finally, a 100% Construction Documents package, marked "For Construction" after final approval by the School District.

The packages will include drawings, specifications, all necessary approvals, and a maintenance manual. Prior to commencing construction, a detailed cost analysis and schedule of the proposed construction shall be provided to show the project construction budget and detailed timeline for the construction work schedule with milestones shown.

#### Phase 5 – Site Preparation and Construction Administration

#### Key Deliverables and Requirements:

- The Vendor shall prepare and submit for all required permits and approvals.
- The Vendor is responsible for overall project construction quality control, including protection and security of the site, providing directives to sub-Vendors, and attending scheduled on-site construction meetings.
- The Vendor should hold weekly construction meetings with the project team. Meeting minutes should be prepared and shared with the team.
- Additionally, the Vendor should conduct, at minimum, weekly site visits and create observation reports.
- Provide inspection/field condition reports as needed.
- Schedule inspections by all required agencies and officials.
- The Vendor shall locate all existing utilities prior to proceeding with work. The Vendor shall proceed with the utmost caution when constructing in the vicinity of existing utilities. Faribault Public Schools will locate any school-specific underground utilities prior to the start of fieldwork.
- The Vendor shall enclose the construction zone with a plastic mesh fence and metal posts to safely separate the construction activities from the adjacent active play areas. The Vendor shall maintain the fence for the duration of construction and shall remove the fence upon project completion.
- All playground equipment, site furnishings, and landscaping shall carry a warranty by the manufacturer or supplier. Equipment and furnishing shall carry a warranty of fifteen (15) years against structural failure, weather corrosion, and defects in materials or craft. Plants and landscaping shall carry a warrant of one (1) year.
- The Vendor is responsible for removing and legally disposing of all construction debris from the site at the Vendor's cost.
- All change orders must be approved by the School.

#### Phase 6 – Project Close-Out and Stewardship

#### Key Deliverables and Requirements:

- The Vendor will secure Substantial and Final Completion approval.
- The Vendor will provide as-built survey and engineered drawings, sealed by a registered Engineer or Landscape Architect in the State of Minnesota, and a boundary survey. Files should be shared in PDF and native format.
- Vendor will provide maintenance and operations guidelines required for the improvements.
- Vendor is welcome, but not required, to attend a grand opening celebration with the school community in the fall of 2023.
- Vendor to supply documentation of all prevailing wages paid

#### PART 4 – SCHEDULE

#### RFP ISSUE AND PRE-APPLICATION GUIDANCE

The release date for this Request for Proposals (RFP) is Tuesday, November 22, 2022.

There will be a mandatory in-person information session and site tour at Jefferson Elementary School on December 7, 2022 at 10 AM. Immediately following the information session, a site tour of the space will occur. Interested parties should

notify Principal Nick Jurrens at <u>njurrens@faribault.k12.mn.us</u>, if they plan on attending. <u>Prospective applicants are</u> required to attend.

All questions and requests for additional information concerning this RFP should be directed in writing to Scott Gerdes with "Jefferson Elementary Community Schoolyard" included in the subject line of the email. The deadline for submitting questions regarding this RFP is December 16, 2022. A list of all questions and responses shall be sent to all firms that request such material and indicate interest in the RFP by sending such a request to Scott Gerdes at sgerdes@faribault.mn.us. Responses shall be issued by email on or about December 22, 2022 (four business day after closing of questions). Telephone communication with project staff is not encouraged, and the School is not bound by any clarifications, interpretations, corrections or changes to the RFP that are made verbally or in any manner other than by written addendum. Interpretation or correction of the RFP will be made by addendum posted on the School's bid webpage and via email to registered bidders. Any addendum will be considered a part of the RFP and will be incorporated therein.

#### PROPOSAL DEADLINE

Sealed Proposals will be received at the Business Service Department of Faribault Public School Independent School District 0656, 710 17<sup>th</sup> Street SW, Faribault, MN 55021, until 2:00 PM Central Time on Wednesday, January 4, 2023, for the furnishing, delivery, and installation of a Community Schoolyard at Jefferson Elementary School in accordance with the specifications set forth herein and the "other" terms, conditions and instructions to the specifications. Proposals shall be delivered to the attention of Scott Gerdes.

All Proposals received after the time stated above will not be considered. The Vendor assumes the risk of any delay in the mail or in the handling of mail by school district employees. Whether the Proposal is sent by mail or by means of personal delivery, the Vendor assumes responsibility for having their RFP clocked in on time at the place specified. Telephone or faxed amendments will not be accepted at any time.

Proposals should be signed by an authorized individual to bind the firm and must be valid for at least 90 days.

\*Vendor agrees to hold equipment and, upon notification from the School Representative, coordinate delivery and installation of furnishings and equipment. The date(s) for the installation of the furnishings and equipment will be determined by the General Vendor and School Representative. General Vendor and equipment Vendor, if different, are to coordinate activities to ensure that the schoolyard is closed for no more than six (6) weeks.

#### PART 5 – EVALUATION OF PROPOSALS

All responses are subject to a determination of "responsive" and "responsible" prior to award. The School District is the sole judge as to the proposer's "responsiveness" and "responsibility." The School District reserves the right to request additional information.

The School District will review all proposals and reserves the right to request necessary modifications, waive minor technicalities, reject all proposals, reject any proposal that does not meet mandatory requirement(s) or cancel this RFP, according to the School District's best interests. The Faribault Public Schools Project Committee will make a recommendation to the School Board of Faribault Public School District No. #0656 for final approval.

The District reserves the right to award this RFP by Project or to reject any or all design proposals, to waive any informality and to accept the Proposal deemed to be in the best interest of the District. No design change or alteration will be considered after the Proposal opening.

#### **SELECTION CRITERION**

#### Factor 1: Qualifications & Experience of the Company

Brief history and organization of the company, legal entity that will enter into the Contract, and the name and title of the person that is authorized to enter into a master contract agreement (must be an officer, partner or member of the company). List any sub-Vendors that will support your company, if any. Provide a narrative of your company's prior experience and qualifications as it pertains to the Scope of Work and provide a list of projects with similar scopes. Proposals must provide proof of direct authorization by the manufacturer to sell the equipment within two (2) business days.

#### Factor 2: Project Management Capacity, Approach to the Project, & Quality Control

Demonstrate project management capacity through a statement of yourrcomapny's current workload and capacity to meet the project schedules. Outline your approach to the project and identify quality control methods that will be employed by your company. This section shall also include an organizational chart for each team member (including sub-Vendor supervisors) and list their roles with responsibilities.

#### **Factor 3: References**

Provide the name, address and telephone number of at least three (3) references familiar with the quality of work done by your company of similar nature as contained in the above Scope of Work. By submission of the references, you are authorizing the Faribault School District to contact these references.

#### Factor 4: Legal, Safety, Insurance, and Financial

The company's submittal shall provide documentation of any history of litigation associated with project performance or professional liability during the past ten years. A short statement of any safety problems the company may have encountered in projects designed or inspected. A statement or other information to describe the company's general financial standing and current insurance coverage.

#### Factor 5: Detailed Budget

Provide a detailed budget that includes all phases and work necessary to complete the Project per the approach described in your Proposal. An itemized list of equipment, amenities, and landscaping must be included with design. Evaluation will be made on the total sum of base items for the Project and will not include alternatives or add-ons. Review of the budget will consider generalized budget for Project 3, if included.

#### Factor 6: Schoolyard Design

Design should be creative. The review team will consider the value of opportunity for natural impact, play and physical activity, visual appeal, outdoor learning opportunity, community gathering benefit, variety of play elements, and compatibility with the site and alignment with community feedback. Design must include scaled two-dimensional drawings and colored three-dimensional drawings of the proposed site.

#### **SCORING**

The School District's evaluation team may elect to first rank proposals with a simple numeric score and then detail score only the top tier of proposals.



#### Students

#### **Design Your Schoolyard**

Students were asked to draw their vision for the schoolyard. Themes included:

- Challenging/Extreme: bright colors, tall height, equipment like trampolines, slides, and zip lines
- Contemplative: reading room, quiet areas, caves
- Nature: trees, flowers
- Unique: forts, tree houses, splash pads, bright colors

#### **Classroom Conversations and Site Analysis**

Students conducted a site analysis of the front and back playgrounds.

#### Front Playground:


- Grass and mulched areas are often too muddy, icy, or have standing water
- The area gets a lot of sun and can be hot
- The fence is necessary to keep balls and kids inside the playground
- A tree fell down after a storm
- Playground equipment is old

#### **Back Playground**

- Similar issues with mud, ice, and water on the track field
- An area is needed for soccer, with fencing to keep balls from going in the street
- The tree-covered area adjacent to the school building is underutilized
- There are blank walls that could be good for art and color
- There's more shade in the back than the front, although it can still get hot
- The back is windier than the front

#### **Pre-Curriculum Student Survey**

A survey was conducted during the Student Leader Class' first session. The use of the survey tool was twofold. First to gauge student interest in specific design solutions, and second to inspire students to think broadly about what the future could hold for the schoolyard. In our observations, when asked about their vision initially, students tend to think of play equipment and athletics — essentially what they know a schoolyard to be. This is compounded by group dynamics that tend to favor more outspoken students. When allowed to choose from a wide variety of design solutions, including natural, artistic, and community- and equity-centered design, the responses tend to shift.




## Student Leader Class Design Workshop Group Worksheets

In May of 2022, the four Student Leader Classes participated in a design workshop over two days. Students were divided into small groups. TPL staff and Jefferson faculty supported the groups of students.

The first week, students were given instructions and asked to consider issues of heat, habitat, health, equity, etc. We found students struggled to negotiate, focus, and consider all options without further guidance. This prompted us to create a worksheet we implemented in the second week. Before jumping into the design exercise, each group was tasked with completing a design worksheet to identify at least one and up to three design solutions to nine different site issues. The table below outlines the solutions identified by the students.


What about the existing schoolyard works well?


### What about the existing schoolyard DOES NOT work well?




What are your Big Ideas for the schoolyard? The sky is the limit, what are your dreams?

- We the parents would like to have a waiting area to pick up our children and there is no place to hide from the rain or climate weather.




## What is your age range?
