English as an Additional Language (EAL)

Upon entry into ISZL your child's English level may be assessed. Based on the results of the assessment, or on any future assessment, it will be for the school to decide whether your child requires English as an Additional Language (EAL) support. It is at the discretion of the school to decide when a student should exit the EAL programme. There is no additional cost for EAL.

ENROLMENT TO ISZL (CONTINUED)

Enrolment

- Enrolment is for the whole school year. The tuition fee is payable within thirty days of date of the invoice. All school invoices will be sent electronically. Any bank fees incurred when transferring funds must be paid by the sender. 12% interest, per year, will be added to all fees which are past the due date. Payment options are available in 2, 3, 4 and 8 instalments. These payment options are open to private payers only and must be pre-arranged with the Business Office on a yearly basis (E-mail: billing@iszl.ch). For families who enrol after August 2023, fewer payment options may be available. There is an associated administration fee of CHF 200 per child per year on all instalment options.
- Students who are enrolled for the new school year, or during the school year, and who are then subsequently withdrawn before the start of their classes, will be charged 25% of the relevant tuition fees unless notice of withdrawal is received at least 4 calendar months in advance of the start date.

Cantonal Support

If there are no changes on Cantonal Legislation and requirements are met, ISZL receives a cantonal subsidy for residents living in the Canton of Zug. Entitlement is for students from Kindergarten to Ninth Grade, who were born before June 1st 2018, have started at ISZL and have been registered with the Canton of Zug by November 15th 2023. As per cantonal legislation, ISZL deducts half of this subsidy from the annual tuition fee of those students eligible. This process is managed by the Business Office. The other half of the subsidy is used for general educational purposes to the benefit of all ISZL students.

Unpaid school fees/invoices

In the event of an unpaid invoice, third parties may be engaged by ISZL for the recovery of any outstanding fees and costs. For this purpose, ISZL reserves the right to pass on the required personal details to the relevant third party agency.

School Bus Service

A separate, additional charge is made for those children using the school bus service.
