INSTRUCTIONS FOR 2022 SENIOR CITIZEN PROPERTY TAX REBATE

- COMPLETE PART A: If this is your first application, provide proof of birth date and social security number. (You can use your birth certificate, PA driver's license, or PA identification card.)
- 2. **COMPLETE PART B:** If you're under 65 and disabled and this is your first application, provide proof of your disability. (This can be a copy of your award letter from Social Security, or a letter from the VA or Federal Civil Service. If you have not been declared disabled by any of those agencies, provide a copy of your PA-1000 PS Physician's Statement of Permanent Disability.)
- 3. **COMPLETE PART C:** Only the 2022 school taxes paid on the homestead residence in which you live are eligible for rebate. Include a copy of the receipt for those paid taxes.
- 4. Only one rebate per homestead will be issued.
