



Volunteer Agreement and Release from Liability

I, _____, agree to work for Encinitas Union School District (EUSD) as a volunteer on farming activities that can include cultivation, harvesting, bed prep, planting, chicken care, composting and site beautification.

1. As a volunteer, I understand that I control the dates and times when I do the work. I also understand that I will not be compensated for any time spent volunteering, nor am I entitled to benefits, including employment insurance benefits, upon the termination of this agreement or as a result of this service.
2. I am aware that participation as a volunteer requires physical activity, (i.e. standing, lifting, digging, and carrying up to 40 pounds) and will require I exercise reasonable care to avoid injury. I am voluntarily participating in this activity with knowledge of the hazards and potential dangers involved, and agree to accept any and all risks of personal injury and property damage. I am aware I can decline participation if I am physically unable to perform a presented task.
3. As consideration for volunteering for EUSD, I hereby agree that I and my assignees, heirs, guardians, and legal representatives will not make claim against or sue EUSD or its employees, agents, or contractors for injury or damage resulting from negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of EUSD as a result of my volunteering. I HEREBY RELEASE AND DISCHARGE EUSD AND ITS OFFICERS, EMPLOYEES, AGENTS, AND CONTRACTORS FROM ALL ACTIONS, CLAIMS, OR DEMANDS THAT I, MY HEIRS, GUARDIANS, AND LEGAL REPRESENTATIVES NOW HAVE, OR MAY HAVE IN THE FUTURE, FOR INJURY OR DAMAGE RESULTING FROM MY PARTICIPATION IN THE PROJECT.
4. If I am injured in the course of the project, I authorize EUSD to seek emergency medical treatment on my behalf in case of injury, accident, or illness to me arising from my involvement as a volunteer. I understand that I will be responsible for medical costs incurred by such accident, illness, or injury.
5. I understand that the materials and tools provided by EUSD are and remain the property of EUSD, and I agree to return these tools and any remaining materials at the end of my volunteer service.
6. I authorize the use of photos taken of me and others under my care by EUSD for its promotional purposes.
7. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND SIGN IT OF MY OWN FREE WILL.
