

# OLDHAM COUNTY BOARD OF EDUCATION POLICY

## SUPPLEMENTAL FEDERAL FUNDING

7010

*Relates to: 7010.01AR*

### **7010.01 NCLB TITLE I, PART A**

Improving Basic Programs - Distributes funds for the establishment of remedial math and reading or other core content area programs to serve the educationally disadvantaged, (public and private school students described as educationally disadvantaged or operating one or more years below their expected grade level in reading or arithmetic). A management system stressing individual objectives, forms the basis upon which remediation is prescribed. Programs must be base for scientifically based research strategies.

The Board provides for and encourages parent participation in both planning and implementing the Title I programs. At least annually any school receiving federal funds under Title I shall meet with parents to inform them about opportunities to become involved in planning, review and improvement of the Title I program and to receive information about the program, including but not limited to information describing and explaining the curriculum, forms of academic assessment, and the parent's and the school's responsibilities to work together to improve academic achievement.

### **7010.02 NCLB TITLE V – INNOVATIVE PROGRAMS**

The Superintendent shall prepare or cause to be prepared an annual application for utilizing the Board's entitlement under the provisions of Title V. The Superintendent shall recommend appropriate programs to the Board.

### **7010.03 NCLB TITLE II, PART A – HIGH QUALITY TEACHERS AND PRINCIPALS**

The Superintendent shall prepare or cause to be prepared an annual application for utilizing the Board's entitlement under the provisions of Title II. The Superintendent shall recommend appropriate programs to the Board.

### **7010.04 NCLB TITLE IV, PART A – SAFE AND DRUG FREE SCHOOLS AND COMMUNITIES**

The Superintendent shall prepare or cause to be prepared an annual application for utilizing the Board's entitlement under the provisions of Title IV. The Superintendent shall recommend appropriate programs to the Board.

### **7010.05 NCLB TITLE II, PART D – EDUCATION TECHNOLOGY**

The Superintendent shall prepare or cause to be prepared an annual application for utilizing the Board's entitlement under the provisions of Title II Part D. The Superintendent shall recommend appropriate programs to the Board.

### **7010.06 TITLE III – SERVICES TO STUDENTS WITH LIMITED ENGLISH PROFICIENCY**

The Superintendent shall prepare or cause to be prepared an annual application for utilizing the Board's entitlement under the provisions of Title III. The Superintendent shall recommend appropriate programs to the Board.

### **COMPLAINT PROCEDURES:**

Oldham County residents having complaints concerning a local Title I-IV program may register that complaint following the Board's procedure as outlined in Administrative Regulation 7010.01AR. Attempts will be made to find solutions to problems and/or provide information to clear misunderstandings that might ultimately result in withdrawal of that complaint at an informal level. The Building principal receiving the complaint shall immediately notify the Assistant Superintendent for Student Learning of the receipt of said complaint. If a satisfactory solution cannot be found, the Complainant may register a complaint with Kentucky Department of Education.
