Bids shall be executed on State Form 96 and Supplementary Bid Form.

Bids shall be accompanied by Contractor's Financial Statement from the most recent completed year.

A bid security in the form of AIA Document A310, a certified check, Indiana General Revised Form No. 86, "Contractors Combination Bid Bond and Bond for Construction" or a form from an acceptable surety shall accompany each bid. The bid security shall be in the penal amount of 5% of the total bid price and made payable to the Owner.

The construction schedule and phasing is included in the Volume 1 Specifications.

Questions will be accumulated and researched and answers will be distributed to all bidders with questions anonymously listed. Answers will be distributed via addendum.
