REGULAR MEETING:

I. CALL TO ORDER

Chair McDonald called the meeting to order at 7:00 pm.

Executive Director Susanne Beauchaine led the Pledge of Allegiance.

All Directors and Superintendent Weight present.

Director Scott made a motion to approve the amended agenda with modified Certificated Personnel Report; Director Rohrer seconded the motion, and the motion passed (5/0).

II. COMMENTS FROM THE AUDIENCE

Chair McDonald read a letter from SEA President, Tanya Rontos, thanking the Board for honoring Steilacoom Historical School District's certificated staff.

III. PRESENTATION - Certificated School Employees Recognition

Executive Director of Human Resources Susanne Beauchaine recognized the district's certificated school employees, and thanked them for their contribution to the education of our district's students.

IV. REPORTS

A. Legislative Update

Director Scott presented a legislative update on current bills.

B. Family Strong Update

Shawn Lewis, Director of Community Relations and Planning, introduced Mary Snyder, SEL Coordinator, who presented an updated on the Family Strong events that took place during the month of April, including Monday Moves, STEAM Activities, Spring Reading Challenge, Virtual Field Trips, JROTC Family Academy Presentation, Family Strong Film Festival, LEGO Challenge Club, Family Shield Events, Superhero Pet Fashion Show, and SteillyCon Cosplay Reverse Parade. Mary noted how our community partners supported these events, and how that helped to bring a sense of connection between our military-connected families with not only our schools, but also with our community.

V. CONSENT AGENDA

Director Scott made a motion to approve the amended Consent Agenda; Director Pierce seconded the motion, and the motion passed (5/0). The Consent Agenda included attached Financial Reports, March and April 2021 Accounts Payable including March 2021 Payroll, March 24, 2021 Regular Meeting Minutes, Proposed Fee Budget for Revised Maintenance Facility, School Improvement Plans, and Personnel Reports.

VI. NEW BUSINESS

A. First Reading of Policy 3241 Student Discipline

Director Forbes made a motion to approve Policy 3241 Student Discipline; Director Rohrer seconded the motion, and the motion passed (5/0).

B. First Reading of Policy 3200 Rights and Responsibilities

Director Forbes made a motion to delete Policy 3200 Rights and Responsibilities; Director Rohrer seconded the motion, and the motion passed (5/0).

VII. BOARD COMMUNICATION

- Chair McDonald shared that Mr. Gabe Van Wyhe, SHS Photography teacher, has offered to take wet plate photographs of each Board Director next month.
- Director Scott commended Mr. Van Wyhe and Mr. Jones for their continuing efforts with the SHS Photography program.
- Director Pierce shared that a parent had reached out to him with concerns that students are participating in field activities, and questioned whether fields are now open for use. The parent had concerns on the district's follow-up with groups to ensure that groups have the appropriate insurance and are following the required registration process. Dr. Weight responded that the district office has a thorough process (per Board policy) regarding the use of the district's fields, and that the District Office staff consistently follow this process.
- Director Rohrer shared parent communication regarding how difficult this year has been, and how students are looking forward to returning to school on a more normal level as soon as possible. Director Rohrer asked whether the district's plans for addressing learning loss are being shared with families. Dr. Weight assured Director Rohrer that the district has a detailed plan, which will be coming to the Board for adoption in May, prior to the district submitting the plan to OSPI. After Board approval, communication will happen to families.

VIII. ANNOUNCEMENTS

- Dr. Weight announced that Steilacoom High School was again placed on U.S. News and World Report's Best High Schools 2021 list. The school is ranked 24th out of 689 high schools in the state of Washington.
- Dr. Weight also shared that Anderson Island Elementary was named a State and National Green Ribbon Schools Winner. They will be recognized in Washington, DC in person in the fall.
 Anderson Island Elementary was the only school in the entire state of Washington to earn the award.
- Director Forbes thanked everyone involved in honoring former Steilacoom Mayor Ron Lucas at the Lucas Field Dedication. He was encouraged by the spirit of community at the event. Director Forbes also expressed his thanks to all staff who continue to work to support our students and families.

- Director Pierce encouraged the district to educate district employees on the new long-term care insurance tax. He also would like the district to add to the robust SEL plan with additional focus on academic gaps.
- Director Rohrer thanked the staff for all they are doing for our students. She mentioned visiting
 a district school and seeing spirit day posters, and is thankful our students are safely
 experiencing that normalcy again. Director Rohrer encouraged school admin to invite Board
 members to any upcoming vents.
- Chair McDonald offered a continued thank you to district staff for their work with inclusionary practices and supporting learners across the board. She stated, "You can feel and see the change happening." Chair McDonald also noted that Dr. Weight was recently presented with the Neural Education Change Agency Award. Chair McDonald thanked Dr. Weight for making the connection between SEL and academics, noting that it is working, and our students are learning in improved ways while also building resiliency.

Chair McDonald recessed the meeting to Executive Session at 7:31 pm.
