# **District Goal 1: Family and Community Involvement**

**Goal:** During the 2016-2017 school year the CTE program at SHS will develop and strengthen communication between the school and key stakeholders including students, parents, community members, Pierce County WAVA, and industry partners.

**Rationale:** Maintaining general and program specific advisory boards is one of the program standards for all Washington CTE programs. Partnering with industry partners and experts in Pierce County will be invaluable to the growth of our programs. Additionally, improved communication with our students and parents about how to best incorporate CTE courses into their chosen high school pathways will ensure the stability and growth of our programs over time.

**Plan to Monitor Progress:** We will monitor progress by keeping detailed notes about our meetings and communication in our program binder. We will also monitor number of visits to our CTE websites monthly.

## **Action Steps:**

- Quarterly meetings of the general advisory board
- Updated information on the CTE tab of the school website to include:
  - o Programs of study
  - o Clear course descriptions
  - o Strategies for incorporation CTE courses into Core-24 requirements
  - o Links to programs offered at PCSC
  - Updated videos highlighting program offerings including those at the Pierce County Skills Center (PCSC)
- Continuation of our winter and spring CTE Advisory Meetings and partnering with University Place School District to increase industry partnerships

## **District Goal 2: Resource Management**

**Goal**: During the 2016-2017 school year, SHS will conduct an internal audit, including detailed program reviews, of all CTE programs to ensure compliance with state wide requirement.

**Rationale:** We completed an external audit with OSPI during the 2015-2016 school year. While we did well in this audit process, we want to continue the yearly comprehensive program review process to ensure that our programs are as successful as possible and provide our students with the best opportunities available.

**Plan to Monitor Progress:** Each CTE course and program will complete the comprehensive program review process at the end of each school year. The program reviews will be kept on file in the CTE director's office to inform progress for the following year.

#### **Action Steps:**

- Update and maintain binders for each course including pathway outlines, teacher credentials, updated frameworks, dual-credit forms, budget allocations and expenditures, and annual program review documentation.
- Audit of current courses to ensure CIP codes and teacher credentials are compatible.
- Review of budget allocations and detailed tracking of expenditures for each program.

### **Mid-Year Progress Update:**

- Audit of teacher certificate codes and state CIP codes was completed during the first semester and all are now in compliance
- Updates of frameworks for those courses in need are in process with OSPI
- Monthly finance meetings with Mr. Brittan to monitor fiscal resources specific to CTE

## **District Goal 3: Teaching and Learning**

**Goal**: During the 2016-2017 school year, SHS will expand our CTE pathways by building connections between middle and high school courses, increasing articulation with post-secondary programs, and adding one or more pathways of study.

**Rationale:** CTE programs provide valuable skills for students in both career and post-secondary study. Emphasizing the usefulness of the programs to our students will allow them to see the big picture and also raise awareness for multiple high-demand, high-paying nontraditional fields.

**Plan to Monitor Progress:** We will monitor our progress by comparing the current CTE Pathways outline to the one that will be presented at the end of the year. Additionally, we will look at the number of dual-credit course offerings in the fall of 2017 as compared to the fall of 2016.

## **Action Plans:**

• Develop articulation agreements for each of our pathways of study, and increase the number of dual credit courses offered.

- Introduce the idea of precision exams for pathways that have multiple levels of courses (i.e. Engineering 1, 2, 3).
- Partner with the middle school to clearly identify how courses at the middle school level support those at the high school.

## **Mid-Year Progress Update:**

- Addition of courses to expand offerings for our students in 2017-2018
  - AP Environmental Science
  - Business Statistics
  - Financial Math
  - American Sign Language 4
  - Ceramics
  - AP Studio Art
- Pierce County Skills Center will visit SHS during both lunches on February 14th and for our Beyond High School night on March 2
- We are in talks with PCSC about offering a satellite summer school campus so students can add some flexibility to their schedules and experience a larger variety of CTE courses

# District Goal 4: Safety, Service and Support

**Goal:** During the 2016-2017 school year we will monitor and maintain the current program-specific safety plans.

## **Student Highlights**

**Film Club:** Our film club traveled to New York this fall to compete in the AT&T film festival. They not only won the contest, but portions of their film will be featured in a nationwide anticyberbullying campaign sponsored by AT&T.

**PCSC Fire Science Student of the Month:** Bailey Fischer was named the PCSC Fire Science Student of the Month for the month of November.

**American Sign Language 3:** Students in our ASL 3 courses are now able to communicate with deaf children from other schools through the use of a video phone system set up by our technology department.

**Expanded College Credit:** We offer college credit through articulation agreements for the following courses: ASL 1, 2, and 3, Human Development, Advanced Foods, Marketing, and Careers in Education. College credit can also be earned with successful completion of the AP Psychology exam.

**School Resource Officer:** Recently our new SRO, Justin Hamerick partnered with our health teachers for a lesson about the dangers of underage drinking and drinking and driving.
