**2.2. Superintendent's Report-**Dr. Biggerstaff congratulated Kara Wilbert on earning her National Board Certification. The 2023-2024 Academic Calendar was tentatively approved at the January 31, 2023 meeting and the final reading will be approved at this meeting. **2.3.1. Cumberland Co. CCMS is planning a celebration for students who meet their personal goals or proficiency on their STAR test. Carson Roach placed 1<sup>st</sup> in Math at Regional Governor's Cup.

He will compete at State in March. Volleyball season started in February. Track practice started and first meet is scheduled for March. David Fueston has been hired as the CCMS Baseball Coach. Wesley Long will be the Assistant. BAFA will be presenting Peter Pan at CCMS March 10-12. The Woodworking Class is working on building the set.

2.3.3. Cumberland Co. High- Mr. Henderson congratulated the Girls' Basketball team who has won 20 games this season. This is the first time since 2008. He congratulated Silas Garmon for being the 1<sup>st</sup> Chair at All State Symphonic Band this week. SBDM and the Leadership Team are working hard on a failure reduction plan.
