The Derry Township School District has a commitment to offering PIAA sports that include women's and men's swimming and diving during the winter sports season. The swimming and diving season for our High School teams' starts mid-November and end mid-March. The School District would like to be clear about our needs for our swimming and diving program.

Our goal has been to be involved in the future planning of the new recreation center. This is to ensure that our needs are met; in order to continue our commitment of offering quality women's and men's swimming and diving, during the winter High School sports season.

The currently approved design for the 35m competition pool at the Derry Township Community Center will adequately meet the needs of our swim and dive teams. A 35m pool will enhance the flexibility of our swim and dive programs, providing additional lane availability for both recreational swimmers and our High School teams. Any delay would further be a detriment to the well-being of our student athletes.

Our swimming and diving teams need to practice 4-6 hours a day, 6 days a week during the November to March season and host 6-7 home meets that last 3 hours between competing schools during their 5-month season.

- Violate any school rules or regulations.

Administration

Students are reminded that during school sanctioned esports events such as practices and games all district rules apply (See disciplinary code in the student handbook).

Students are also reminded that personal games / activities outside of school not sanctioned by the esports club are under jurisdiction of Bullying Prevention Policy 249.

School sanctioned events include practices, intrascholar games, interscholar games, and any fundraising / community building events. All school sanctioned events must be scheduled in advance and approved by the club supervisor and posted on the official club website.

Communication

- All student interaction through Esports hosted channels will be recorded and saved for a minimum period of 2 months.

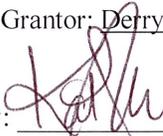

SETTLEMENT AND RELEASE AGREEMENT

This **SETTLEMENT AND RELEASE AGREEMENT** (“Agreement”) is made as of the latest date of the signature page of this Agreement (the “Effective Date”), by and between the **DERRY TOWNSHIP SCHOOL DISTRICT** (hereinafter the “District”) and the **PENNSYLVANIA LEADERSHIP CHARTER SCHOOL** (hereinafter the “Charter School”) (collectively the “Parties”).

WHEREAS, the Parties dispute whether the School District owes funds to the Charter School with respect to the 2016-2017 school year;

WHEREAS, the Charter School has initiated an action with the Commonwealth of Pennsylvania, Department of Education, found at docket No. BBFM-00-2017-331;

WHEREAS, the Parties desire to resolve this dispute without the uncertainty, burden and expense of litigation.

NOW, THEREFORE, intending to be legally bound and in consideration of the mutual undertakings and covenants contained herein, with the foregoing incorporated by reference, the Parties covenant and agree as follows:

1. **Payment.** For and in consideration of the covenants contained in this Agreement, the District shall pay to the Charter School the full amount in dispute and alleged to be owed for the 2016-2017 school year, the sum of Two Thousand Three Hundred Seventy Five Dollars and Eighty-Four Cents (\$2,375.84). Payment shall be remitted via check within forty-five (45) days of approval of this agreement by the School District’s Board of School Directors. The District shall submit this Agreement for approval at the next meeting following receipt of the executed Agreement from the Charter School.
2. **Satisfaction of Amount in Dispute.** The Charter School acknowledges and agrees that the District’s payment represents the total amount alleged to be owed and in dispute for the 2016-2017 school year. The Charter School shall not again seek any additional funds relating to the 2016-2017 school year, and the Charter School forever waives and disclaims any right or entitlement it may have in any other amounts owed for the 2016-2017 school year.
3. **Mutual Release and Discharge by the Parties.** For and in consideration of the covenants set forth in this Agreement, each Party hereby releases the other Party, along with the other Party’s predecessors, successors, assigns, beneficiaries, employees, officers, directors, managers, agents, representatives, affiliated or related entities, attorneys, insurers or any person claiming by, through, or on behalf of the other Party, from and against any and all actions, causes of action, suits, debts, claims and demands (including reasonable attorneys’ fees and costs) whatsoever in law or equity, including without limiting the generality of the foregoing, any claims, related or unrelated, which were raised or could have been raised by either Party relating to the 2016-2017 school year, the Parties prior dealings, or otherwise prior to or through the conclusion of the 2016-2017 school year.

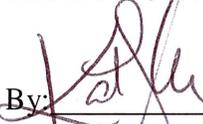
4. No Admission of Liability. This Agreement constitutes a compromise of disputed claims for purposes of achieving an amicable and efficient settlement. Nothing in this Agreement constitutes or shall be construed as an admission of liability by any person or entity. All such liability is expressly denied. This Agreement shall not be admissible as evidence or usable by any person or entity for any purpose in any action or proceeding, except to enforce this Agreement or any provision hereof.
5. Non-precedential. This Agreement shall not set precedent for any dispute that has arisen or may arise in the future.
6. Attorneys' Fees. The Parties to this Agreement shall bear their own attorneys' fees and costs.
7. Entire Agreement. This Agreement contains the entire understanding of the Parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral, between the Parties with respect to the subject matter hereof. Each party has executed this Agreement without reliance upon any promise, representation, or warranty other than those expressly set forth herein.
8. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same Agreement. This Agreement may be executed and delivered via electronic facsimile transmission or email with the same force and effect as if it were executed and delivered by the parties simultaneously in the presence of one another.
9. Withdrawal of Action. The Charter School shall take all necessary steps to withdraw and discontinue the above-captioned administrative proceedings.

CAIU BOARD HIGHLIGHTS

The following actions were taken at the **January 23, 2020** meeting held at the Enola Office of the Capital Area Intermediate Unit.

Reports/Updates

- The Board Spotlight was on the General Operating Budget. Daren Moran, Director of Business & Operations, provided a basic overview of the CAIU budgets and of the 2020-21 General Operating Budget. He highlighted the budget timeline, current issues and concerns, and budget assumptions for 20-21.
 - No increase to the indirect cost rate of 7.75%
 - No increase to the district contribution of \$902,460
 - Interest Income – increasing by \$40,000
 - Fund balance – using \$500,000 for Capital Improvements
 - Major high level Changes - Expenses
 - Salaries (100) – no significant changes to staffing and increase is related to proposed raises
 - Benefits (200) – increase because of PSERS offset by reduction related to budgetary health care costs
 - Purchased services (300) - \$50,000 investment in Frontline technology system for absence management, recruiting and hiring and document management software.
 - Purchased property services (400) - \$600,000 budgeted for upgrades at the Enola facility.
 - Equipment (700) – increase of \$240,000 due to the upgrades of technology (switches, routers, servers, etc.) This is part of a 5 year technology plan.
 - Other (800) – Reduction of bank fees and elimination of the ACA transmittal fee.
 - Other Financing Uses (900) – No major changes
- The Board recognized CAIU Retiree, Beth Spittler, Transportation Specialist, retirement after 34 years of service
- In celebration of Board Appreciation Month, CAIU Administration provided a special breakfast and a small gift as a token of appreciation.
- Statement of Financial Interests Forms must be completed and submitted to the Board Secretary for the calendar year 2019 no later than May 1, 2020.
- Ms. Alicia McDonald, Director of Student Services, passed around thank you notes to the Board Members from our MDS Elementary class. The CAIU is proud to have partnered with United Way of the Capital Region and the community to launch a school readiness pilot project to move the needle on education disparities in our region. Currently, 75 percent of local families are unaware, or cannot afford, these types of programs. The project employs early education liaisons. The focus of their work is through the lens of the school they work with to tailor approaches to help prepare children for kindergarten. The CAIU will provide oversight for liaisons who are working with districts on Kindergarten readiness. The CAIU will also monitor the progress in achieving all deliverables. We were just notified by the state that our request for additional preschool funds was granted at approximately 90%. The additional funding has allowed us to post 19 much needed preschool positions.
- Mr. Dave Martin, Director of Technology Services, reported that technology is in the early stages of looking for a new provider for our phone system which will result in a significant cost savings for us and our ten participating school districts.
- Mr. Daren Moran, Director of Business & Operations, reported that the monthly Business Managers meeting was held yesterday. The Auditor General was present to provide a very informative presentation. Mr. Moran worked closely with the human resources team on the carving out of our prescription drug care plan. The Trust reported that the carve-out was a success and was one of the best roll outs due to the good communication and minimal issues.

He reported on the status of the Steelton-Highspire School District payments and continues to work closely with their staff. They are doing a great job at keeping up on their payments and appear to be heading in the right direction fiscally.

- Dr. Tom Calvecchio, Assistant Executive Director, provided a human resources update: HSA funds were replenished on January 1 and W-2s were made available to staff. The teacher shortages continues to be a challenge for the IU and our school districts. We are collaborating with ten of our school districts to hold a job fair on March 12. Hard to staff positions such as PCAs and EPPs will be targeted. Dr. Calvecchio also provided a communications update and shared a video from our recent All Staff Day to demonstrate the great things our staff are doing.
- Mr. Brian Griffith, Director of Educational Services, reported that on January 7 a meeting was held for those school buildings that have been designated as Targeted Support and Improvement (TSI) – one or more students groups are performing below the CSI thresholds for academic proficiency and growth. We are providing supports to these schools who have been tasked to develop an improvement plan. Mr. Griffith reported on the High Impact Strategies Training that was recently held for student teachers. We trained 130 student teachers that are now out serving in the school districts. Currently, CAIU uses the 48 CARATS system for registration, approval, tracking and uploading to Department of Education. The system is very antiquated and we are in the early stages of looking for a replacement system.
- Dr. Andria Saia, Executive Director, highlighted that the *All In* Newsletter that was available for the Board's review. She highlighted and expressed her gratitude to our Board Members for their service to the CAIU and our communities. The *Did you Know* section highlighted our Application Development team who work hard to plan, develop, and launch programs that enhance and support the CAIU. Dr. Saia provided an update on the property located on the corner of Valley and Miller Rd. The property is currently under a proposed development plan for possible townhouses, apartments, retail, bank, and/or hotel space. The old stone house on the corner, the Miller House, is in the way of their plans. The developers have worked with the Historical Society and with the CAIU to come to an agreement to move the house to a piece of land that we've donated on the corner of Miller and First Street. In exchange, we will be hooked up to their sewer system and will be provided an additional exit with an emergency gate. The developers are planning to file the final approval to the township in March and are looking to close on the property in May or June. Dr. Saia also reported on her recent activities and updates.

When I think of “apps,” I think about the icons on my phone that let me check the weather, access my bank, and crush some candies. © Apps are far more than this, however, and include all of the software programs we use every day.

Here at the CAIU, we have our own Application Development or “App Dev” team, consisting of developers and business analysts. Our business analysts (BA’s) Amy Cserny and Ben Berry translate the client’s needs into requirements that are used to create the application. The developers, Royce Brown, Corey Gelbaugh, Dan Conway, Jack Rentzel, as well as contractor, Damian Salgado, take those requirements and create the program, by writing the computer code that makes the app run.

Together, BA’s and developers take the project from the planning stage, to development and launch – seemingly like magic!

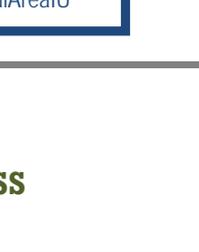
The CAIU application development team does so much to make the work of the CAIU and our partners easier. Some of the programs used every day were built in house, enhanced, or supported by our App Dev team:

- AgendaManager: online meeting management system
- Track: student information and time tracking for our ANPS team
- OASIS: Operations Access Student Information System (in development), a comprehensive student information and billing system for student services
- CAOLA Invoicing: analyzes the data in the CAOLA team’s invoicing process to ensure accurate results
- 48 CARATS: professional development approval and tracking system, used by CAIU and many of our districts
- PoST: Program of Study Tracker for Dauphin County Tech. School to track the requirements of the technical programs of study
- School Store and Inventory system: for Cumberland Valley School District
- PDE Comprehensive Plan tool: utilized by all public schools in PA to develop and submit their plans as well as other requirements.

Message from the Executive Director

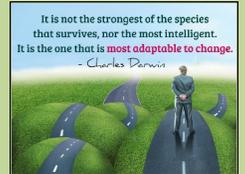

Student Services

Loysville YDC - Holiday Student Assembly - There was a student assembly on December 19 featuring Animals from Zoo America. The theme was protecting the environment and endangered species. Mrs. Painter's Science Escape Boxes -

Using critical thinking skills as a team, student's problem solve science-specific puzzles to open locked boxes. During one class period, they have three to four puzzles to complete to find the number of word combinations to unlock each lock. There are several different types of puzzles, such as using symbols, puzzle pieces, number/letter cypher using a phone keypad, mazes, text messages, mirror images, speeding tickets, etc. This is a student-led activity which, so far, they have enjoyed immensely.



Farm to Table activity in Culinary Arts Class at Loysville - In the LYDC Culinary class, students have learned the value of farm to table. Mrs. Moyer, the Culinary Arts teacher, planned activities and menus that would specifically require classes to go to the orchard between the LSTU school and the Openside school to pick apples. They learned how to discern which apples were ripe enough to pick and use, how to properly pick them, and how to transport them without destroying their harvest. Once they were back in the classroom, students were able to express how they "just go to the store" and that it was "different" to have to go out and get the apples themselves. Students used their harvest in a variety of apple dishes. One student told another teacher that it tasted better because he picked his own apples!

Tech Services

January 6 was National Technology Day. The day was established to recognize the advancements in technology and how they impact our way of living. I guarantee every one of us has used the line "When I was younger I had to do it this way....and your generation is lucky to have...." This line usually has a reference to technology and how much easier it is to accomplish tasks these days. In today's society we take for granted solutions like the Internet, digital assistants like Alexa and Google Home, Smart Phones, GPS units, drones, and one of my personal favorites, robotic vacuum cleaners.

Technology is something that continues to evolve at a fast pace, and school districts are embracing technology and integrating it into the classroom. In order to make all of the new technology work, you need to have a few key components in place. First, a solid infrastructure needs to be established. This would include having the proper network (routers, switches, wireless, etc.) with the proper cyber security measures to keep students and data safe. Next, you need the correct team in place to manage and monitor the infrastructure. You often hear about the stuff that makes things work, but it is also important to recognize that the team behind the stuff is equally important. At the CAIU, our technology team consists of three main sub teams, Network Operations, Application Development and Helpdesk support. These teams help support software and hardware infrastructure both here at the CAIU and to our member school districts.



The Network Operations Team is responsible for overseeing the daily operations of the CAIU data center which provides numerous services for the 24 school districts and two technical schools. These services include server hosting, wireless hosting, Internet services, Voice over IP, disaster recovery, content filtering, next-generation firewalling, network monitoring, spam filtering, email archiving and various other services.



The Application Development Team provides custom software development services. These services include project management, coordination and collaboration with stakeholders to understand and document software requirements, and software development services.

The Helpdesk Team includes Application Support Specialists and Technology Support Specialists. These staff members provide application support, maintenance, and troubleshooting to CAIU employees and external customers. These services include support for the applications we develop and configuration, deployment, and maintenance of all CAIU desktop and laptop computers as well as phone support, remote support, video conferencing, and audio/visual support for all internal CAIU staff.



Tech Tip of the Month

Having trouble with your computer, smartphone, digital assistant or any of your other electronics? Start by restarting it. Yes! Actually, restart it. It is not just a joke, but a common practice when an electronic device is not working and is the first step to take before contacting your IT person. That puts the device in a boot up mode and will often fix a problem.

This month's topic we are going to focus on Intermediate Unit transportation services. Our IU transportation department is a critical component of providing special education services to the students we serve.



The CAIU Transportation Department serves the specialized transportation needs of both Early Intervention and school-age students in our region. School districts choose whether to take advantage of the cooperative transportation services that we offer or to provide for transportation themselves or with their preferred contractor. The goal is to provide safe, efficient, customer-friendly service that complement the school day, and ensures that all students are transported to and from the home and the classroom in a professional manner.

Did you know that the CAIU transported over 920 students, 2.85 million miles, with 116 different vehicles during the 2018-19 year. The 2.85 million miles is like driving back and forth across the United States 530 times or six times to the moon and back.



The Intermediate Unit does not hire our own drivers but we work closely with six different transportation companies to provide these services. Len Kapp and his support team of Dori Dorritie and Crystal Jenkins lead the work of our transportation department. They are responsible for maintaining all of the contacts with over 100 drivers per day and at least 40 different points of contacts at the schools we serve.

The next time that a student arrives safely in your classroom, please take time to think about all the work that was done by the transportation team to make this happen.

As the holiday season comes to an end and a new year is beginning, many people are indulging in retrospection and reevaluating some of their life choices. New Year's resolutions are the perfect opportunity for a new start.



Chances are, more than a couple of the most common resolutions will look familiar to you: Exercise more, lose weight, get organized, live life to the fullest, save more money, quit smoking, spend more time with family and friends.

January marks the beginning of the third quarter of our Wellness Calendar. In an effort to support you in meeting your wellness resolutions, our focus will be on Nutrition and Heart Health during the months of January – March.

Make the simple steps below part of your life for long-term benefits to your health and your heart.

- **A variety of fresh, frozen and canned vegetables and fruits.**
- **Whole grains** - choose fiber-rich whole grains for most grain servings.
- **Low-fat dairy products** - select fat-free (skim) and low-fat (1%) dairy products.
- **Skinless poultry and fish** - Choose poultry and fish without skin. Eat a variety of fish at least twice a week.
- **Non-tropical vegetable oils** - Avoid foods containing partially hydrogenated vegetable oils to reduce trans-fat in your diet.
- **Limit Sugar** - Cut back on beverages and foods with **added sugars**.
- **Limit Sodium:** Choose foods with less sodium and prepare foods with little or no salt. To lower blood pressure, aim to eat no more than 2,300 milligrams of sodium per day.
- **Limit alcohol** - If you drink **alcohol**, drink in moderation.
- **Portion control:** Follow the American Heart Association recommendations when you eat out, and keep an eye on your **portion sizes**.
- **Live Tobacco Free** - Don't smoke, vape or use tobacco or nicotine products — and avoid secondhand smoke or vapor. **Learn more about quitting smoking.**

Education Trends and Ideas Worth Leaving Behind in 2019

For public education, 2019, like previous years, brought its share of the good, the bad, and the ugly. On balance, there was plenty of good news, made largely possible by the 2018 mid-term elections of pro-education candidates into office. Much of *that* energy was drawn from the #RedforEd movement, and we are headed into the new decade stronger than ever.

Betsy DeVos' Voucher Plan – In her three years, DeVos has focused on championing school privatization, and weakening oversight into everything from civil rights protections to fraudulent student loans. DeVos continues to push a proposal which would divert already scarce funding away from neighborhood public schools – where 90 percent of children go – and give it away to private schools, which are not accountable to taxpayers.

'Money Doesn't Matter' - The debate whether increased funding actually improves student outcomes is “essentially settled.” Bruce Baker of Rutgers University acknowledged that money had to be spent wisely to produce better results, but, in direct tests of the relationship between financial resources and student outcomes, money matters.

'Lunch Shaming' - It's hard to believe, but children across the country are still denied nutritional meals because they have negative balances on their meal accounts. The good news is that we may actually not hear too much about lunch-shaming incidents in 2020. In addition to individual states passing laws, a federal bill, the [Anti-Lunch Shaming Act](#), is moving closer to becoming law.

Dress Codes That Discriminate - Across the country, black girls are more likely to be punished in school for their clothing or appearance, including natural hairstyles. School dress codes often include bans on hair extensions, braids, and dreadlocks. While young black males are also victimized by dress codes, girls are more likely to be “dress-coded” by school officials.

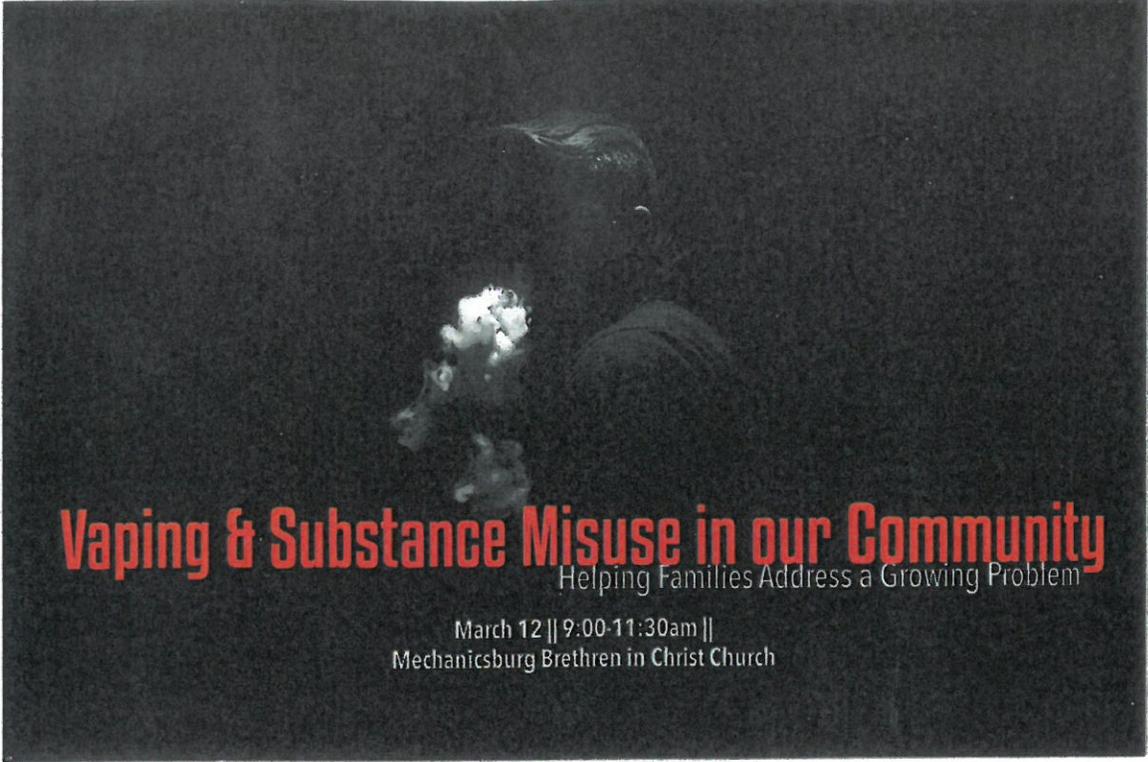
Leave it to the Machines - Baltimore school officials felt when it became clear that the county's “one-to-one” laptop program didn't produce the anticipated improvement in student performance. Other districts have reached the same, and very expensive conclusion: Technology is a tool and a useful one, but it's not a panacea.

Arming Educators - In 2019 there were approximately one school shooting a week. As for the response of arming teachers, most law enforcement experts agree that school staff should not carry guns because they lack the tactical knowledge of handling weapons that trained law enforcement personnel receive on a regular basis, and poses too high a risk to school safety.

'Stress is Just Part of the Job' - In addition to spotlighting the urgent need to reinvest in public education, the #RedforEd movement has also drawn long overdue attention to the [demands and pressures educators](#) face every day. Too many educators are burning out from workload pressure and other anxieties and are not receiving the support they need, particularly those newer to the profession.
