### Registration Information for Sign Language Proficiency Interview: ASL

The Sign Language Proficiency Interview (SLPI) is an assessment required for Deaf/Hard-of-Hearing (D/HH) teacher licensure under the Minnesota Professional Educator Licensing and Standards Board (PELSB). See Minnesota Rule 8710.5200 [Teachers of Special Education: Deaf or Hard-of-Hearing](#).

This SLPI assessment is administered to:

- Students completing a Deaf/HH Teacher training program
- Minnesota teachers seeking full Deaf/HH Teacher licensure
- Out-of-state applicants seeking Minnesota D/HH licensure
- Minnesota teachers seeking ASL Teacher licensure

**Test dates for 2023 are:    March 18, 2023            May 20, 2023**

The SLPI assessment is administered on Saturdays via **Zoom**, in order to accommodate teachers' work schedules. Registrations must be received no later than 2 weeks prior to the test date, in order to ensure that appropriate interview arrangements are in place. Late submissions may be deferred to the next test date.

MDE now requires all applicants to pay a \$175 fee for the SLPI exam. Your payment will need to be received before your test is scheduled.

After your registration form is processed and payment is completed, you will receive confirmation via email with your scheduled interview date/time and other pertinent details. The e-mail will also include an attachment with helpful interview tips and a list of functional descriptors for each SLPI rating level.

You can expect to receive the final written report within 2 weeks of your interview date. You are then responsible to submit the report to the Minnesota Professional Educator Licensing and Standards Board with your licensure application.
