

You are instructed to read and note the following described changes, corrections, clarifications, omissions, deletions, additions, approvals and statements pertinent to the Construction Documents.

Addendum No. 1 is a part of the Contract Bid and Construction Documents and shall govern the performance of the Work.

- I. <u>General Information</u>
 - A. Attached are Google views of the buildings and outlined roof areas where roofing work will be taking place this summer.
 - B. Attached is a REVISED Bid Form for Lakeview Middle School.
 - 1. The Unit Pricing has been removed.
 - 2. The attached REVISED Bid Form must be submitted with your bids.
 - C. The signage that is tight to the walls at several schools will remain in place and will be protected, worked around, and cleaned as needed by the awarded contractor.
- II. <u>Clarifications</u>
 - A. <u>Gerner Family Early Education Center</u>
 - 1. Do not include work on trash enclosure.
 - B. <u>Lakeview Middle School</u>
 - 1. All EIFS walls on all levels will be included in the scope of work.
 - 2. Do not include work on trash enclosure.
 - 3. The \$10,000 EIFS repair allowance is being removed from the project specification.
 - a) In the specification "Summary" section: Delete item 1.3, D., 2., i., 8), a)., that reads "Include a \$10,000 Allowance for EIFS repairs."
 - b) All bidders must include all EIFS repairs in their bids.

- 4. Do not caulk any false/reveal joints on the EIFS walls.
 - a) Where any false/review joints have been caulked, remove any deteriorated or loose material, repair EIFS as needed, and install specified coating.
- 5. Change specification "Summary" section 1.3, D., 2., i., 6), to read "Replace 20 deteriorated bricks."
- C. <u>Line Creek Elementary</u>
 - 1. Do not include any work on the vertical Emseal/WillSeal expansion joints.
- D. <u>Tiffany Ridge Elementary</u>
 - 1. The east wall of Penthouse Roof 2 is the only wall being coated with Tremco SolarGard Hy-Build System.






