COMPENSATION REPORTED FOR THE HEAD OF SCHOOL, DREMA BROWN, WAS PAID BY AN UNRELATED AFFILIATED ORGANIZATION, THE CHILDREN'S AID SOCIETY. FORM 990 REQUIREMENTS NECESSITATE THAT MS. BROWN'S COMPENSATION IS REPORTED IN PART VII, COLUMN D (AS THOUGH PAID BY THE CHARTER SCHOOL).
