**G. FINANCIAL IMPACT OF PROPOSED AGREEMENT IN SUBSEQUENT FISCAL YEARS**

The following assumptions were used to determine that resources will be available to fund these obligations in future fiscal years (including any compensation and/or noncompensation provisions specified below that have been agreed upon if the proposed agreement is part of a multi-year contract):

2023-24: 8.13% Revenue COLA 2024-25: 3.54% Revenue COLA. The District will stop making annual OPEB contributions of \$2,900,000.

**H. NARRATIVE OF AGREEMENT**

The District and VVTA have agreed to the following compensation changes: 2022-23 - 5% on schedule and 5% off schedule salary increases. 2023-24 - 5% on schedule and 5% off schedule salary increases.

The following source(s) of funding have been identified to fund the proposed agreement

The District is funding this agreement using revenue COLAs. The COLA for 2022-23 was 13.26%. The projected revenue for 2023-24 is projected at 8.13%.
