# Highlights

  - (\$1.2) million loss on investments
- Restricted General Fund ending fund balance of \$8.5 million
  - \$ 3,980k Expanded Learning Opportunity Program
  - \$ 1,394k Educator Effectiveness Grant (State)
  - \$ 1,401k Restricted Lottery
  - \$ 355k Mental Health Services

# Looking Forward

- *Enrollment was down an additional **49** students from prior year (day 5 counts)!*
  - *Represents a reduction of an estimated **493** students from 19-20 enrollment levels*
    - *6 of the 11 schools current have enrollment less than that!*
- *Average Daily Attendance (ADA) greatest protection is the 3 year prior average ADA and is projected to be needed in the foreseeable future with a projected loss of **145 ADA** in 23-24.*
- *Funding is projected to grow, but enrollment is not.*
- *Projected Step/Column increases (includes benefits without projected pension increases)*
  - *\$ 896k Certificated annually*
  - *\$ 241k Classified annually*
  - *\$1,137k Total annual increase*

**Part IV - Carry-forward Adjustment**

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year.
