Term of the Contract

Authorization

If both Parents or Guardians having legal custody sign this Contract, they hereby authorize each other to make and/or to receive all declarations and notifications in connection with this Contract. They are jointly liable for all obligations arising under this Contract.

By signing this Contract, the Parent(s) confirm that they have read the Contract and the accompanying documents and acknowledge, understand and accept their content. These accompanying documents are an integral part of the Contract

Force Majeure

The Parents accept that due to reasons of Force Majeure, including closing of the school or certain grades due to decisions by the authorities, the LAB service may stop during such Force Majeure events or during the closing of the school or certain grades.

Termination

An ordinary termination of this Contract is excluded. However, Parents can terminate this Contract free of charge within 2 days after signing this Contract and before service is used. Notice of termination shall be given in writing in order to be effective (receipt date of MIS decisive).

General

The Parent(s) shall immediately inform MIS in writing of any material changes affecting the Contract, such as changes of name or address, contact details or legal custody for the Student. Any additional costs of MIS resulting from the non-adherence to this obligation shall be borne by the Parent(s).

The Contract has a fixed term as chosen by the Parents, either per season or all 3 seasons per school year

Bus Fees

By participating in the LAB Service, MIS incurs personnel and transportation costs which must be borne by the Parent(s) or his/her legal representative according to the information provided on the first page.

The bus fee will be due in full within 10 days after receipt of the electronic invoice; the fee includes VAT.

Third Party Payment

In the event that the company or a third party agree to pay the LAB fees owed, the so-called "Confirmation of Payment" shall apply and is accessible via the generic document folder in iSams.

Final Provisions

No amendment to this Contract is effective unless it is in writing, identified as an amendment to this Contract and signed by each party.

If any provision of this Contract, wholly or in part, is or becomes void, invalid or unenforceable, the effectiveness and enforceability of the remaining provisions shall not be affected thereby. To the extent legally permitted, the void, invalid or unenforceable provision shall be deemed to be replaced by a legally valid and enforceable provision which comes as close as possible to the economic and legal purpose pursued by the parties. The same shall apply in case of any missing provision in this Contract.

All legally binding statements and other notices in connection with this Contract shall be made in writing. The written form requirement shall be satisfied through transmission by facsimile or an exchange of letters. An electronic transmission (such as by e-mail) shall be sufficient to satisfy the requirement that notices be made in writing.
