Code Red/Lockdown Drills

1st - 6 weeks of school (Aug/Sept)

1st - 6 weeks of 2nd semester (Jan/Feb)

Severe Weather Drills

1st semester - Sept/Oct/Nov

2nd semester - Jan/Feb/March
