#### **Lead Grounds Maintenance Worker**

#### JOB SUMMARY:

Under the direction of the Director of Maintenance and Operations, lead and provide grounds maintenance services at assigned sites; ensure attractive and safe grounds areas and athletic fields; perform a variety of special grounds maintenance operations; prepare and maintain athletic fields; provide training and oversight of assigned staff; maintain grounds for assemblies, events and recreational activities.

### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Mow lawns, fields and other grounds; apply fertilizers, pesticides and herbicides; promote healthy growth and controlling insects and weeds in accordance with established procedures.
- Prepare grounds and athletic fields including fertilize soil, protect against erosion, courtyards, flower beds, and paint stripping; provide adequate, attractive and safe areas for assemblies, recreational activities and athletic events.
- Maintain, operate and adjust irrigation controllers and sprinklers according to manufacturer's instructions; perform minor repairs and setting times; ensure systems are in proper working condition.
- Lead and train assigned staff; provide work direction and ensure tasks are completed in a safe and timely manner.
- Clean landscaped areas and related items such as raking leaves, removing trash and sweeping walkways; prevent flooding and remove hazards.
- Prunes trees, hedges and shrubs to ensure safe and attractive grounds.
- Inspect equipment for mechanical problems; ensure necessary repairs are made.
- Maintain job related grounds keeping equipment routine repairs and minor adjustments; ensure safe and proper operating conditions.
- Maintain playground equipment; ensure the availability of equipment in safe operating condition in compliance with established guidelines.
- Request materials, supplies, equipment, and support personnel; complete assignments in a timely manner.
- Respond to immediate safety and operational concerns including facility damage, vandalism and alarms; undertake appropriate action or notify appropriate personnel for resolution.
- Operate a variety of power-driven equipment such as tractors, mowers, edgers, blowers, power pressure sprayers and other equipment used in grounds maintenance work; utilize standard gardening hand tools.
- Transport a variety of tools, equipment and supplies; ensure the availability of materials required at job site; drive a vehicle to conduct work.

### **OTHER DUTIES:**

Perform related duties as assigned.

### Education and Experience:

Any combination equivalent to: graduation from high school and two years of general grounds keeping experience in gardening or maintenance.

### Knowledge of:

- Grounds maintenance procedures including mowing, edging, raking and weeding.
- Methods, equipment and materials used in gardening and grounds maintenance work.
- Cultivating, fertilizing, watering and spraying of flowers, trees and shrubs.
- Procedures, methods, materials and equipment utilized in the installation, repair and maintenance of irrigation systems.
- Operation of hand and power tools and equipment used in ground maintenance.
- Principles of training and providing work direction.
- Basic inventory methods and practices.
- Oral and written communication skills.
- Interpersonal skills using tact, patience and courtesy.
- Methods and materials used in controlling weeds and other pests.
- Record-keeping and basic report preparation techniques.
- Basic arithmetic calculations.
- Health and safety regulations.

#### Ability to:

- Oversee and participate in grounds maintenance and gardening activities in the beautification of organization-wide grounds and landscaped areas.
- Lead, train and provide work direction and guidance to assigned personnel.
- Coordinate grounds maintenance activities to meet organization-wide needs.
- Mow, edge, water, weed, fertilize, rake and cultivate lawns, flower beds, athletic fields and other landscaped areas.
- Assure athletic fields and grounds areas are maintained in a clean, orderly and safe condition.
- Operate and maintain hand and power tools and other equipment used in grounds maintenance.
- Apply specialized chemicals to control and eradicate weeds, gophers and other pests.
- Work independently with little direction.
- Maintain records and prepare reports.
- Observe health and safety regulations.
- Meet schedules and timelines.
- Assign employee duties and inspect completed work for accuracy.
- Communicate effectively both orally and in writing.
- Establish and maintain cooperative and effective working relationships with others.

- Dexterity of hands and fingers to operate grounds maintenance equipment.
- Walking or standing for extended periods of time.
- Seeing to perform gardening and grounds work.
- Lifting, carrying, pushing or pulling heavy objects as assigned by position.
- Sitting for extended periods of time to operate mowers and other machines.
- Bending at the waist, kneeling or crouching.
- Reaching overhead, above the shoulders and horizontally.
- Heavy physical labor.
- Generally, the job requires 10% sitting, 50% walking and 40% standing.

### Hazards:

- Exposure to chemicals used in pest control and weed abatement.
- Working around and with machinery having moving parts.
- Working on ladders.
