Executive Summary

Budget Perspective

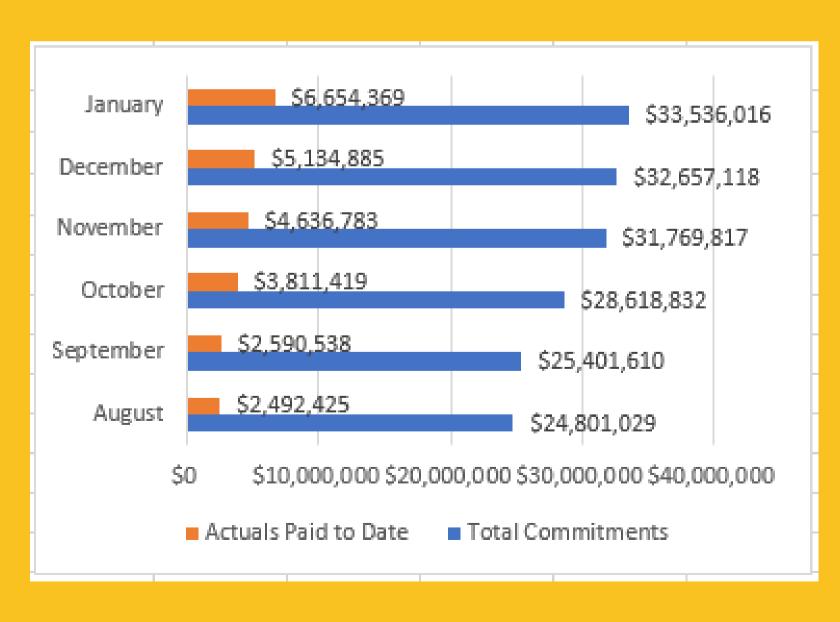
- Energy Trust of Oregon incentive checks received for BHS, AHS Office Relocation and Raleigh Hills in the amount of \$20,900.
- Transferred \$2.2M from Deferred Maintenance to Five Oaks Seismic for non-seismic work, such as mercury gym flooring.

Schedule Perspective

- Pence Contractors was selected at the CM/GC for the Raleigh Hills replacement. They will immediately begin estimating and constructability review.
- Modernization Phase 1 projects on pause to evaluate phasing schedule.
 Will likely look to front-end classroom technology.
- The Sato Classroom addition will start construction on Spring Break.
- Phase 2 cameras installed under security upgrades.
- Changing to a badge only and no key policy for the district.
- Generator projects at Fir Grove and Sexton Mountain underway.

Challenges and Opportunities

- In December, we submitted grant applications for the seismic projects at Five Oaks and Mountain View. IF awarded, they would be \$2.5M/ea.
- Whitford Reimagine video and device testing video complete.
