# **REGISTRATION AND APPLICATION FEE**

- Application fee is a one-time fee, due at the time of application. The fee is non-refundable.
- Registration is an annual fee. It is first due at time of enrollment and each year thereafter during the re-enrollment period. The registration fee is non-refundable.
- Registration Fee includes office records, student accident insurance, and consumable supplies.

# **TUITION ACCOUNT AND PAYMENTS**

- Tuition fees are effective August 28, 2023.
- ♦ Heights Christian Schools partner with Tuition Express to provide secure and convenient payment through Auto Pay.
- ♦ All tuition payments and incidental fees will be automatically drafted from the preferred payment method on the 1<sup>st</sup> of the month.
- There are no other discounts other than those listed on the reverse side.
- ♦ The monthly tuition fee is the same regardless of how many days or weeks are in a month.
- The monthly tuition fee is the same regardless of sick days, vacation days, holidays, or mandated temporary closures or periods of guarantine or isolation.
- ♦ All HCS preschools will be closed Thanksgiving Week (Monday-Friday) and Week of Independence Day (Monday-Friday) for Professional Development Days and the holidays.
- ♦ Accounts with any outstanding balance will be assessed a late fee of \$25 after the 5<sup>th</sup> of the month.
- When making a payment, the payment will first be applied to any outstanding balance on the account, and the remainder will then be applied to the current balance.
- Accounts that are not paid in full by the end of each month may result in the student being disenrolled.
- ♦ A service charge of \$30 will be assessed for each returned payment.
- A fine of \$1 per minute per child for late pick-up after 6:00PM will be assessed.
- A fine of \$5 will be assessed each time a parent does <u>not</u> use their <u>full name</u> when signing their child in or out. Parents must use their full name when signing their child in and out, per state regulations.
- A charge of \$1 will be assessed for each occurrence of the preschool having to provide a blanket and sheet for the child. State regulations require that each child have their own blanket and sheet to lie on for rest time. Parents are to provide a freshly washed blanket and sheet each Monday.
- Mid-month enrollment will be pro-rated for new families only.
- ♦ A two-week written notice to the school office is required upon withdrawing your student. Mid-month withdrawals will be subject to a tuition pro-rate <u>only</u> if the required two-week written notice is given to the school office. Families withdrawing their students the last day of the month <u>who do not give</u> the required two-week notice to the school office will have their account charged two week's pro-rated tuition.

# **PROGRAMS AND ATTENDANCE**

- ♦ It is the parent's responsibility to notify the preschool office of any needed program changes.
- Parents can use our emergency drop-in if they need their child to attend on a day that is not part of their regular program. Daily rate fee is due at the time of student drop-off. Drop-ins accepted if space permits.
- Credit is not given for missed days regardless of the reason; there is no swapping of days.

# HOLIDAYS AND TEACHER'S IN-SERVICE DAYS

 Our preschool is open year-round. We are closed on the following days: Presidents' Day, Good Friday, Memorial Day, Week of Independence Day (Monday-Friday), Labor Day, Thanksgiving Week (Monday-Friday), Christmas Break (December 24 through January 1), the first Monday in October, and Teacher's In-Service Days (see preschool calendar).
