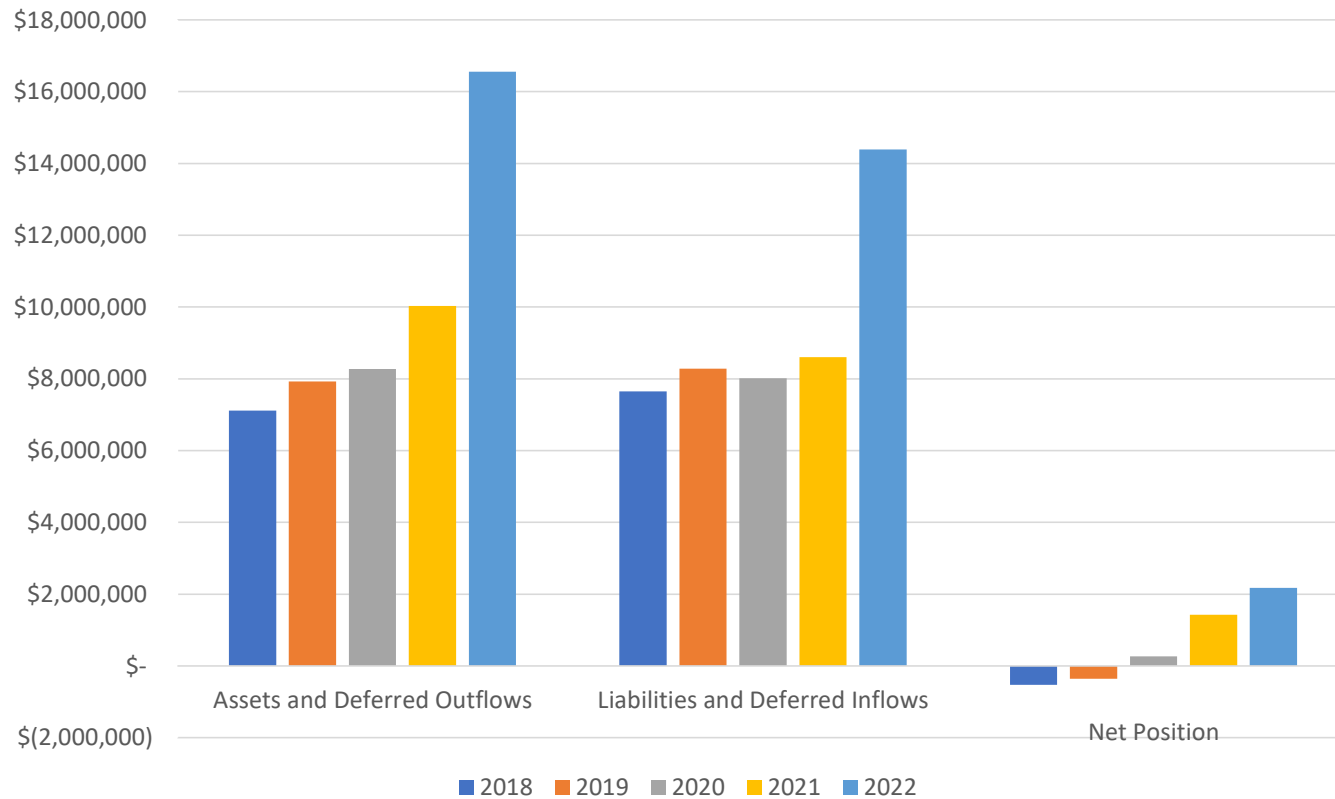

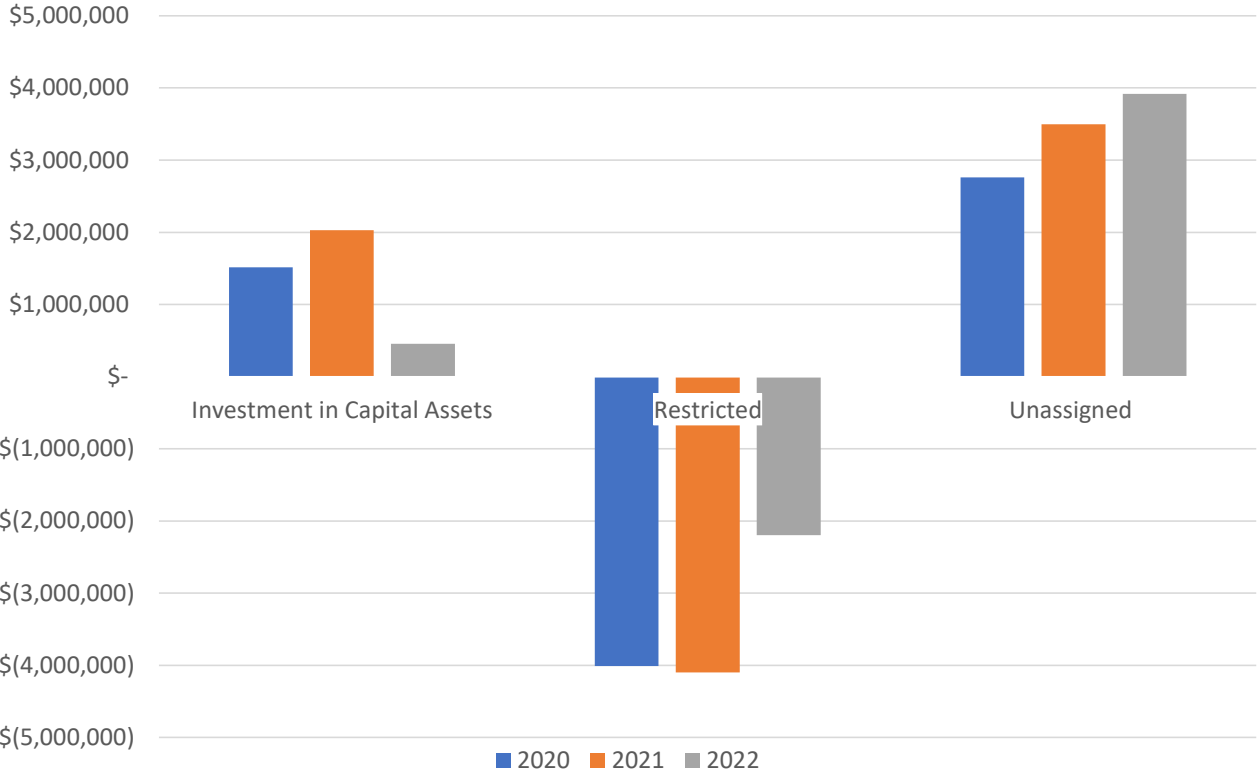

STATEMENT OF NET POSITION

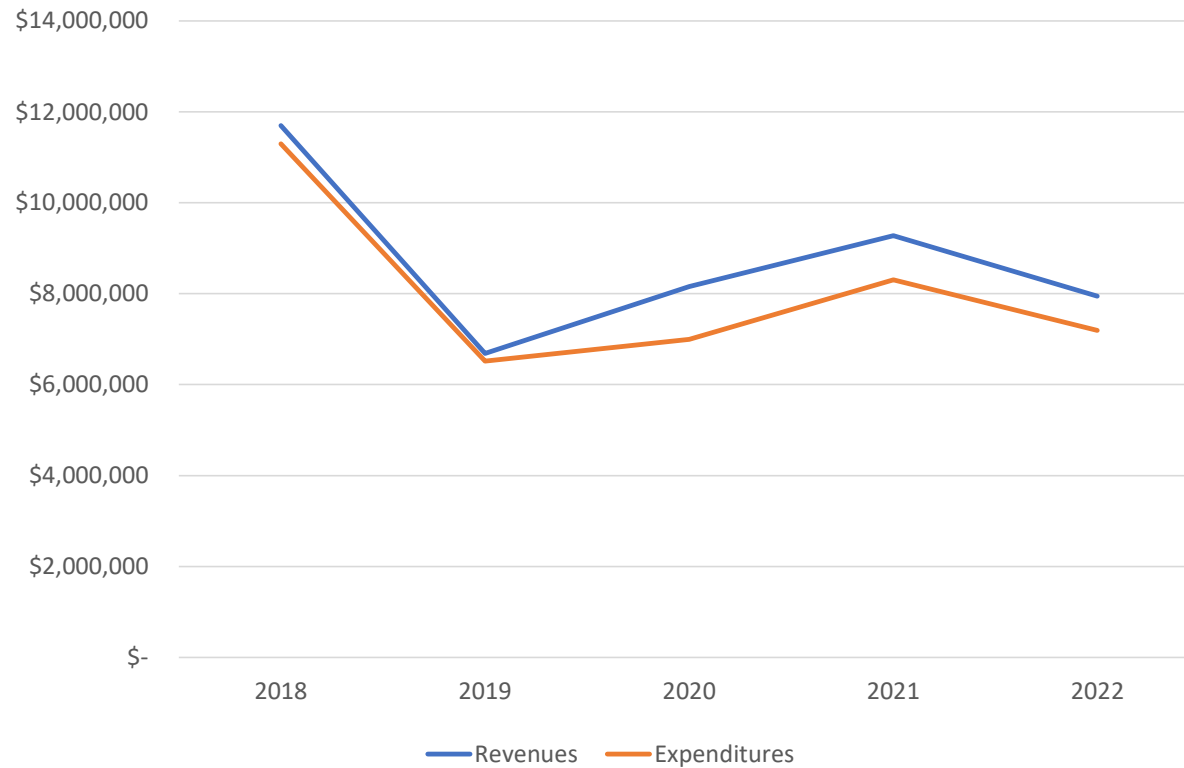
TRENDS DISTRICT WIDE



DISTRICT-WIDE NET POSITION ANALYSIS

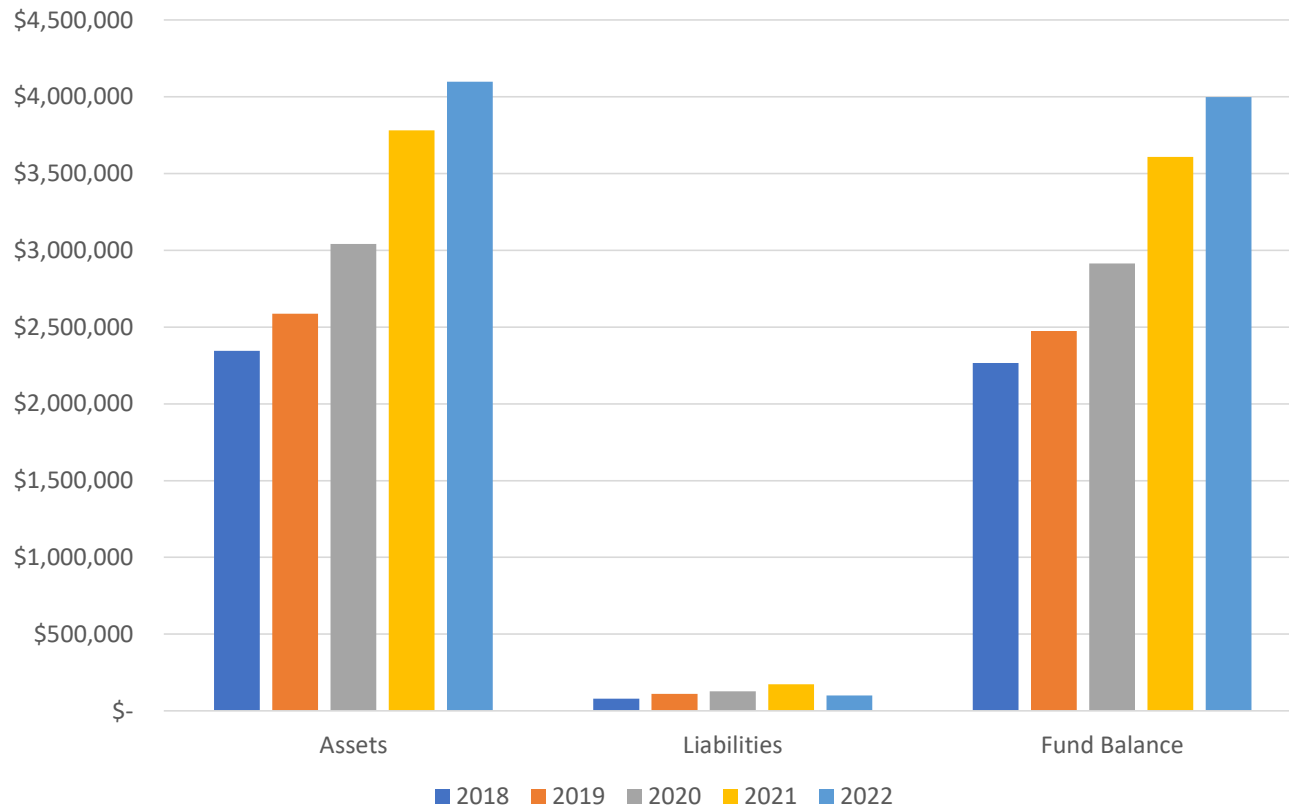


REVENUE OVER EXPENSES – DISTRICT WIDE

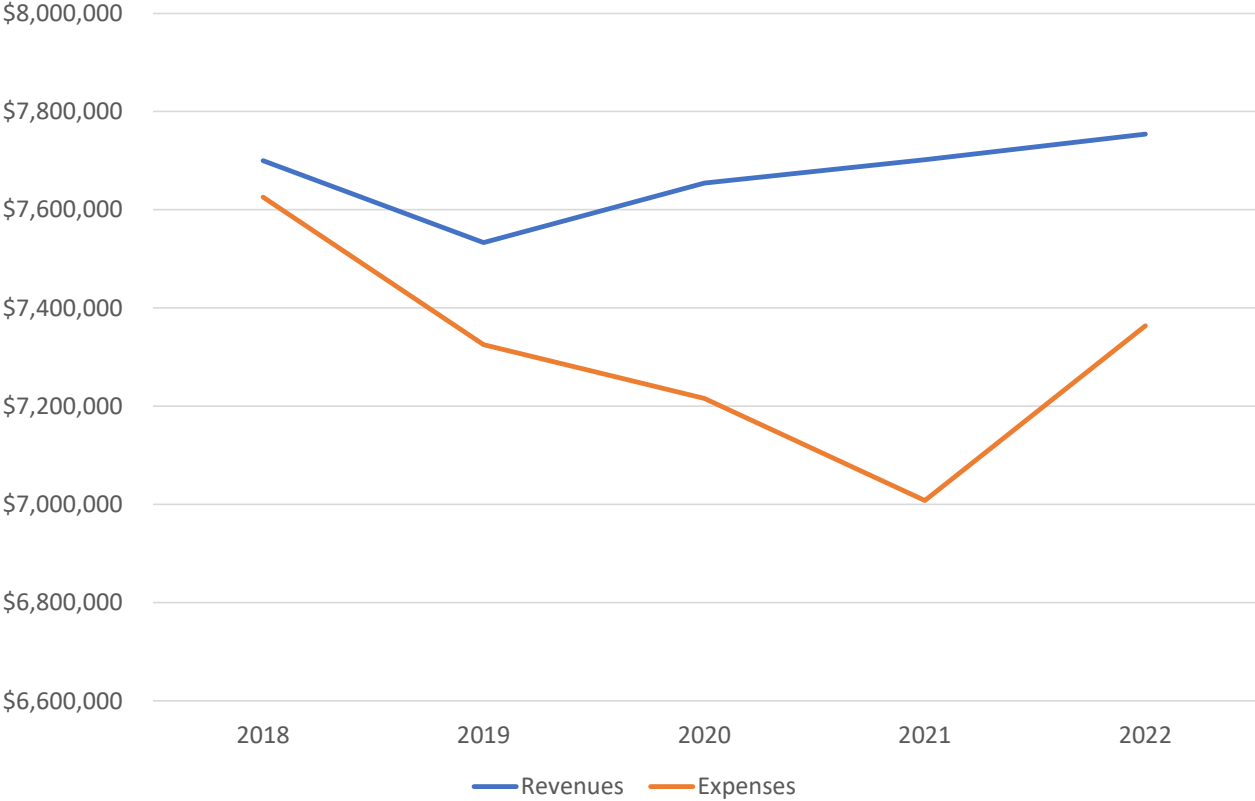
