**Approx. 1 hour after auditions conclude, team results posted by number on Blue Angels website. For those auditioning for Elite, this will be denoted with an asterisk next to the number.

Eligibility Requirements:

- 1. Students must be enrolled as a student at Little Elm HS, or 8th grader at Walker or Strike Middle School. If a student is not enrolled in LEISD at the time of tryouts, they are not eligible to audition. If the student is not currently enrolled in LEISD but provides documentation of intent to register (i.e. housing contract, lease, etc.) the student may tryout at that campus. Candidate must attend all mandatory meetings and/or practices.
- 2. All candidates are eligible to attend the three workshops and tryouts *regardless* of academic standing. ALL THREE WORKSHOPS ARE <u>EQUALLY IMPORTANT</u> TO ATTEND!
- 3. All student athletes in grades 7th 12th must complete all LEISD and UIL forms annually to participate in any tryout or practice and to be placed into any athletic period. Forms <u>must</u> be completed prior to each new school year for all athletes. This includes a physical.

3 Workshops: (March 6th-10th)

- 1. Only the students auditioning for Blue Angels will be admitted to the workshops. All practice sessions and auditions are <u>closed</u> to the public.
- 2. All workshops will begin promptly at 5:30pm <u>PLEASE be on time.</u>
- 3. Wednesday is an optional open gym. Attendance will not be taken. This serves as an additional opportunity to have space to practice.
- 4. Candidates must wear a fitted top, dance pants/capris/leggings (any colors allowed) during workshops. Black jazz shoes must be worn at all times. NO SHORTS OF <u>ANY KIND</u> WILL BE ALLOWED!
- 5. Hair must be in a ponytail. (Pulled back and out of your face)
- 6. No gum is allowed and ALL jewelry must be removed before the workshop begins.
- 7. Food and drink are not allowed in the gym. (However, a closed top *water* bottle is permitted)

Auditions: (March 10th)

- 1. Only those students auditioning for Blue Angels will be allowed into the tryout area, along with any senior Blue Angel members who are assisting.
- 2. All candidates will have an individual number and a group number assigned to them. Each group will consist of 4-5 dancers. Judges know the candidates <u>ONLY</u> by number no names are used.
- 3. Candidates should wear appropriate drill team make-up: neutral color eyeshadows, blush, *red* lipstick, black mascara/eyeliner.
- 4. No jewelry is allowed (including stud earrings/nose rings) and hair must be in a ponytail. No ribbons or scrunchies are allowed.
- 5. Candidates must wear the following items for auditions:
 - Solid black fitted T-back sleeveless top, solid tank top (no spaghetti straps) or solid leotard
 - Solid black Jazz pants or leggings (*no capris*)
 - Black Jazz shoes (any style)







Judging Criteria:

1. All candidates will be judged on the following categories. The judging score sheet is listed within this packet.

a.	Poise	5 pts
b.	Splits (Rt- 5, Lf-5)	10 pts
с.	Dance Technique	25 pts
d.	Kick Technique	20 pts
e.	Showmanship	10 pts
f.	Memory	20 pts
g.	Timing and Rhythm	10 pts

- 2. The judges only know each candidate by number NO NAMES WILL BE USED.
- 3. At the bottom of the scoresheet, if the candidate wishes to be considered for the Blue Angels Elite team, the judges will make that determination. This aspect does not affect the overall tryout score.
- 4. Each candidate must remain at the audition site until the Director dismisses the candidates in the event that callbacks are necessary.
- 5. Results will be posted approximately 1 hour after tryouts are completed on the Blue Angels website. ONLY numbers will be posted and in numerical order. https://www.littleelmisd.net/blueangels
- 6. After tryouts occur you <u>may</u> ask to see your scores. However, you must go through Mrs. Infante (LEHS House Principal over Drill Team). If you wish to see your scores contact Mrs. Infante at minfante@littleelmisd.net to set up an appointment. The deadline to request scores from the 2023-2024 tryout will be Friday, March 24th.

IMPORTANT INFORMATION & DATES IF YOU MAKE BLUE ANGELS:

MANDATORY New Team/Parent Meeting:

The Director will meet with just the team members first to go through some basics and introductions. Then, while the students are trying on sizers/taking measurements Mrs. Miner-Selby will conduct a parent meeting in the Lecture Hall.

 - Parents will receive a copy of their Blue Angel's dance attire price sheet to see the cost of items to be purchased as well as reminders and upcoming dates.
 - During that same time, the team will have an attire fitting using sample sizers.
 - Wear tight fitted clothing to try on sizers, get measured, & bring a <u>pencil</u> to record sizes.
 - Everything must be paid in full **<u>before the end of the school year</u>** as our fiscal year closes.
- 6:30pm 7:00pm Dance & Social Officer Interest Meeting
 - Candidates interested in a leadership position should stay to hear about the requirements and tryout process for the upcoming school year.

Team Camp:

- Team Camp will be in two parts this summer:

- Directly after the 22-23 school year has concluded, the new team may have a Boot Camp with the Directors and officers that will require 2 practices. These dates are TBD and will be available after tryouts at the new team meeting. We will use this time to learn Game Day material in preparation for football season!
- At the end of July, we will host professionals in the industry to teach choreography for the upcoming year: pep rally routines, field routines, competition routines and master classes. This will be hosted at LEHS from July 24th 28th from 8:30am 4:30pm.

• These dates are set and provided as far in advance as possible so that you may schedule summer plans accordingly. We aim to have camp the week before teacher inservice starts.

GUIDELINES FOR EXTRACURRICULAR ACTIVITIES

Students involved in extracurricular activities are held to a higher standard of conduct than the general student body. The Blue Angels organization views participation in extracurricular activities as a privilege, not a right. Any student who violates the Student Code of Conduct shall be subject to extracurricular discipline and/or regular school district disciplinary action. This includes any misconduct, regardless of time or location, that would reflect negatively upon Little Elm ISD in an extracurricular activity. Students clearly involved in major disciplinary infractions (i.e. including, but not limited to, drugs, alcohol, and violent behavior) will be placed on probation, removed temporarily, or removed permanently from extracurricular activities. Seasons of extracurricular activities may vary and could extend into the next school year. Disciplinary action may affect tryout eligibility for the next season. Disciplinary measures taken by the sponsor/principal may be in one or more of three forms, defined as special assignments, probation, and dismissal. Special assignments may consist of extra duties and may be assigned for minor disciplinary infractions. Probation and/or dismissal from extracurricular activities will be for infractions involving alcohol, smoking, drugs, use of profanity, violence, and other serious offenses when the sponsor/principal believes the integrity and credibility of the organization has been jeopardized by the student's action. Probation may also be assigned when the student fails to comply with rules and regulations of the extracurricular activity. (Probation is defined as: A trial period in which a student is permitted to redeem bad conduct.) The student may be dismissed from the extracurricular activity upon any major infraction, or during a probationary period. Prior to being dismissed from extracurricular activities, the student and parents will be notified of the reasons for the action. The student will not be eligible for any individual or team recognitions or awards that occur after the date of dismissal.

Blue Angels Drill Team Constitution 2023-2024

The purpose of the LEHS Blue Angels Drill Team program is to conduct a successful extra-curricular program that consists of members that display positive attitudes as well as promote school spirit and exhibit high morals. The LEHS Blue Angels Drill Team is a program that fosters creativity, strengthens leadership qualities, and provides a creative outlet for students. In addition to the development of drill team dance skills, the drill team shall promote school spirit, good sportsmanship, encourage teamwork, develop leadership skills, serve as positive role models in the community and support the mission of Little Elm High School.

Article I-Name

The name of this organization shall be the Little Elm High School Blue Angels Drill Team.

Article II-Purpose

The Blue Angels will function as a support organization representing Little Elm High School. The Blue Angels will provide entertainment at all football games, home basketball games (schedule permitting), pep rallies, competition and Spring Show.

Article III-Special Performances

The Blue Angels may also perform in special performances such as the Little Elm Christmas Parade, competition, and any other venues/performances selected and approved by the Director. The team might not attend competition every year. The Director will make this decision on a year-by-year basis. All members will be expected to participate in all activities and performances.

Article IV-Code of Ethics

Being on drill team is a privilege, not a right. As a result LEHS Blue Angels members will take pride in themselves and in the Blue Angels organization as they are held to a higher standard. They will conduct themselves in an appropriate manner and will maintain the highest moral & ethical standards at *all times*. This includes, but is not limited to:

- 1. Following all laws concerning consumption and possession of illegal substances.
- 2. Using appropriate language.
- 3. Not having body piercings (other than ears) or visible tattoos.
- 4. Acting in an appropriate manner reflecting the values of the organization.
- 5. Being the only students allowed to wear any "Blue Angel" apparel and uniform pieces.
- 6. Making up any missed work so that you do not become ineligible.
- 7. Facebook, YouTube, Twitter, Instagram, SnapChat, TikTok etc. Warning: Blue Angels members should be extra cautious and aware of the fact that these types of web pages and the postings they contain are in public view. All Blue Angels members are reminded to maintain high ethical and moral standards when posting and also reminded that others can easily post such things as pictures of Blue Angels members on their own pages, which can result in negative attention upon the team. All Blue Angels members are reminded to avoid situations which could lead to this type of situation where embarrassment to themselves, their parents and the team as a whole is the end result.
- 8. Gossip: every person has passed on gossip. Every person has been hurt by it. The difference is that if we are to be a team we simply cannot afford idle words. Always ask yourself, "If she walked into the room, would I continue my conversation?" If not, then you should reconsider the benefit of those who have to listen to you

Article V-Grades

- 1. Grades for Blue Angels Drill Team class will be assessed by the willingness to follow policies, procedures, and by participation in class. (Demerits)
- 2. Each Blue Angel member will receive a weekly grade, for every demerit received in that week **2 pts** is deducted.

Article VI-Summer Camp & Summer Practice/Practices/Performances/Attendance Procedures

Summer Camp/Summer Team Practice:

- 1. Summer Camp/Summer Team Practice It is **mandatory** for **all** Blue Angels members to participate in summer camp practice & summer team practice.
- 2. Summer Camp is an important building block for a successful year.
- 3. Any member who misses camp, for whatever reason will be expected to learn any choreography and material taught during camp on their own time. They will also receive 5 demerits (if considered an unexcused absence) and will not be able to perform at the first Blue Angels performance once school begins in August.
- 4. Special practices will *not* be formally arranged for those who miss any days of camp.

Practices:

- 1. Practices will be conducted by the Director and assisted by the Officers.
- 2. Proper attire must be worn at all times.
- 3. No gum, food, or open drinks (except water) in the dance room at any time, unless approved by the Director for a specific reason or occasion. Please help keep our dance room clean!
- 4. All dance bags and personal items should be stored and LOCKED in school lockers or assigned lockers. You may **not** leave items in the gym or on the floor of any dance area during practice.
- 5. Cell phones may **not** be turned on/used during drill team practices or events (excluding bus rides), unless otherwise given permission by the Director.
- 6. Only the Director is to operate any school-owned video/audio equipment unless given permission of the Director.
- 7. Blue Angels members should not be in the Director's office or the storage closets unless invited or sent in by the Director for a specific purpose.

Performances:

- 1. It is possible to be a member of the Blue Angels and *not* perform in every performance. This includes football, basketball, competition, pep rallies, Spring Show, and any other performance selected by the Director.
- 2. Selection for routines may be based on auditions if the Director chooses. If auditions are necessary, the Director will announce them at least ONE week in advance of the performance.
- 3. During the performance tryout process, Blue Angels will be judged by the Director and officers. The Director makes the final decision on which members will perform.
- 4. Feedback from each routine tryout is available to each Blue Angel to discuss with the Director.
- 5. If a member misses an audition for *any reason* they will not perform in that routine.
- 6. If a Blue Angel member is not performing with the team, they will *still* attend the practices and performances in uniform. If they are academically ineligible they will still attend practices, but may **not** attend performances in uniform or travel with the team per UIL guidelines.
- 7. Blue Angels will not be allowed to talk to friends or family members while in the stands at football or basketball games. If an emergency arises, the Blue Angel member must clear it with the Director.

Specialty Groups: (Blue Angels Elite)

- 1. It is up to the discretion of the Director whether to offer specialty groups such as elite dance teams.
- 2. Any member is eligible to audition for a specialty group as long as they meet specific requirements defined by the Director.
- 3. Any specialty group member put on probation (academic or disciplinary) during the course of the year must step down from their position immediately and permanently.
- 4. Returning members of specialty groups must try out each year for a place on the team.
- 5. The amount of positions will be determined by the Director to meet specific needs of the team.
- 6. Scoring system for Elite will be determined by the Director and published prior to tryouts.
- 7. There may be additional time commitments for Elite team members to learn choreography and practice.

Attendance: (Blue Angels Drill Team follows Little Elm High School's Attendance Policies)

- 1. All practices and performances are mandatory. Schedules will be announced as far in advance as possible.
- 2. It is the student's responsibility to avoid scheduling work, going out of town, medical appointments, private lessons (piano lessons, dance class, driver education courses, etc.), and any other conflicts with time periods involving drill team activities. These activities will be considered **unexcused** absences and will result in consequences as per Article VII.
- 3. If a drill team activity conflicts with another school-related activity, then the Director and the other teacher(s) involved should be notified in writing as far in advance as possible. The Director and the other teacher(s) will confer and work out the best solution to the problem. Under no circumstances is the student to do as he/she pleases and then use the conflict as an excuse.
- 4. An <u>excused</u> absence from a rehearsal or performance is one that would be accepted by the attendance office (personal illness, death in the family & religious holidays).
- 5. Special problems or situations that might require an absence should be requested in writing two weeks in advance. *A two week notice does not guarantee approval, but is required before approval may be considered.*
- 6. If last minute emergency situations arise, the Director should be contacted by email, phone, or in person if at all possible.
- 7. No matter the situation, if a Blue Angel member misses <u>practice</u>, they are *expected to bring a written explanation of the absence from their parent/guardian upon returning to school.*
- 8. Blue Angels members will attend tutorials and make-up tests <u>before</u> school or during a tutorial time designated by the Director. If an emergency arises, you **must** secure permission from the director in order to miss practice. <u>Not all</u> requests can or will be granted. This is only to be used in emergencies. *(Little Elm High School offers morning AND afternoon tutorials to accommodate the students with morning or afternoon commitments).*
- 9. If a Blue Angels member misses two or more practices in the week of a performance, then she will not be in the performance(s). No Exceptions.
- 10. If a Blue Angels member is going to be absent, the Blue Angels member must either call Little Elm High School and leave a message for the Director at 972-947-9443 ext. 25119 or via email mminer@littleelmisd.net. (Email is always best). If a Blue Angels member fails to e-mail or call, she risks being cut from the next performance. The message must be received in advance of the absence.
- 11. If a Blue Angels member must leave early from a scheduled practice, one day advance notice is required. *However, if the reason is considered 'unexcused,' demerits will be received.*

- 12. The day returning from the Holiday/Winter break begins a new attendance policy for competition/spring show:
 - a. If a Blue Angels member misses a rehearsal of the same (Competition/Spring Show) dance 4 times, they will be cut from the dance...even with a doctor's note.
 - b. If a Blue Angels member misses a weeks' worth of rehearsal or more, they **must** attend drill team tutorials for an entire week to rehearse their lost rehearsal time.
 - c. If they fail to attend drill team tutorials, this could result in being cut from a dance (*Director's discretion*).
 - d. The week before Spring Show will require *every* member (including managers) to attend the rehearsals. The Director will not know the rehearsal schedule until the week before, therefore it will not be possible to know in advance which routines require more work (and therefore which students will be more heavily involved.) Traditionally, all Blue Angels have always been heavily involved that particular week.
 - e. ALL Blue Angels members (including managers if needed) **must** attend the *one* Saturday rehearsal from 9am-5pm in preparation for **Competition**. *NO EXCUSES*!
 - f. ALL Blue Angels members (including managers if needed) **must** attend the *one* Saturday rehearsal from 9am-5pm the month of **Spring Show**. *NO EXCUSES!*
 - g. Saturday rehearsal times are dependent on the amount of work to be done.
 - h. All Blue Angels members (including managers) **must** be present for all team rehearsals during the week of Spring Show.
 - i. Any **OFFICER** that misses practice for **ANY** reason (even with a doctor's note) 4 times for **ANY** dance/ **ANY** rehearsal will be cut from a dance of Director's choice.
 - j. The previously listed elements of the attendance policy in the constitution are unchanged for the Spring Semester.
 - i. No scheduling tutorials that conflict with practice times.
 - ii. No scheduling doctor's appointments during drill team practices, etc.
 - iii. Please note demerits for unexcused absences will *still* be given.

COVID Addendum: If a Blue Angel is quarantined during competition season, per official documentation from the school, and will miss *more than 3 days of rehearsal*, they will be removed from dances regardless of audition results. If the Blue Angel has made a routine, they will be removed and serve as an alternate in case they are needed to substitute back in at the discretion of the Director. Serving as an alternate does not guarantee performance.

Article VII-Demerits/Probation/Merits

Discipline is essential for a drill team to run properly. In order for the Little Elm High School Blue Angels Drill Team to function in this manner, the team will operate on a merit and demerit system.

- 1. Only the Directors and officers are allowed to issue demerits.
- 2. An officer can give demerits to a team member (for obvious reasons such as incorrect shirt, etc).
- 3. Demerits begin the 1st day of summer team practice (line camp) and end the last day of school.
- 4. Each team member will be required to sign their demerit sheet when they are given demerits.
- 5. Signing or not signing the demerit sheet has no effect on the receipt of the demerit.
- 6. For every 5 or more demerits accumulated, the Blue Angels member will not be allowed to perform in the next performance/activity. *However, if a 5th demerit or greater is issued on a performance date, the removal of the student will take place at the next scheduled performance.* The Blue Angels member is still required to attend and participate in all practices. They may not do homework or attend tutorials during this time. They must also attend the performances in uniform.
- 7. After tryouts, the student is considered part of the new school year drill team; therefore, infractions that occur after tryouts then become part of the new school year. Drill Team members may be placed on probation, removed temporarily, or removed permanently.

Probation: Listed above are possible grounds for probation and dismissal from the team after a review with the Director, House Principal and Parent(s). The Director will determine punishment on a case by case basis.

- 1. If a Blue Angels member is placed on probation for any reason it will be for a minimum of *three weeks*. The Blue Angels member will not perform during this time and will continue to attend practices and attend performances in uniform.
- 2. While on probation, if another offense occurs, it may be grounds for dismissal from the team after a review with the Director, House Principal and Parent(s).
- 3. If a Blue Angels member is placed on probation twice (either first and second semester, *or* twice in one semester), she may be dismissed from the team after a review with the Director, House Principal and Parent(s).
- 4. Probation is for disciplinary actions only. If a Blue Angels member is academically ineligible, she is not on disciplinary probation.
- 5. Blue Angels members on probation need to work off their demerits while on probation.

Merits:

- 1. Blue Angels members have the opportunity to earn merits to erase demerits.
- 2. It is the individual's responsibility to ask the Director how they may earn merits.
- 3. Once a member reaches 5 demerits, any merits earned will be applied after they miss one performance.
- 4. Merits will not impact the student's nine-weeks grade, only eligibility to perform.
- 5. It will be up to the discretion of the Director on how the merits are earned. (Cleaning, organizing supplies, community service, etc.)

Article VIII-Academic Eligibility

- 1. All members are expected to be academically eligible as per UIL regulations.
- 2. If a Blue Angels member becomes ineligible, they will attend and participate in all practices.
- 3. Academically ineligible members may not attend performances in uniform or travel with the team.

Article IX-Uniforms

- 1. Uniforms, costumes, poms, props, etc. are provided by LEISD and are the property of Little Elm High School.
- 2. Each member will be required to sign a uniform contract upon receipt of their uniform.
- 3. It is the Blue Angels member's responsibility to treat uniforms with care. It should be returned in excellent condition.
- 4. No alterations are to be made without written consent from the Director.
- 5. Damaged or lost items will be repaired or replaced at the individual member's expense.
- 6. The Director should be contacted immediately if the uniform is damaged. (This includes broken zippers, fraying fringe, etc.)
- 7. The Blue Angel uniform/costumes are not to be worn in public for the exception of traveling to and from performance sites unless the Director gives personal permission for a specific reason.
- 8. Blue Angels members will not eat or drink (except water) while in a uniform/costume.
- 9. Wearing make-up in the Blue Angels uniform and/or a Blue Angels costume is required.
- 10. Nail polish will NOT be worn for any performances and/or in uniform or costume. Nail polish of a neutral color may be acceptable at the Director's discretion.
- 11. If a Blue Angels member leaves the team for any reason, all uniforms and equipment must be returned immediately. In this matter, uniforms will be treated like textbooks, etc. and the student will not be allowed to register or have their transcripts forwarded if transferring until these items have been properly-returned and inventoried.

Article X-Transportation

- 1. Travel to and from drill team performances and outside activities will require school provided transportation unless a <u>written request</u> to ride home with a parent is provided 24 hours in advance. If in charge of equipment, the Blue Angels member must bring back equipment following the activity or on a given date designated by the Director.
- 2. Students must have their Medical Release/Emergency Form on file before they may travel with the team.
- 3. All drill team members must be off LEISD property within 15 minutes of dismissal or demerits may be issued.
- 4. Buses will be left spotless and Blue Angels will always treat bus drivers with respect.
- 5. Bus must be cleaned/cleared of trash when the trip has ended. *1 piece of trash = 100 kicks*

Article XI- Hazing

LEISD School Board Policy prohibits hazing. There will be no hazing or initiation of new members (including Dance Officers/Social Officers). Anyone engaging in these activities (even hazing others who are NOT on Blue Angels) falls under the district's policy for the Extracurricular Code of Conduct.

Article XII- Director Communication

- 1. Parents and/or Blue Angels should address their concerns with the Blue Angels Director before contacting a school administrator. Just as with any class, the teacher should be contacted first and allowed to address the issue. If the concern is not addressed to the satisfaction of the student or parent, then contacting an administrator is encouraged.
- Any concerns you may have with the Director email is the quickest way of communicating with the Director. (mminer@littleelmisd.net) However, you may leave a message for the Director via her voice mail at 972-947-9443 ext. 25119. The Director will make every effort to return your email or call by the following *school day*.
- 3. Meeting in person with the Director may be arranged during the Director's conference period Monday Friday.
- 4. If a concern arises when school is not in session (summer, holidays), parents may contact the Director via email. The Director will return emails as soon as possible; however, accessibility to the Director will be limited during these times.
- 5. If a Blue Angels member has a concern after school/practice hours, then he/she should contact their dance officer.
- 6. Parents will not contact a Blue Angels officer regarding a concern. All parent concerns must be addressed with the Director.
- 7. Please contact the Blue Angels Director through school email or school telephone only.

Article XIII – Leadership Positions:

Little Elm Blue Angels Drill Team Dance Officers

- 1. The Blue Angels will have dance officers that will consist of 11th- 12th graders only. Each officer candidate must be a current Blue Angel member in good standing.
- 2. The Blue Angels dance officers will be expected to assist the Director in teaching and choreographing routines, leading practice, and organizing events.
- 3. The ranks will be as follows: Captain, First Lieutenant, and Lieutenant(s). The Director may amend these rankings as desired.
- 4. All rules and regulations apply to the dance officers.
- 5. Should a dance officer fail to follow-through with their assigned duties or should their attitude be questioned, they will be dismissed from their position.
- 6. Should an officer exceed 10 or more demerits, they will be removed from their position. Dance officers are responsible for providing an excellent example for the team.
- 7. Occasionally, the dance officers will be given the opportunity to perform as an officer group which includes both Captain and Lieutenants. These performances will be designated by the Director and should not be assumed by the officer squad. Each year is different and the opportunities can vary from year to year.

IT IS AT THE DIRECTOR'S DISCRETION TO DETERMINE RANKS & NUMBERS FOR ANY OFFICER POSITION.

Little Elm Blue Angels Drill Team Social Officers

- 1. The Blue Angels will have Social Officers that will consist of 10th-12th graders only. Each candidate must be a current Blue Angel member in good standing.
- 2. The social officers are in charge of social activities for the team, team building activities, birthdays, and other duties the Director may assign.
- 3. Social Officer ranks will be as follows: President, Vice-President, Secretary, Historian, Spirit Leader, and Parliamentarian. The Director may amend these rankings as desired.
- 4. Social Officers should not receive more than 10 demerits. If a social officer should exceed 10 demerits, they will be removed from their position. These leaders of the Little Elm Blue Angels are expected to be examples for the team.

IT IS AT THE DIRECTOR'S DISCRETION TO DETERMINE RANKS & NUMBERS FOR ANY SOCIAL OFFICER POSITION.

Article XIV – Little Elm Blue Angel Drill Team Managers

- 1. The Director will determine the need for managers on a year-by-year basis.
- 2. 9th-12th graders may be a Blue Angels manager.
- 3. In the event a manager(s) is chosen, they will be expected to follow all the rules and regulations stated in this Constitution.
- 4. Should a manager fail to follow-through with their assigned duties or should their attitude be questioned, they will be dismissed from their position.
- 5. Managers will be enrolled in the Drill Team class period, unless an academic schedule prevents it.
- 6. Managers are required to attend one after school practice each week if not enrolled in the Drill Team period.

- Being a part of the Blue Angels requires a <u>HUGE</u> time commitment and it is important that you understand the requirements **before** you decide to join the team. Please review the SAMPLE yearly calendar carefully and discuss it with your family.
- All Blue Angels practices, meetings and performances are mandatory. (This includes summer practice *AND* camp).
- Summer line camp/summer team practices are **mandatory**. All Drill Team members (including managers) are expected to participate. This is the time that the team learns all football routines, pep rally routines, competition routines as well as team bonding. It is **vital** that you are present for these events.
- During the school year, we will practice every day during the class period as well as after school Monday, Tuesday, and Thursdays. Practice can be up to eight hours a week *outside of normal* school per UIL guidelines. You should anticipate practice ending at 4:30 with some exceptions.
- About two weeks prior to Spring Show (March/April) we will switch to longer practices in the evenings in order to have access to the stage.
- Football games are *usually* held on Friday nights. (SOMETIMES they are on Thursdays or Saturdays as well).
- During basketball season, the team usually performs at basketball games if invited to perform.
- Blue Angels activities will be held to a minimum on the weekends. It will *average* out to be one a month. These Saturday dates are scheduled with as much advance notice as possible. It is the parent/student's responsibility to avoid scheduling events during these **mandatory** activities.
- If we attend contests/competitions, it will be on a Saturday (occasionally Fridays as well), is mandatory and is a full-day commitment.
- Spring Show will be held in the Spring semester, both Friday and Saturday nights are mandatory.


