## **JOINTLY DEVELOPED**

**East Side Elementary** will take the following actions to involve families in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by families, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

ESE's Parent Teacher Advisory Committee (PTAC) is involved in the development of our school parent and family engagement plan. The Parent Teacher Advisory Committee, comprised of administration, teachers, and parent representatives meets regularly throughout the school year to discuss and provide input for school improvement and parent and family engagement planning based on identified needs, input from families, and results from annual surveys. Cultural, economic, language, and demographics will be given attention in planning school family engagement events and activities. Additionally, family input and comments regarding this plan are welcome during the school year through an online form. The plan is posted on our school website for families to view and submit feedback throughout the year. All feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey to ask parents for their suggestions on the plan and the use of funds for family engagement. Families can also give feedback during several meetings and activities during the school year.

## **ANNUAL TITLE I MEETING**

**East Side Elementary** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all families of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the families' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

Annually in August, ESE will invite all students' families and provide information about the Title I program, the school-parent compact, family engagement and activities, a description and explanation of the school's curriculum, forms of academic assessment, and expected achievement levels.

ESE will also provide communication between families and the school through Skyward Family Access, teacher newsletters, surveys, school social media outlets, student agendas, student handbook, parent/teacher conferences, grade level parent meetings, RTI/IEP meetings, school calendar, etc. Our EL Teacher is available to translate written communications to families in a language they can understand.
