

### **Budget Expenditures**


### At 6.9%, inflation has risen sharply over the past two years putting pressure on school budgets

**Over-the-year percent change in CPI-Northeast region (October 2022)** 





# FY24 Hanover District budget expenditures proposed to increase 3.2% or \$471K, driven by special ed tuition, salaries/benefits and transportation




#### Ray School Full-time equivalent (FTE) change from FY23 Budget




### Revenue

### Net assessment is proposed to increase 8.1% or \$951K, despite budget up only 3.2% due to significant revenue changes



## Nearly all the increase is due to uncontrollable events or contracted district agreements

#### State is required "to provide a constitutionally adequate education to every educable child in the public schools in New Hampshire"




## Part of the State's funding for an adequate education comes from a statewide property tax


## If SWEPT amount raised by local properties not enough to fund adequate education, then the State uses other taxes to pay districts

Last year the State decided to cut the FY23 SWEPT rate and raise more education funds from other taxes


#### FY23 Hanover adequacy aid was high due to SWEPT rate cut


### Hanover education tax is combination of local and state school taxes


## Local school tax comprises Hanover and Dresden assessments, includes share of SAU 70 administrative costs

#### Local school assessments are proposed to increase \$2.1M or +7.09%



## Local school tax rate found by dividing local school assessments by growth in Hanover assessed properties



## Statewide education property tax is used to fund part of the State's obligation to pay for an *adequate* education


#### **Components of Hanover education tax**



\*Hanover's share of NH State's obligation to pay for an adequate education. The SWEPT rate is determined by the State. SWEPT funds are raised and retained locally. If the SWEPT amount raised is not enough to cover the State's obligation for Hanover schools, then Hanover District will receive an additional payment called "Adequacy Aid", found as a source of Hanover District revenue in Hanover net assessment.


### Statewide education property tax is used to fund the State obligation to pay for an *adequate* education

## Excluding three "noisy" uncontrollable factors, projected tax rate increase would only be 3.2%, not 6.6%




A \$500K assessed property would see a \$365 total tax increase (\$30.42 per month) 25


Hanover education property tax rates



### **Federal and State Education Funding**

#### Most of Hanover and Dresden relief funds have already been spent or earmarked related to pandemic response

On February 14, after school boards approved local budgets, Governor Sununu introduced draft biennium budget, proposed significant changes to education funding

#### Governor Sununu's education budget *initially* appears favorable to Hanover School District by nearly \$1M


Governor's proposed changes to state adequacy aid will increase funding by \$127M

- Increase base adequacy 21.5% to ~\$4,700 per pupil, this alone would give Hanover +\$905K more in aid
- Increase free & reduced meals piece by \$20M, this would be +\$22K additional to Hanover
- Increase \$20M to special ed differentiated aid, HB 540 unanimously supported in House Ed Committee, at least +\$15K for Hanover and likely higher depending on Special Education enrollment/ADM (legislative ask, not executive)
- Eliminate \$1.7M Grade 3 reading aid, this would reduce -\$4.5K to Hanover aid
- Phase out stabilization/create hold harmless funding, which Hanover does not currently receive
- Tie base adequacy calculation to compounding inflation rate of 2% per year, now rate adjusted once every two years


#### Projected changes to Hanover adequate education funding amount to nearly \$1M if executive and legislative changes implemented

## Additional adequate education revenue, if fully realized, would essentially make net assessment flat in Hanover District





#### Ray School students achieve far above NH state average in English, Math and Science


#### FY22 Ray School Student Achievement
