## Discipline Guide

- This document is not to serve as a step-by-step matrix. Per AB1729, we are required to consider each student and circumstance individually. Being fair does not mean we treat everyone the same.
- In all cases, a reasonable effort must be made to contact parents.
- A violation could lead to suspension or expulsion depending on the frequency or the nature of the act. Even though a violation may be listed in one area in the plan below, it may apply to other areas of discipline. Per EC 49800 (r), a pupil may be suspended or expelled for acts committed to school related activity or attendance at any time, whether school is actually in session or not.
- Student Expectation and Discipline Assemblies: All UUSD schools are required to hold annual student expectations and discipline assemblies. Presentations must contain responses grounded in PBIS, Restorative Practices and SEL Tier I and Tier II strategies in addition to summarizing California Ed Code 48900 violations

<b>Education Code 48900 (a):</b>			
1) <b>Caused, attempted to cause, or threatened to cause physical injury to another person (fighting, mutual combat);</b> 2) <b>Willfully used force or violence upon the person of another, except in self-defense.
