

Memorandum of Understanding (MOU)  
Between Kankakee Valley School Corporation (“The Board”) and Kankakee  
Valley Teachers Association (The Association”)

1. Parties: This Memorandum of Understanding (MOU) is made and entered into by and between the Board of Education of the Kankakee Valley School Corporation (the Board) and the Kankakee Valley Teachers Association (The Association).
2. Purpose: The purpose of the MOU is to revise the Board contribution paid per month toward health insurance.
3. Term of MOU: The MOU is effective upon the date last signed and executed by the duly authorized representatives of the parties to this MOU and shall remain in full force and effort for the term of the teacher collective bargaining agreement which will end June 30, 2023.
4. Responsibilities of the Board: Article V, Insurance, Section 1: Health Insurance. The Board agrees to adjust the monthly board contribution as listed below:

The Board shall provide a health insurance plan for all Teachers who meet the eligibility requirements of the insurance carrier. The Insurance Committee will meet on a timely basis and make recommendations to the KVTA Negotiating Team and the Board with respect to insurance matters. The Board selects the vendor.

The Board agrees to pay the following per month toward health insurance:

Single membership	\$845.00 beginning with March 2023 premiums
Member and Child(ren)	\$1,170.00 beginning with March 2023 premiums
Member and spouse	\$1,509.00 beginning with March 2023 premiums
Member and family	\$1,657.00 beginning with March 2023 premiums


In no event, however, shall the Corporation's contribution exceed the cost of the insurance less \$1.00

Teachers whose spouses also are Corporation full-time teachers are eligible for the following board contribution provided, however, a teacher cannot be covered as both an employee and dependent at the same time.


Single membership	\$873.00 beginning with March 2023 premiums
Member and Child(ren)	\$1,385.00 beginning with March 2023 premiums
Member and spouse	\$1,763.00 beginning with March 2023 premiums
Member and family	\$2,018.00 beginning with March 2023 premiums

March premiums would affect April coverage.



- A. Boys Volleyball as an emerging sport – a stipend of \$2,250 for a limited schedule in 2023.
  - B. Assistant Coach Special Olympics/Unified Track - Index .0407 (Starting 2023)
  - C. Assistant Golf Coach Girls – a stipend of \$1,500.
  - D. Assistant Golf Coach Boys – a stipend of \$1,500


