Listed below is a summarized outline of the reopening plan for the Upper Adams School District as of July 22, 2020. More details will be forthcoming from each building principal. Additionally, we will continue to monitor federal and state guidelines and update our plan for the August school board meeting.

In order to begin the day safely, we are requiring parents/guardians to check their child(ren) for any symptoms of sickness. If parents notice any sickness, we ask that you keep your child(ren) at home.

If your child(ren) rides district transportation, masks will be worn during the ride as we attempt to socially distance students.

Students in Grades K-6 will attend school in-person each day while social distancing within the classroom setting without masks. When students are not able to social distance in the school, masks will be required.

Students in Grades 7-12 will be split into two groups for "A day" (last name A-L) and "B day" (last name M-Z). Splitting the population in half for in-person attendance every other day will provide flexibility to socially distance in our middle and high school. Students will alternate between in-school instruction and remote instruction to cover the district curriculum. Flexible Days will be integrated into our school calendar for teacher planning, monitoring of student progress, and addressing student progress needs. On Flexible Days all students will do remote learning.
