## Introduction

Rotterdam International Secondary School (RISS) is a semi private school. We receive government funding that enables the school to offer prospective families a provision at a lower cost.

Our parental top-up fees are an important part of our school success as they enable us to make an educational offer that is internationally recognised, that has over 35 years of experience, that seeks high standards of teaching and learning and provides strong pastoral support for students, i.e., we offer value for money.

Parental fees enables RISS to offer:

1. Small classes so that we can guarantee personal attention to every student. We strive for classes with an average of 16 students.
2. Internationally hired and highly vetted teachers to deliver our programmes.
3. Covering the costs of internationally recognised qualifications and accreditations.
4. Participation in extra government funding programmes to support the school projects within its semi-private status.
5. Continuous professional learning and development that ensure our practitioners are fully and consistently upskilled.
6. A full equipped library at the Senior Campus and a small one in the Junior Campus.
7. Additional curriculum enrichment programmes.
8. In both campuses a professionally run school canteen.
9. Extra support for students with special educational needs.
10. Extra support staff and management to meet the international standards.
11. Physical Education clothing for all students in G6-9
12. High quality ICT support and hardware across our campuses.
13. All requirements, digital licences and memberships that are required for IB, IGCSE education and the CIS and NEASC licence.
14. School trips of more than one day.
15. A capital fee for a high quality standard of maintenance of our buildings.
16. Learning materials ( such as books, digital books, notebooks, textbooks)
17. A graphics calculator for all Grade 9 students and new students in Grade 10 and 11. The loss of the equipment will have to be replaced at a cost to the family.

**TUITION FEES**

Grades 6-9	:	€ 8650 per year
Grade 10	:	€ 8300 per year
Grade 11	:	€ 10.000 per year
Grade 12	:	€ 9290 per year

The tuition fee includes the capital fee of €500 per child, the cost of the annual school trip for Grades 6, 7, 8, 9 and 11, GDC for Grade 9 and also the contribution of € 20 per child for the PTA, all of which are non-refundable even if a student leaves during the course of the school year.

**NEW STUDENT REGISTRATION FEE € 250.00 (PER STUDENT)**

This is an administration fee for processing the application and placing the student.  
This fee is not charged for students transferring from de Blijberg International Department.

**NEW STUDENT SECURITY DEPOSIT € 500.00**

The deposit is paid on acceptance of a placement at RISS.  
This security deposit secures a student's school place at RISS.  
This security deposit is not refundable should the student not enter RISS.  
This deposit is held by the school whilst the student remains at RISS.  
This security deposit is fully refundable when the student leaves RISS and there is no outstanding money owed to the school and the proof of leaving documentation has been completed (see below).  
If money is owed to the school it will be deducted from this deposit and the balance refunded.  
Text books which have not been returned at the end of academic year or ahead of students leaving school will be charged at € 25.00 per book to cover replacement costs. Students must present their:

IB Diploma / Certificates / IGCSE Certificate; or Uitschrijving (Proof of Leaving) GBA document from their Town Hall; or Proof of registration in another educational establishment.

This is a legal/audit requirement to enable the school to release the security deposit.

**INSTALMENT PAYMENT CHARGE € 60.00 (PER STUDENT)**

This is a charge for payment by instalments. This charge will be applied pro-rata for families joining the school during the school year.

**DISCOUNT € 100.00 (PER STUDENT)**

This is an incentive for full payment of our school fees on or before the due date of the invoice.  
This discount will be applied pro-rata for families joining the school during the school year.

## **ADDITIONAL COSTS INVOICED BY THE SCHOOL**

### EXAMINATION FEES – (GRADES 10 AND 12 ONLY)

All students in IGCSE (Grade 10) and IB (Grade 12) pay examination fees to sit their respective final examinations. This is an additional charge to the School Fees. Examination fees are established annually by the specific examination boards and are invoiced to families. Students who have not had their examination fees paid will not be eligible to take examinations.

The approximate cost of Examination Fees are: -

Grade 10 – IGCSE (10 subjects) -	€ 975.00
Grade 12 – IB Diploma programme	€ 700.00
Grade 12 - IB Career programme	€ 350.00

### FIELD TRIPS / DAY EXCURSIONS

In support of our curriculum, Field Trips may be organized by subject teachers or Team Leaders. Small charges may be invoiced for such trips. However, we shall strive to keep such charges as competitive as possible.

### **Terms of payment Rotterdam International Secondary School (RISS) (Returning families)**

1. The person liable to pay has two options to make the payment of the total outstanding amount:
  - a. **Single payment: (Company Payment of School Fees must be completed by this option)**

This option is also available for family payments of School Fees.

Payment of the total amount is due before the due date of the invoice. With this option you shall receive a **discount of € 100** if payment is received within the due date and you will not be charged the Instalment Payment charge.

*(Total saving: € 160)*

- b. **Instalment payments: (Available only for family payments of School Fees)**

Payment of the total amount is due in five instalments. To compensate for the additional costs, the invoice amount payable shall be increased by € 60 (instalment payment charge).

2. Your choice of payment option must be received by the school on the declaration form by **Friday, 9<sup>th</sup> June, 2023** at the latest. You may use the copy of the declaration form for your own administration.

### **Terms of payment Rotterdam International Secondary School (RISS) (New families)**

1. The person liable to pay has two options to make the payment of the total outstanding amount:
  - a. **Single payment: (Company Payment of School Fees must be completed by this option)**

This option is also available for family payments of School Fees.

Payment of the total amount is due before the due date of the invoice. With this option you shall receive a **discount of € 100** if payment is received within the due date and you will not be charged the Instalment Payment charge. (*Total saving: € 160*)

- b. **Instalment payments: (Available only for family payments of School Fees)**

Payment of the total amount is due in five instalments. To compensate for the additional costs, the invoice amount payable shall be increased by € 60 (instalment payment charge).

2. Your choice of payment option must be received by the school on the declaration form by **Friday 9<sup>th</sup> June, 2023** at the latest.

### **Conditions of payment Rotterdam International Secondary School (RISS)**

1. The Central Administration of the Wolfert van Borselen Schoolgroup has authority for all invoicing and collection of monies for the school fees of the Rotterdam International Secondary School. Payment details and bank account number will be supplied with the invoice.
2. All ‘Declaration Forms’ must be signed by a parent/guardian/company person responsible for payment. Each student must have his/her declaration form signed by his or her parent/guardian. The parent/guardian/company person is responsible for all school fees and agrees to make payments according to the schedules of Single Payment or Instalment Payment.
3. The declaration form is signed for the entire school career of a student at RISS. Parents / guardians are responsible to inform the central administration of the Wolfert van Borselen Schoolgroup as soon as possible if anything changes in the way of payment of the school fees. The fees booklet is determined annually by the central board of the Wolfert van Borselen Schoolgroup, after approval of the Participation Council. It will be published on the RISS website.

Yearly the tuition fees will be increased to compensate for inflation and the increase in wage costs. The tuition fees include a capital fee.

4. Payment of the amounts invoiced by the Central Administration of the Wolfert van Borselen Schoolgroup has to take place without any deductions within a 14 day period or before the stipulated due date according to the instalment schedule.
5. If outstanding payments have not been made despite requests from the Central Administration of the Wolfert van Borselen Schoolgroup to pay the outstanding amount within 14 days, the matter will be handed over to our Debt Collector. All costs incurred with respect to that, both in and out of court (inclusive of the cost of legal assistance), shall be at the expense of the person or company responsible for the school fees payment, and will become liable for payment of the full remaining amount of school fees for the current school year.
6. The Central Administration of the Wolfert van Borselen Schoolgroup will charge the legal interest on the (remainder of the) principal sum due, without any further notice after the 14-day period and for any subsequent reminders, which are sent as a consequence of non-payment.
7. It is in everyone's interest that the RISS school fees are paid in a timely fashion as agreed upon in the declaration form to avoid the matter being transferred to the Central Administration of the Wolfert van Borselen Schoolgroup. Failure to pay school fees will result in legal measures to enforce collection and all costs arising from this will be charged to the parents/guardians. The student will not receive any transcripts, diplomas or certificates until the payment is made in full and another school will have to be found for the student.
8. Disputes arising from outstanding payments and/or issues of debt collection, can be finally settled under the Rules of Arbitration of e-Court, in legal proceedings accordance with the said Rules, whereby a party will be given a one month's notice to opt for the settlement by the Rotterdam District Court. The Rules of Arbitration of e-Court and other information have been published on the website [www.e-court.nl](http://www.e-court.nl)."
