Ms. Bugosh received her bachelor's degree from IUP. Her certificate is in English.



Gold Activity Card

The Gold Activity Card allows a resident to attend free with one guest any home athletic contests (except PIAA playoff games), music concerts, plays, etc. may be used for graduation ceremonies as long as the seats are reserved through the High School Principal's Office. 



School-Family Partnership and Success

Ask parents whether they care about their child's education, and you will nearly always get an emphatic "yes." Ask any community member whether successful public schools are important to the community, and you'll most likely get the same answer.

At Ferndale Area Elementary school we have been able to translate parent and teacher concerns into meaningful involvement that affects student achievement. In the fall of 2002, the elementary school implemented a new program to address the homeschool connection. The home-school connection is facilitated by the Ferndale Area Elementary Family Support Program. Family Support is a preventative measure that involves parents as an integral part of the educational team. Students are referred for Family Support services in the areas of academic, social, behavioral, and emotional areas of student development. Referrals can be made by parents or teachers. The program was developed by elementary school counselor, Eileen Zankey and enforced by building principal, Mr. Ed Moran. Successful implementation of the program can be attributed through the diligence of district teachers and parents.

All students referred for Family Support services must attend a team meeting at the elementary school. A unique quality of the Family Support program is that of the home visit arrangements. Mr. Moran and Mrs. Zankey make personal home visits to those

families whose schedule cannot accommodate the inschool meeting. The goal of the team meeting is the development of an intervention plan to meet the child's needs identified in the referral. An intervention plan is developed, implemented and reviewed within 30 days. All meetings are individualized to the specific needs of the student. Intervention recommendations might include academic tutoring, home-school behavior plan, classroom interventions or increased school-parent contacts. Successful implementation of interventions include a partnership between parents, teachers, tutors and instructional aides. Parents are encouraged to take an active part in the monitoring of the plan.

Over the past two years, Mrs. Zankey and Mr. Moran have tried to send the message to parents that the Family Support Program is preventative not punitive. It is not an uncommon site, to see the building principal and guidance counselor walking down the street of any of our communities. Family support involvement is geared to help the parent become effectively involved in their child's school success.

Special Education Gaskin vs. PA Department of Education

The Gaskin case was first filed on June 30, 2004 by students with disabilities and 11 disability organizations (the plaintiffs). The plaintiffs claim that the Pennsylvania Department of Education and the State Board of Education failed to assure that students with disabilities were being included in regular education classrooms to the maximum extent appropriate, and that students were receiving appropriate supplementary aids and services in regular classrooms. The proposed settlement to this case had a hearing on June 24, 2005 in Courtroom 11A, US Courthouse, 601 Market Street, Philadelphia, PA.

As ordered by the Court, school districts and intermediate units are to take the following actions:

1) Distribute a copy of the Notice to the parents of special education students.

- Post a copy of the Notice in each building where it may be seen by parents.
- 3) Inform parents of how to access copies of the notice and proposed Settlement Agreement on the following website:

Paper copies of the Notice may be obtained by contacting the Special Education Office at Ferndale Area Elementary School—814-535-6724. Ferndale Area School District will continue to work cooperatively with parents of all eligible students to provide a free appropriate education in the least restrictive environment and will comply with the Federal Court's orders.

Yellow Jackets Around the World

Since the late 1980's many teenagers from Western Europe, Scandinavia, and several from the Orient and South America have spent a school year at Ferndale Area High School. These young people have been afforded the opportunity to experience life in a very friendly small school and small town setting. Over the years more than 70 foreign exchange students have participated in the full range of Ferndale Area High School involvements including the academic program, athletics, and other extra-curricular activities such as theatrical productions and music programs.

Those exchange students have lived with families in each of the five sending areas of the FASD – Ferndale, Dale, Brownstown, Middle Taylor, and Lorain. The benefits of the exchange student program have accrued not only to those foreign students in regard to the "once in a lifetime" experience but the FASD community and the host families have benefited as well in terms of learning about other cultures and countries. Perhaps the greatest lesson learned generally has been not how different the cultures and various countries are – but how similar in fact American teenagers and those from around the world truly are.

LOOKING AHEAD

Project 720

Ferndale Area High School has received a \$77,000 Project 720 grant through Pennsylvania Department of Education (PDE). The high school was one of 67 high schools statewide to be awarded the grant. Project 720, named to reflect the number of days a student spends in high school, provides schools with the opportunity to engage in reform initiatives designed to prepare graduates for college and career. Highlights of the Ferndale Area High School grant include:

School Health Council

Beginning with the first day of the 2006-07 school year, each district in Pennsylvania must have established a local school wellness policy. State Assessment Information—Disaggregate Data

The state requires each school district to disaggregate Pennsylvania System of School Assessment (PSSA) test data for several groups of students. The groups include: race, ethnicity, gender, disability status, migrant status, limited English proficiency, and economically disadvantaged.

Adequate Yearly Progress (AYP)

The PSSA ranks student achievement in reading, math, and writing by using the following rating system: below basic, basic, proficient, and advanced. Adequate yearly progress (AYP) is defined as the progress needed to bring all children to the "proficient level" by the year 2014. In order for a district to make AYP, each school within the district (the elementary, middle school, and high school) must be analyzed and any disaggregated group (race, ethnicity, economically disadvantaged, disability status and limited English proficiency) comprised of 40 students or more, must be scored separately. In order to make AYP, the scores must be above the levels stated below:

- At least 54% of the students must score at the proficient or advanced level in reading.
- At least 45% of the students must score at the proficient or advanced level in math.
- At least 95% of the students in each group listed above must have taken the test.
- (As of yet, no baseline scores have been determined for adequate yearly progress in writing.)

As a parent of a student in the Ferndale Area School District, you have the right to know the professional qualifications of the classroom teachers who instruct your child. No Child Left Behind federal law allows you to ask for certain information about your child's classroom teachers, and requires us to give you this information in a timely manner if you ask for it. Specifically, you have the right to ask for the following information about each of your child's classroom teachers.

- Whether the Commonwealth of Pennsylvania has licensed or qualified the teacher for the grades and subjects he or she teaches.
- Whether the Commonwealth of Pennsylvania has decided that the teacher can teach in a classroom without being licensed or qualified under state regulations because of special circumstances.
- The teacher's college major; whether the teacher has any advanced degrees and, if so, the subject of the degrees.
- Whether any instructional aides or similar paraprofessionals provide services to your child and, if they do, their qualifications.

All instructional materials, including teacher's manuals, audiovisuals, or other supplementary instructional material, used in the instructional program shall be available for inspection by the parents or students, in accordance with Board policy. Instructional materials do not include tests or academic assessments. Parents and students (age 18 and over) have a right to access information about the curriculum, including expected student learning outcomes, instructional materials and assessment techniques.

If you would like to receive additional information about any teachers or paraprofessional aides who work with your child, please contact the Superintendent's Office at 814-535-1507.

No student shall be required, without written parental consent for students under eighteen (18) years of age or written consent of emancipated students or those over eighteen (18) years, to submit to a survey, analysis, or evaluation that reveals information concerning:

- Political affiliations or beliefs of student or parents.
- Mental and psychological problems of the student or family.
- Sexual behavior or attitudes.
- Illegal, antisocial, self-incriminating or demeaning behavior.
- Critical appraisals of other individuals with whom respondents have close family relationships.
- Legally recognized privileged or analogous relationships, such as those with lawyers, physicians, and ministers.
- Religious practices, affiliations, or beliefs of the student or parents.
- Income, other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program.

However, such survey, analysis or evaluation may be conducted on a voluntary basis, provided that the student and parent have been notified of their right to inspect all related materials and to opt the student out of participation.

Parents have the right to inspect the material and opt out the student from participating in any activity that results in the collection, disclosure or use of personal information for purposes of marketing or selling that information. This does not apply to the collection, disclosure or use of personal information collected from students for the exclusive purpose of developing, evaluating, or providing educational products or services for or to students.

Each year, more than 800,000 school-age children in the United States experience homelessness. The federal No Child Left Behind Act of 2001 includes a provision to make sure that homelessness does not cause these children to be left behind in school. Homeless children should have access to the education and other services that they need to meet the same challenging state academic achievement standards to which all students are held. The Ferndale Area School District is required to provide activities for, and services to, homeless children, including preschool-age homeless children and youths, enabling them to enroll in, attend, and succeed in school or preschool programs. The law states that, pending resolution of a dispute about school placement, a school district must immediately enroll a homeless student in the student's school of origin or other school selected on the basis of the child's best interest and provide a written explanation of the rights of appeal to the parent or guardian of the student

In compliance with local, state, and federal laws, to protect students, staff, and others from the safety hazards of tobacco, the Board prohibits possession or use of tobacco in any form by students, staff or others (community):

- 1. in buildings owned by, leased by or under the control of the School District;
- 2. on property owned by, leased by or under the control of the School District;

- 4. at any school-sponsored or school-sanctioned events (day or night);
- 5. when a student represents the school (i.e. work study program, seminars, school visits, field trips, or any similar event).



During the summer vacation, five middle/high school teachers attended the TEAMS (Teaming Educators for Applied Math and Science learning) program at St. Francis University. This is Ferndale Area's second year of participation.

Ron Wilson, Amanda Williamson, Lesley Miller, Kim Reighard, and Amy Kopriva are working together with Dr. Rose Clark, Matt Harbart, and Kristy Woefel in presenting science concepts across the curriculum. This year, the team focused on developing a **seventh grade forensic science unit** as well as illustrating the
