### **OPENING**

The Board of Trustees of Hellgate Elementary School District #4 met in special session on Friday, April 22, 2022 at 12:00 p.m. The meeting was held in-person and also broadcast by virtual video conferencing. The motion was seconded by Jack Babon. Voting in favor of the motion were Tom McLaughlin, Rod Sharkey, Kate Walker, and Jack Babon. Voting against the motion were none. The motion passed.
