Happy belated New Year! We hope you had a wonderful winter break. It was nice to have some time off to refresh and recharge and we are back ready to tackle the rest of the school year.

Our original plan was to show a video of our students playing the recorders, but several of you had the opportunity to see a live performance from my 5th graders -- they were so excited to

play in front of an audience so thank you for coming by and listening to them. Several Taylor Mountain teachers also commented how nice it was to have board members and admin on campus so thank you for coming by!

This year has flown by and we are at the halfway mark. It's a few months away, but as upper grade teachers, we are already getting into test prep mode. We will soon be administering the ELPAC followed by the SBAC at the end of the year.

That's all we have for tonight so we look forward to seeing you next month.

11.3. Principal Reports

Nina Craig, Bellevue Principal, reported:

Good Evening Members of the Board and Superintendent Kellison

We hope you had a wonderful holiday and wish you a Happy New Year. We have all jumped into this New Year ready to continue the good work of the district.

Registration for the 2023/24 school year has opened. Our offices are welcoming new families and supporting them in registering their students. We understand for many families this is their first child in the school system and the process is totally new to them, so our office staff's are as helpful and supportive as possible. We are preparing to begin hosting our first tours later this month.

This past week all grade levels came together to continue their Professional Development as it pertains to our new Writing Program, Writing by Design under the guidance of Aracely Romo-Flores. Teams became more familiar with the Rubrics and potential ways to use them as an instructional tool with their students. They also spent time reading eachothers student writing samples and identified anchor papers to use as examples or models of student writing aligned to the scoring rubrics. Us principals were able to join some of the teams in this work and enjoyed spending time discussing student writing with our teachers!

CPI Training: Certificated and classified staff representatives from all sites are participating in Crisis Prevention Institute training at the end of this month. This CPI training is being hosted by our own BUSD trainers. The training provides de-escalation strategies and behavior interventions that puts student need first. Throughout the spring our staff, led by Tracy Whitaker, Susie Hirsch, and myself, will continue to train members of the special education teams...we have the goal to get all of our sped staff trained by the start of our next school year.

Our district is in the process of taking the Youth Truth Survey. If you have a child in the district you've probably received emails and text messages to take this survey. 3-6th grade students, all staff, and all parents are asked to take this survey. The window closes Jan 27 and we are continuing to remind and nudge these groups to take the survey. We look forward to the results as we take the feedback seriously as we strive for continuous improvement.

Boys Basketball is underway. We are so appreciative of our coaches at each site stepping up to make this happen. Stay tuned for upcoming evening events from all sites.

John Jarvis said today was phenomenal, much better than usual with the facilities walking tour earlier today and then the performances tonight. Becky Hansen's students nailed it with their recorders today. The chorus and piano performances made us proud of the district. The board will be doing school tours at all sites.

Adele Walker said they had a great time today especially seeing students here and Margaret and her team on the facility tour. It was a pleasure to hear Ms. Hansen's students play their recorders and to see and hear our chorus and piano students this evening.

Jamie Padilla said today was a nice reminder why we sit in these seats. That the work we do here is for our students. Thank you for bringing this to us. Such a good reminder.

11.5. Superintendent Report

11.5.1. Enrollment Update

Superintendent Kellison reported:

A new year brings new opportunities. Although 2023 started off a bit wet and stormy, there are nothing but blue skies ahead for the Bellevue Union School District.

State of the District

Enrollment for the 2023-24 school year began January 9th. During Winter Break, we sent home postcards notifying all residents living in the Bellevue Union School District boundaries that enrollment for the upcoming school year was set to begin in early January. So far, we are generating a good amount of foot traffic and phone calls as we begin the process of enrolling students in our schools for the upcoming school year. It is our plan to hold a district-wide enrollment event in early February. We intend to partner with some of our local community organizations to make the event one in which families can enroll their children while also learning more about available resources within our community. More information to come as we firm up plans for this event.

To date, I have met with two of the four parent groups from our campuses to gather their feedback on our "Planning for Our Future: Bellevue 2025 and Beyond" initiative. As you recall, our first session was with BUSD staff in December. During that meeting, I asked staff to envision their ideal school district. I have engaged our parent community with the same prompts focusing on: Programs for Students, Facilities Needs, and Community Partnerships. Within each of these categories, our parents will provide us with valuable feedback as we look to develop a comprehensive plan for our future. I am excited to continue this process with the two remaining campuses and am planning on engaging our staff and students in a similar manner with on-site visits.

Today, we completed the first of our special board meeting site visits. The Board and I had the opportunity to visit Taylor Mountain school. Principal Jacobson led us on a tour of her beautiful

campus where we had the chance to look into some classrooms and watch student learning occur. We saw the tail end of a science lesson on mushrooms, a kindergarten read aloud and were treated to a couple of songs from fifth grade students on the recorder. Additionally, we walked the campus looking at potential areas of improvement. We will hold one site visit per month with the goal of collecting information that will serve as the basis for future decisions by the Board and Superintendent as it relates to budget priorities and program additions/modifications.

In closing, there is so much that we hope to accomplish in the next five months. We will be working hard to develop long-term plans and to implement actions in support of our students. While I am certain that we will encounter both success and challenge, I am confident that our BUSD team is primed and ready to support our students' growth and development.
