SUPERINTENDENT'S REPORT

- The PDE Safe Schools Targeted Grant was not awarded to our district.
- Application for the 2-part PCCD grant, due October 12th, was submitted today.
 - Part A - \$25,000; will know by the end of October if we received this grant.
 - Part B – competitive; will know by late November if we received this grant.
- ALICE training for faculty and staff was held today.
 - Leo Sokoloski, retired Bloomsburg police chief, spoke.
 - Seven Hemlock Township police officers participated, provided input, and made suggestions. The officers were very complementary with the training; especially participation. The officers felt confident about the security measures already in place.
 - The training was well-received with faculty and staff providing positive feed-back.
