Dr. Bowling advised that this is the last step of the budget process for the 2023 budget. Previous meetings consisted of a public hearing to discuss the 2023 budget. Once approved, it will be sent to the Department of Government and Local Finance. Dr. Bowling recommended the Board approve the resolution.

Susan Albrecht made a motion to approve the Resolution. Kathleen Brown seconded the motion. The motion passed unanimously.

b. Consider Transfer from the Rainy Day Fund to the Operations Fund

Dr. Bowling advised the Board since the last meeting a transfer has been done from the Education Fund to the Rainy Day Fund. We take this extra step to make sure we are compliant with the new law. The Operations Fund gets hit hard with property tax caps and has to be supplemented by other school funds. The resolution will allow the transfer of up to \$2,000,000.00 to fund maintenance, repairs, transportation, fuel, and everything that is part of the operational role within the school. He, therefore, recommended the approval of the resolution.

Kent Minnette made a motion to approve the transfer. Ellen Ball seconded the motion. The motion passed unanimously.

c. Consider a Resolution to Establish Recurring Transfers from the Education Fund to the Operations Fund

Dr. Bowling advised funds are required to be approved by the Board per the State Board of Accounts. This requires the School Board to pass a resolution each year giving the approval to do said transfers on a monthly basis not to exceed \$500,000.00. The current monthly transfer is \$200,000.00. Dr. Bowling recommended the Board approve the resolution.

Kathleen Brown made a motion to approve the Resolution to Establish Recurring Transfers from the Education Fund to the Operations Fund. Ellen Ball seconded the motion. The motion passed unanimously.

d. Consider Amendment Four to Service Agreement Between CCSC and SSC

Dr. Ryker advised this fourth amendment to our contract with SSC that includes adding two full-time custodians, due to two CCSC employee retirements, and increases the starting custodial pay to \$13.50. Dr. Ryker recommended the Board approve this amendment.

Kathleen Brown made a motion to approve Amendment Four to Service Agreement Between CCSC and SSC. Kent Minnette seconded the motion. The motion passed unanimously.

e. Consider North Mechanical Bid for ESSER-funded Willson PreSchool HVAC System Replacement Project

Dr. Ryker advised we only received one bid that met the requirements for the bid opening for the ESSER-funded Willson HVAC replacement project. Due to the window wall structure, low ceilings, and limited space at Willson, all equipment will be placed on the roof. All equipment and piping will be replaced in the building. The base bid plus two alternates equal \$715,714.00 and will be paid for with ESSER Funds. ESSER Funds are from the Elementary and Secondary School Emergency Relief Fund which was established as part of the Education Stabilization Fund in the CARES Act to address the impact of COVID-19 had and continues to have on elementary and secondary schools across the Nation. Air quality is an identified area to address.

Dr. Ryker recommended the Board approve the North Mechanical Bid in the amount of \$715,714.00 paid for with ESSER Funds.

Susan Albrecht made a motion to approve the North Mechanical Bid for ESSER-funded Willson PreSchool HVAC System Replacement Project. Ellen Ball seconded the motion. The motion passed unanimously.
