10. Presentation and Discussion of Draft SBCEO Board Trustee Area Maps

Justin Rich, Executive Director of Cooperative Strategies shared a presentation of the 2020 Census and Redistricting options for the Santa Barbara County Education Office trustee areas. Two map scenarios were provided for the County Committee's review. The highlights of the census and maps include:

- With the 2020 Census, there is a 12% variance between the smallest and largest Areas which pushes these areas beyond the allowable 10% or less variance
- Areas 1 and 6 are the least populated and cover the Santa Barbara and Carpinteria portions of SBCEO trustee areas
- Areas 2 and 5 are the most populated. Area 2 is in the Santa Barbara/Goleta area and Area 5 is in Orcutt in the north county
- Both scenarios show two trustees in Area 6 because Area 1 is pushed westward into Santa Barbara to gather more population
- Scenario 1 brings the variance to 1.5% and Scenario 2 brings the variance to 0.9%

During the meeting, Mr. Rich showed the areas that were adjusted to bring the boundaries into alignment with the 10% or less variance requirement. The scenarios were presented to the County Committee for consideration and/or future adjustments. He also provided interactive maps showing the current boundaries and adjustments in the two scenarios for members to review before the next meeting.
