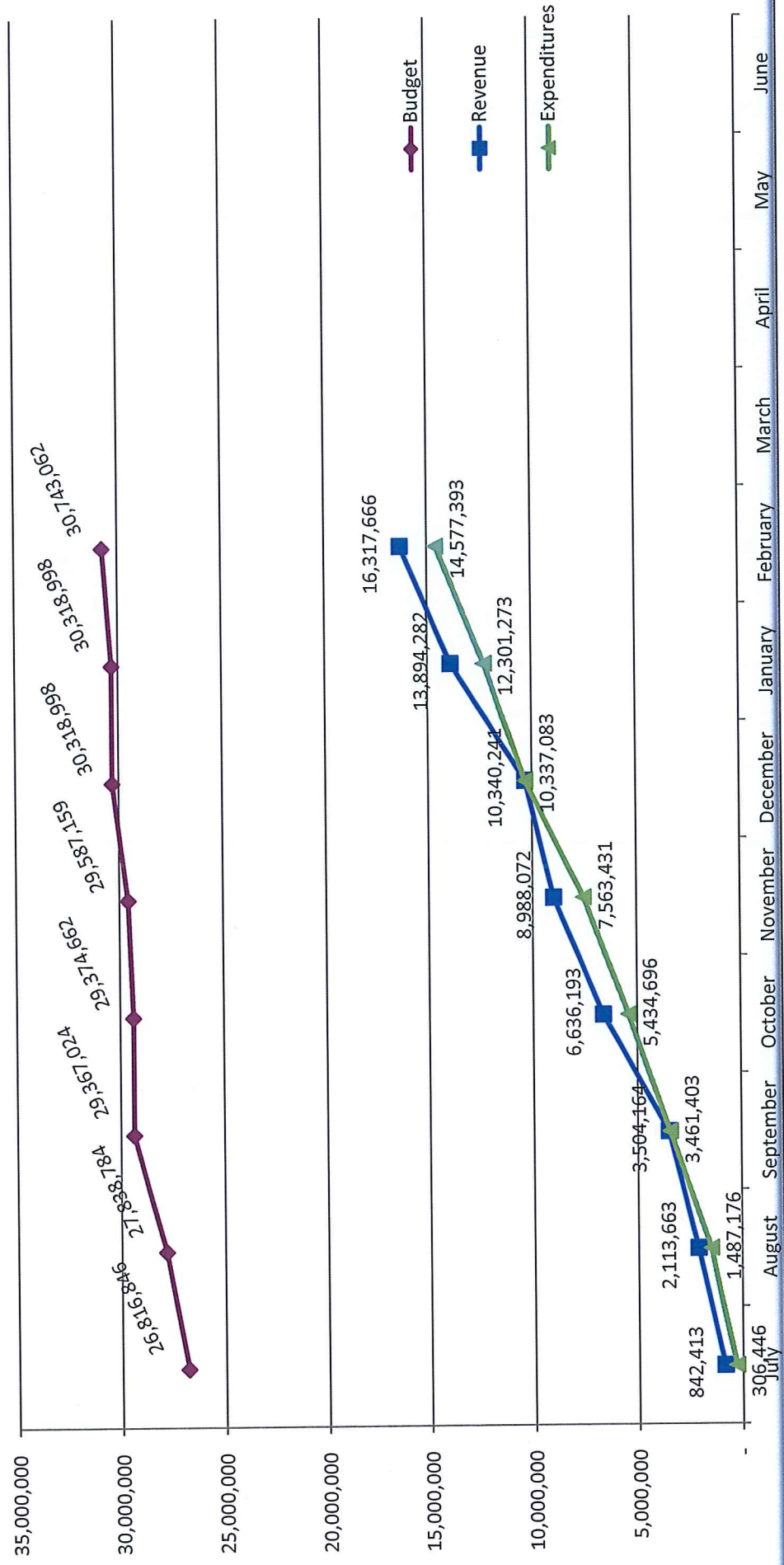

Chair Helsel called the work session of the Poquoson City School Board to order at 8:01 p.m.

- I. Budget Presentation:** The Superintendent's proposed budget was distributed and discussed. The personnel needs at PPS were also discussed. A position was included for Special Education Coordinator and Behavioral Specialist to assist with special education and behavioral needs.
- II. Board Leadership:** The Board discussed selecting a Vice Chair. The decision was made to think it over and discuss it at the March meeting.
- III. School Safety:** Weapons Detection System was discussed. Carryover money funded ballistic shields for schools. Digital Mapping – "Collaborative Response Graphics" CRG was spoken about. – Digitally mapping school and creating overlays. This information will go to the police, dispatch, etc. This will allow first responders to locate areas quickly and can be used to navigate.
- IV. Anticipated Enrollment Increases:** An analysis of enrollment projections (2022-2027) was conducted by Weldon-Cooper of UVA. PCPS should expect an additional 125-185 students once construction has finished. Typically, 34 new homes in Poquoson yields 15 additional K-12 students. Mr. Tillett presented facilities options for growth. Next year should be okay. PPS could move resource classes out into trailers (band aid solution). Eventually add onto PES.
- V. Service Animals:** The need for a Service Animal Policy in PCPS was discussed. There is currently a request to bring a service animal next year. The Board reviewed ADA requirements and a sample policy. Clarification was requested if the policy can be limited to dogs due to space limitations and if schools are able to request hypoallergenic

dogs. The Board discussed the ability for parents of other students with severe allergies to opt out or request different placement.

There being no further areas to be discussed by the Board, Chair Helsel adjourned the work session at 9:27 p.m.

Subject: Motion to waive the second reading of the Service Animal Policy 7-5.16 and approve it during the first read based upon (1) discussions held regarding the policy during the Work Session held on February 21, 2023, (2) the legal requirement for an established policy, and (3) a pending request for a service animal to accompany a student.

Background

Service animals, as defined by the Americans with Disabilities Act (ADA), are trained to assist children and adults with disabilities with daily living activities. Persons with disabilities have the same right as persons without disabilities to the use and enjoyment of our schools. We strive to make reasonable accommodations for a person with a disability to use a service animal on school property. However, to ensure the health and safety of everyone in our school, a service animal, like any personal property, cannot be brought onto school property on a continual basis without prior approval as further outlined by a School Board Policy. Currently, Poquoson City Public Schools (PCPS) does not have a policy that addresses service animals.

Discussion

PCPS has recently received an inquiry regarding our Service Animal Policy. In order to obtain a service animal and complete the required, and intensive training, animal training centers and organizations require a copy of the Service Animal Policy from the school division in which the child attends school. At this time, no such policy has been approved and included within our School Board Policy Manual. The formal request for a policy has been made.

The Americans with Disabilities Act (ADA) requires public entities to “modify its policies, practices, or procedures to permit the use of a service animal by an individual with a disability” (§ 35.136(a).) There is a clear legal delineation between a pet and a service animal. A service animal is properly qualified to be a service animal if it is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability. In addition, the work or tasks performed by a service animal must be directly related to the individual’s disability. While public entities may prohibit/exclude pets, service animals that have obtained prior permission to be in the school, may not be prohibited.

Requirements of the Service Animal

- Service animal must be trained to do work or perform tasks for the benefit of the individual with a disability
 - Work/Tasks performed must be directly related to the individual’s disability
- Service animal must be housebroken, and under the control of the handler. The following conditions apply to the animal.

- Must be clean, well-groomed, and/or have no offensive odor
- Must not urinate or defecate in inappropriate locations
- Must not solicit attention, visit, or annoy any member of the student body or school personnel
- Must not vocalize unnecessarily (e.g.: barking, growling, and/or whining)
- Must not show aggression towards people or other animals
- Must not solicit or steal food or other items from the student body or school personnel
- Any handler, other than the student with a disability, will be subject to the same approval and background check policies as School Division volunteers.
- Current health certificates that evidence the animal is currently in good health, free from parasites, and that vaccinations are up-to-date

A draft policy is included for your review. The policy has been vetted by our School Board Attorney and includes key components, to include legal standards, requirements of service animals, requirements for training and handling while in school, procedures for obtaining prior approval, reasons and rationale for exclusion, process for appeal, care and supervision, charges, and exceptions. This list is not exhaustive.

Recommendation(s):

POLICY 7-5.16 SERVICE ANIMALS

1. Philosophy

- 1.1. Service animals, as defined by the Americans with Disabilities Act (ADA), are trained to assist children and adults with disabilities with daily living activities. Persons with disabilities have the same right as persons without disabilities to the use and enjoyment of our schools. We strive to make reasonable accommodations for a person with a disability to use a service animal on school property. However, to ensure the health and safety of everyone in our school, a service animal, like any personal property, cannot be brought onto school property on a continual basis without prior approval as further outlined in this Policy.

2. Legal Standards

- 2.1. This policy applies the legal standards as set forth in the following:
 - 2.1.1. Code of Virginia § 51.5-44,
 - 2.1.2. Individuals with Disabilities Education Act,
 - 2.1.3. The Rehabilitation Act of 1973, as amended ,
 - 2.1.4. Americans with Disabilities Act, and
 - 2.1.5. Virginians with Disabilities Act.

3. No Pets in School

- 3.1. We are dedicated to protecting the health and well-being of our community. Some students are highly allergic to certain animals. Animals can also spread disease, or behave in dangerous or unpredictable ways that can cause injury to persons with whom they come into contact. For these reasons, pets are not allowed in school. Please help us maintain a safe environment for all students by respecting this policy.
- 3.2. Service animals are not pets. Provided that prior permission to have the service animal in school is obtained and maintained, the “no pets in school” prohibition does not apply.

4. Requirements of the Service Animal

- 4.1. A service animal is properly qualified to be a service animal if it is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability. In addition:
 - 4.1.1. The work or tasks performed by a service animal must be directly related to the individual’s disability.
 - 4.1.1.1. The crime deterrent effects of an animal’s presence and the provision of emotional support, well-being, comfort or companionship do not constitute work or tasks for the purposes of this policy.

- 4.2. The animal must at all times be housebroken and under the control of the handler. The following factors may determine that the animal is not housebroken or under control if the service animal:
 - 4.2.1. Is unclean, not well-groomed, and/or has an offensive odor;
 - 4.2.2. Urinates or defecates in inappropriate locations;
 - 4.2.3. Solicits attention, visits or annoys any member of the student body or school personnel;
 - 4.2.4. Vocalizes unnecessarily, i.e., barking, growling or whining;
 - 4.2.5. Shows aggression towards people or other animals; and
 - 4.2.6. Solicits or steals food or other items from the student body or school personnel.
- 4.3. To ensure compliance with the law and the safety of students, a handler if different than the individual with the disability, though not a School Division volunteer, will be subject to the same approval and background check policies as volunteers.
- 4.4. Current health certificate that evidences the animal is currently in good health, free from parasites, and that all vaccinations are up-to-date.

5. Service Animal in Training

- 5.1. A person who is training a service animal may be accompanied by a service animal while on school property for the purposes of school business. The service animal must be at least six (6) months of age and:
 - 5.1.1. In harness, provided the person is an experienced trainer of guide animals or is conducting training of a guide animal;
 - 5.1.2. In a harness, backpack or vest that identifies the animal as a trained service animal, provided such person is an experienced trainer of service animals or is conducting continuing training of a service animal;
 - 5.1.3. Wearing a jacket identifying the recognized guide, hearing or service animal organization, provided such person is an experienced trainer of the organization identified on the jacket; or
 - 5.1.4. The person is part of a three-unit service animal team and is conducting continuing training of a service animal.

6. Procedure for Obtaining Prior Approval

- 6.1 To ensure the health and safety of everyone in our school, we have established procedures for evaluating requests to bring service animals on school property on a case-by-case basis.
 - 6.1.1. Complete the Service Animal Access Request Form to include:
 - 6.1.2. Identification of the type of service animal;
 - 6.1.3. Identification of the work or task(s) the animal has been trained to perform for the student with a disability;
 - 6.1.4. A plan to meet the basic needs of the service animal;
 - 6.1.5. Verification that the handler, if someone different than the individual with a disability, is qualified according to PCPS volunteer school policies to be on school property though not a School Division

volunteer; and

- 6.1.6. Current health certificate that evidences the animal is currently in good health, free from parasites, and that all vaccinations are up-to-date.
- 6.2. Submit to the school's principal the completed Service Animal Access Request Form and any necessary attachments.
- 6.3. Submit necessary information to Human Resources confirming that the handler meets the criteria for PCPS volunteers, though the handler is not a PCPS volunteer.
- 6.4. Within five (5) school days you will be notified in writing of a decision or given reason why the decision will require more time and the predicted date when a decision will be made.

7. Exclusion of a Service Animal

- 7.1. Permission for the service animal to be in school may be revoked in the following circumstances:
 - 7.1.1. The animal is out of control and the animal's handler does not take effective action to control it;
 - 7.1.2. The animal is not housebroken;
 - 7.1.3. The presence of the animal poses a direct threat to the health or safety of others; or
 - 7.1.4. The presence of an animal would require a fundamental alteration to the service, program, or activity of the school division.
- 7.2. The individual with a disability must still be given the opportunity to participate in the service, program, or activity without having the service animal on the premises.

8. Appealing a Denial of a Request for the Service Animal

- 8.1. An appeal to the administrator's determination regarding the qualification of the handler/student or the animal may be appealed to the Assistant Superintendent for Instruction and Support Services.

9. When Prior Approval Has Not Been Obtained

- 9.1. If a child arrives at school with an animal, and prior approval has not been obtained, the parent/guardian will be immediately notified and requested to retrieve the animal until it can be determined that the presence of the animal in school is in compliance with the law and School Board policy.
 - 9.1.1. The animal will remain with the child until the parent/guardian removes the animal from school property.
 - 9.1.2. The animal will not be taken away from the child by school personnel.
 - 9.1.2.1. However, if the principal or his/her designee believes the service animal may be dangerous or sick, he/she may contact animal control.

10. Updates Required

- 10.1. A service animal that has been given prior approval to be in the school as a service animal must have a current approval on file in the school.

11. Care Or Supervision of the Service Animal

- 11.1. Poquoson City Public Schools is not responsible for the care or supervision of a service animal.
- 11.2. In the event that the service animal damages property or otherwise behaves in a manner resulting in cleaning, repair or replacement costs, the owner is solely responsible for the entirety of such cost.
- 11.3. Any costs associated with the use and care of the service animal are the responsibility of the owner.

12. Exceptions

- 12.1. This policy does not apply to Poquoson City Public Schools-initiated programs involving animals that are not trained service animals.

13. Extra Charges

- 13.1. The owner or handler of a service animal cannot be required to pay an admission fee or charge for the animal to attend events for which a fee is charged.
