SUPERINTENDENT'S REPORT

18. The superintendent reported on the following topics:

- General – The superintendent thanked the board members for their comments at the start of the meeting, which were focused on supports for families, students and the community, especially for the staff in terms of

the Thoreau Community School charter school petition and the SBCEO Education Celebration.

- Countywide graduations – Dr. Salcido congratulated all students within the county graduating from school at this time of year.
- June 15 California “opening” – The superintendent stated that schools anticipated guidance from the California Department of Public Health (CDPH) on June 15, including on physical distancing and face coverings.
- Cal/OSHA and CDPH alignment – Dr. Salcido shared that California’s Occupational Safety and Health Administration department (Cal/OSHA) had a board meeting today with public comment regarding new draft Emergency Temporary Standards. Cal/OSHA’s standards contrast with CDPH guidance. Dr. Salcido asked Assistant Superintendent of Human Resources Mari Baptista to report on the meeting. Ms. Baptista reported that the meeting was still going on. She shared five key areas that the draft standards included:
 - Unfunded mandates for all employers to install partitions, provide N95 masks to all unvaccinated employees and install HEPA filtration
 - Unvaccinated employees must wear N95 masks
 - All indoor workers must remain 6 feet apart unless wearing N95 masks
 - The draft standards were focused on the date of July 31, not June 15 – the California “opening”
 - Do not need to quarantine individuals who are vaccinated and had close contact with a positive COVID-19 case but are asymptomatic

Ms. Baptista briefly mentioned some concerns of employers. She reported that the Equal Employment Opportunity Commission said employers could mandate vaccination. She shared that there was some advocacy occurring to exempt school districts from the standards.

- Highlights of the state budget proposal – The superintendent mentioned the following highlights of the state budget proposal:
 - In the area of early education and child care, expanding transitional kindergarten (TK) for all 4-year-olds over a period of time. In five years, ensure that all 4-year-olds would be able to enroll in TK.
 - An increase to ongoing CTE funding
 - An increase for student mental health

The superintendent also shared that more definition was expected around what it would mean to have or not have distance learning or independent studies.

- Upcoming board meetings – Dr. Salcido mentioned the board meeting next week at 10 a.m. via Zoom. She reminded the board that the July 1 board meeting would likely be held in person. She stated that the August 5 board meeting would be held around 4 p.m. in order to accommodate a public hearing on instructional materials and textbook sufficiency that must be held at a later time.

Dr. Salcido shared that there were various educational organizations that were advocating in one voice to the state legislature about distance learning/independent study. She shared that this legislation, which was tied to the state budget, and which was undergoing further changes, should be enacted in the coming days.






