SUPERINTENDENT'S REPORT

14. The superintendent will give a brief report.

The superintendent thanked the board, as well as the Personnel Commission, for supporting the education community. She also thanked Board Member Howell for continuing to write letters to the high school graduates of SBCEO's Juvenile Court and Community Schools programs.

The superintendent updated the board on the following items:

• Week 8 of school campus closures

There has been incredible work happening by teachers, staff and parents.

- State support
 - \circ Waivers
 - UC/CSU flexibility
 - \circ LCAP

State support has been important and appreciated.

The state has postponed the approval of the LCAP. It no longer needs to be approved at a June board meeting, therefore, our second, special board meeting in June is no longer needed.

There will be a 1-year LCAP due in December, so there is a potential for a second board meeting in December. More information to come.

Districts will need to complete a new Operations Report in June, instead of completing their LCAP, to go with their budget.

• Districts

• Food continuity

Thirteen districts are to be commended for making around 19,000 distributions a day. Districts are collaborating with the Foodbank and many other entities.

o Distance/Remote learning, devices, connectivity

The need for devices has largely been met, but connectivity needs still exist.

o "Closing down" this school year

When schools closed in mid-March there were student items left in classrooms. There will be yearbooks that need to be distributed. Districts will check with Public Health about these and other issues.

• Recognitions/Graduations

Districts will check with Public Health about recognitions/ graduations.

- Loosening Stay-at-Home order
 - o REACH/SB County

SBCEO is working with Santa Barbara County and REACH on plans/guidelines for loosening up the Stay-at-Home order in the county.

- Re-entry for schools
 - Financial backdrop
 - Instructional minutes
 - Labor agreements
 - Communication

Schools will likely need social distancing when they re-open. Districts are considering how school could be staggered. There is a significant financial backdrop to any creative options to schools re-opening. There needs to be flexibility on instructional minutes if there is to be a blended learning environment. There will need to be significant negotiations with labor. Communication is really important to manage expectations for how schools will look and feel when Public Health determines that it is safe to re-open schools.e

• SBCEO

SBCEO staff are doing incredible things. JCCS pivoted to distance learning. Special Education also pivoted to distance learning for the 3 districts they support directly. Curriculum & Instruction (C&I) is supporting educators with distance learning. C&I's credential programs had their accreditation approved again for another 7 years. School Business Advisory Services and Fiscal Services have been moving forward with their work, including successfully processing payroll. Information Technology Services has done an incredible job. Educational Services helped with childcare centers for essential workers and has changed the I Madonnari festival to be a virtual festival this year. Human Resources (HR) has worked with bargaining units. HR's template language was used statewide. HR is also conducting the superintendent search for Vista del Mar Union School District. Communications launched a new SBCEO website. The North County Liaison Office continues with its operations, as does the Hope Center and Cathedral Oaks site locations.

Dr. Salcido stated that she would likely share about teacher recognition items that had been happening at the next board meeting.

Lastly, the superintendent wished everyone a happy Mother's Day.
