**STUDENT DRUG TESTING AGREEMENT**

GREAT LAKES BIOMEDICAL, referred to as GLB, and WADSWORTH CITY SCHOOL DISTRICT, referred to as EMPLOYER, agree:

GLB shall provide drug testing services regarding the students of EMPLOYER beginning August 1, 2017 and ending on July 31, 2018 unless earlier terminated as is provided for herein. These services shall generally include:

- a) Testing as required of eligible pool members at the beginning of a testing season.
- b) Random testing as required of eligible pool members.
- c) Providing a list of names for random testing as requested by the district representative.
- d) Provide personnel required for all testing sessions.
- e) Positive tests will be confirmed by a SAMHSA certified lab and verified by the certified medical review officer.

EMPLOYER agrees that it shall reasonably cooperate with GLB in the provision of information required by GLB.

GLB shall travel to the Employer’s site up to weekly if needed during the term of this agreement. The dates for these trips shall be agreed upon by the parties. During such trips EMPLOYER shall make key personnel available to the GLB.

GLB shall be available for telephone review of any matters related to this agreement at reasonable times.

Either party may terminate this agreement on 30 days notice for a material breach of the contract, or, 30 days notice without cause.

The parties may from time to time exchange confidential business information such as plans for future events. As to such information neither party shall disclose the same, unless the information becomes part of the public domain without the fault of either party, or was known to both parties prior to the execution of this agreement.

This is the entire agreement between the parties and may not be altered except in writing. This agreement guarantees pricing for the 2017-2018 school year. Billing is on a per test basis and there are no minimum yearly testing requirements.
