MINUTES
SPECIAL SCHOOL BOARD MEETING
MONDAY, MARCH 7, 2016

The meeting was called to order by President Delmore at 6:00 p.m. Members present were Kathy Anderson, John Campbell, Lisa Delmore, Jennifer Gavinski and Robert McClyman. Randy Gilner and Holly Waterman were absent.

Motion by John Campbell and second by Kathy Anderson to approve the agenda. Motion carried.

President Delmore announced that the School Board may go into Closed Session pursuant to Section 120.13(1) Subparagraph (c), Section 19.85(1) Subparagraphs (a) and (f), and 118.125 of Wisconsin Statutes, and Family Educational Rights and Privacy Act 20 of U.S.C. Section 1232 (g).

Motion by John Campbell and second by Robert McClyman to adjourn to Closed Session per Wisconsin Statutes under Sections 120.13(1) (c); 19.85(1) (a) and (f); 118.125 for the purpose of conducting a hearing on recommended student expulsions that may involve discussions of confidential student records, and to discuss other matters involving student records and personal histories that, if discussed in public, would likely have a substantial adverse effect on the reputations of the person(s) discussed; and Family Educational Rights and Privacy Act 20 U.S.C. Section 1232 (g). A roll call vote was taken. (5 yes votes: Kathy Anderson, John Campbell, Lisa Delmore, Jennifer Gavinski and Robert McClyman. Randy Gilner and Holly Waterman were absent.) Motion carried.

The purpose of the Closed Session was for student expulsion hearings.

Motion by John Campbell and second by Robert McClyman to expel the student, as recommended by Administration. A roll call vote was taken. (5 yes votes: Kathy Anderson, John Campbell, Lisa Delmore, Jennifer Gavinski and Robert McClyman. Randy Gilner and Holly Waterman were absent.) Motion carried.

Motion by John Campbell and second by Jennifer Gavinski to expel the student, as recommended by Administration, with additional tutoring services as detailed by the Board. A roll call vote was taken. (5 yes votes: Kathy Anderson, John Campbell, Lisa Delmore, Jennifer Gavinski and Robert McClyman. Randy Gilner and Holly Waterman were absent.) Motion carried.

Motion by Kathy Anderson and second by Robert McClyman to reconvene into Open Session. Motion carried.

Motion by John Campbell and second by Jennifer Gavinski to adjourn. Motion carried.

President Delmore adjourned the meeting at 7:47 p.m.
