School Vision and Mission

Leffingwell Continuation High School's Vision and Mission Statements

Based on the Dashboard Alternative School Status Program, all students at Leffingwell High School will become prepared for 21st century college and career opportunities, supported by all stakeholders to achieve high school graduation success.

School Profile

Leffingwell High School is one of four schools in the Coast Unified School District. Curriculum is focused on real-life learning skills and preparation for post-secondary education and employment in the community. Enrollment at Leffingwell during the 2022-23 school year is currently at eleven students.

Surveys

Leffingwell High School greatly benefits from its supportive parents who are in regular contact with the school. Student and parents participate in regular conferences. Every six weeks, 1/2 of the students have a parent teacher conference, with all parents, teachers and students having a conference during a 3 month period. During parent-teacher conferences, stakeholder input is gathered. Additionally the parents and student provide regular feedback informally via email, phone calls or in-person conversations. Parent input is also gathered during school-site council meetings.

Classroom Observations

This section provides a description of types and frequency of classroom observations conducted during the school-year and a summary of findings.

Classroom observations are regularly occurring throughout the year at Leffingwell. These observations are both formal/scheduled observations as well as informal "drop ins". All teachers participate in goal-setting meetings with the principal at the start of the school year and observations are focused on progress toward meeting these individual teacher goals, as well as progress toward school and district goals. The high school counselor regularly monitors student progress and keeps the students informed about the college registration process, credits accumulated and community service opportunities. Parents attend conferences every three months.

Assessments used to modify instruction and improve student achievement include statewide assessments (ELPAC, CAASPP), the NWEA school-wide assessment and teacher-created formative and summative assessments.

Students at Leffingwell High School are on an Individualized Credit Assessment Program and meet each grading period to monitor progress towards graduation.

Staffing and Professional Development

3. Status of meeting requirements for highly qualified staff (ESEA)

All teachers are highly qualified and are credentialed in their areas of instruction.

4. Sufficiency of credentialed teachers and teacher professional development (e.g., access to instructional materials training on SBE-adopted instructional materials) (EPC)

Leffingwell High School has sufficient access to instructional materials. Both hardcopy and digital materials are utilized. Early release Wednesdays are used as opportunities for professional development and teacher/staff collaboration with Coast Union High School. Other professional development opportunities are scheduled throughout the year covering a variety of topics (technology in education, common core implementation, classroom management strategies, English Language Learner strategies, etc). Additionally, credentialed teachers meet daily to discuss curriculum development and implementation.

5. Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA)

Student performance and teacher needs are assessed as the basis for professional development offerings.

6. Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC)

Beyond professional development and trainings, teachers are given additional support through constructive feedback from colleagues and administration, along with collaboration time with staff from Coast Union High School.

7. Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

There are no department meetings at Leffingwell because of its small size, however the teacher attends Coast Union High School staff meetings and is able to collaborate with teachers at CUHS on a regular basis. However, both teacher discuss curriculum daily and co-teach multiple subjects.

Teaching and Learning

8. Alignment of curriculum, instruction, and materials to content and performance standards (ESEA)

All curriculum and instruction at Leffingwell is aligned to the California Common Core State Standards. Leffingwell uses the state minimum graduation requirements and offers courses to meet them. Courses offered include English, Government/Economics, Algebra 1, Geometry, Marine Biology, Art, Physical Science. English class placement is based on NWEA data. Additionally, elective credits are aligned with career and personal goals. All students are on an independent contract to meet the 270 credits required for graduation. Students are also required to complete a community service obligation of 60 hours. Curriculum is aligned to career and college goals.

All students, including English Learners and students receiving 504 services, are instructed using standards-based instructional materials that mirror those used at CUHS.

12. Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

All courses and materials are standards-aligned, including intervention courses and materials and have been approved by the Coast Unified School Board.

Opportunity and Equal Educational Access

13. Services provided by the regular program that enable underperforming students to meet standards (ESEA)

Services provided by the regular program that enable underperforming students to meet standards include the use of school-wide, research-based instructional practices, and multi-modality instruction (instruction given visually, auditorally, kinesthetically, high use of technology). Student teacher ratio at continuation high schools is capped at 15:1, allowing for individualized instructional programs for all students.

14. Research-based educational practices to raise student achievement

Research-based curriculum and instructional practices are implemented school-wide. Students also partake in project-based learning with many hands-on projects and community service projects conducted on campus. Students also participate in research-based social-emotional curricula as well as weekly group and monthly individual counseling.

Parental Involvement

15. Resources available from family, school, district, and community to assist under-achieving students (ESEA)

Leffingwell High School greatly benefits from its supportive parents who are in regular contact with the school. The school also benefits from several community partnerships, including Friends of Fiscalini Ranch Preserve, Greenspace, Cambria Services District Fire Department, Coastal Discovery Center.

16. Involvement of parents, community representatives, classroom teachers, other school personnel, and students in secondary schools, in the planning, implementation, and evaluation of ConApp programs (5 California Code of Regulations 3932)

School staff and stakeholders meet regularly to discuss school needs, goals and progress, whether in conferences or School Site Council meetings.

Funding

17. Services provided by categorical funds that enable underperforming students to meet standards (ESEA)

Coast Unified is a Basic Aid school district. LHS does not receive categorical funding, other than Title III which helps to pay for ELD supplemental materials.

18. Fiscal support (EPC)

Description of Barriers and Related School Goals

75% of students at Leffingwell High School come from socio-economically disadvantaged households. Many students enrolled at LHS are credit deficient. A lack of parental support and involvement is a hinderance. Due to the small size of the school, data is not report from state test. The lack of state reported and small sample size makes it difficult to determine patterns.

Increasing overall academic achievement and success are goals of Leffingwell High School. Goals are based on local testing data (NWEA) and stakeholder input. Students receive an individualized instructional program based on graduation needs and interest.
