FERPA in Common App

The **FERPA Release Authorization** is the first requirement in the Recommenders and FERPA section. The FERPA release will ask if you would like to <u>waive your FERPA rights</u>. This means that you will not be able to request access to your educational records like letters of recommendation.

It is recommended that you waive these rights but be sure to **check with your counselor**. <u>In Scoir you will also be asked to complete a FERPA release</u>. Be sure the answers on both releases are the same!
