5. What do you see as the basic purpose of public schools?
Public schools are accountable for student achievement, including state standards, attendance, and goals. It provides social-emotional learning. Public schools support
teachers and promote technology and STEM learning. The public school aims to keep student records, financial management, and communication.

Governing board sets priorities, creates policies, and considers outcomes for the schools it oversees.
7. How does the board's role differ from that of the superintendent?
The Board of Education is elected differently than the superintendent because boards set priorities, create policies, and consider outcomes. In comparison, superintendents have a job to pinpoint policies or needs, regulate rules, and manage the daily operation of the district.

All parties should share their voice to address concerns. We need to have active communication to develop goals regarding achievement and instruction.
