Sherwin Chen (MPCSD Board Member) provided an overview of Measure B, which proposes a replacement parcel tax (\$598 per parcel -- a total \$4.6M per year -- for 12 years) that will help secure long-term financial stability for the MPCSD schools. The Measure B Campaign is seeking an official endorsement by the Oak Knoll PTO General Membership. Corey Binns noted that there is no organized opposition campaign for Measure B, and that is the reason there was no one present to formally present the opposing viewpoint to the General PTO Membership. Upon Sherwin's departure, Corey Binns moved to take a vote for the Oak Knoll PTO to officially endorse Measure B. Becky Bullard seconded the motion. The vote was called and the motion for the Oak Knoll PTO to officially endorse Measure B was approved unanimously.
