1. Ewe Kinikinin Sukuun Salem-Keizer a pwon pwe epwe anisi ewe nenien angang me sukuun an esapw wor emon epwe eriani emon faniten nónómwun inisin ika ii mwan are fefin ika met ii e finata an epwe sani (mwan are fefin are iir me ruu). Osufónungawa inisin emon mei ngaw me ese mwumwuta.
2. Kapin ei esinesin epwe kawor ngeni chon sukuun, ekkewe chon tumwunu ewe chon sukuun, chon angang, me chon ewe mwuun me won ewe website.
