- 2021-2022 Master Schedule needs - - **8 additional teaching units**
  - Use Title I Funding to pay for the following NEW positions (**5.53**) for the 2021-2022 school year:
    - 5 full teaching units + .53
      - **3 teachers** (*Note: currently being paid out of Title I*)
        - 2 social studies positions
        - 1 math position
      - 1 English position
      - 1 additional Math position
      - .53 to make a full position (Added to .47 unused allocation for 2021-2022)
    - 1 SPED teacher - - Paid for by District
    - Non-renewed PE position will become Family & Consumer Science position
    - Possibly 2 will come from ESSER funds

- CURRENT positions to be paid out of Title I for 2021-2022 school year:
  - Behavior Interventionist (certified) - - teaching unit + 5 extended days
  - Reading Interventionist (certified) – 128 days
  - Math Interventionist (classified) – 50 days
  - School Liaison (classified) – 180 days
- The Counsel approved by consensus to use Title I funds to pay for 5.53 new teaching positions (*salary/fringes*) in addition to the Behavior Interventionist, Reading Interventionist, Math Interventionist, and School Liaison.
