Eastern Center for Arts and Technology (EASTERN) is pleased to enter into an agreement/partnership with Bucks County School of Beauty Culture, Inc. located at 1761 Bustleton Pike in Feasterville, PA 19053. Thank you for agreeing to accept transfer cosmetology hours according to the following Bucks County School of Beauty Culture, Inc. policies:

Articulation Procedure for students who have completed more than 500 hours at EASTERN:

- Bucks County School of Beauty Culture, Inc. will accept all cosmetology (hairdressing program) student transfer hours earned at Eastern Center for Arts & Technology as long as the student possesses a high school diploma.
- All students must attend a Tour & Information session with the school's Admissions Director prior to acceptance. The director will evaluate the student's skill level, discuss the remaining hours needed to complete their training and also discuss the student's educational goals.
- All Transfer Students will be given the opportunity to explore the schools optional classes/electives available. Classes and program electives are listed in the Schools Catalog.
- The teaching staff will evaluate a students clinical skills when they start school. Any transfer student who is unsure of a specific skill, will be permitted to sit in on the class for that skill when it is being taught.

Exceptions to the above articulation agreement include:

- No hours will be accepted if they have expired.

Additional Enrollment Details:

- Transfer students are not required to purchase the Bucks County School of Beauty Culture, Inc. kit if they already have a comparable kit & supplies from EASTERN.

Students will be expected to purchase the school uniform which is sold to the student by Universal Techniques Inc., located in the same building as the school.


- If the student does not have the same textbook and workbooks used at Bucks County School of Beauty Culture, Inc., they will be required to purchase them.
- Bucks County School of Beauty Culture, Inc. will provide specific start dates to all transfer students. Each transfer student will be required to attend a School Orientation.
- Prior to starting school, all the required paperwork and documents must have been completed & submitted to the school.
- Bucks County School of Beauty Culture, Inc. will charge a transfer student by the clock hour if that student is only completing their Cosmetology hours needed for licensure. The tuition charged will be based on the most current price per hour. Charges will vary if the student elects to add classes in one of the schools optional program electives.
- The Bucks County School of Beauty Culture is a nationally accredited school. Students may choose to apply for Federal Title IV Financial Aid and the school has a Financial Aid Administrator to assist all students with this process.

Effective Date and Term: This Agreement goes into effect on December 9, 2022. The term of this Agreement shall be ongoing. The Agreement will continue in effect until it is modified by mutual written agreement or terminated by either party.


