SESSION FIVE

5.0 Student Board Members' Comments

Student Board Member Middleton reported that at her school she has joined the Young Women Empowerment Foundation that helps young women learn about their self-worth and full potential. In November with the Jobs for Graduates program at her school she will be going to Washington, DC to attend a two-day conference with other students from around the country.

Student Board Member Greg Weidler spoke about Pacific High head counselor, Ms. Prutsman, who passed away on October 7. He commented that Ms. Prutsman supported not only him but many other students. During hard times, bad times, and when the world seemed unfair and unreasonable, she was the voice of reason; she was always there for the students. When Mr. Weidler had the opportunity to become a student board member it was she that pushed him to take the opportunity. He thanked her for everything she had done for him, stating that she changed his life and she would not be forgotten.

In honor of Ms. Rebekah Prutsman, Dr. Marsden asked for a moment of silence.

SESSION SIX

6.0 Public Comments

Speaker(s): Linda Hart

Topic: Student Recovery – School First. Dr. Hart spoke on chronic absenteeism and questioned what and where students go when they are not in school and shared a student's perspective she had recently spoke with. The student said that his mom gets up early to take two buses. His older brother would make sure he got to school, but there was no accountability. He shared with Dr. Hart that to make money he and several friends would videotape themselves having sex. Dr. Hart said that if he and the others had been in school, they would be in a classroom, not out making videos. She is currently looking for someone to mentor him. She stated that intervention does make a difference and that we need to get our kids in school; to have access to a safe place; it is important for student recovery.

Dr. Marsden thanked her for sharing and said he would like to get her involved with students and asked her to reach out to Assistant Superintendent Perez. Dr. Flores thanked her for her work on chronic absenteeism and Mrs. Rodgers said that it starts with one student at a time to get them reconnected with school.

Speaker(s): Belen Vera

Topic: Sharing her experiences with severe anxiety and the Options for Youth (OFY), San Bernardino charter school. Ms. Vera is a senior at OFY and will be graduating soon. She shared her experiences with anxiety and depression and how OFY helped her through difficult times and because of their help she has been able to look forward to school, college trips, and graduating with honors. Ms. Vera shared part of her graduation speech.

SESSION SEVEN

7.0 Student Achievement

Session Seven began at 7:06 pm. Both Student Board Members left the meeting at 7:20 pm.

7.1 Overview of the State's Accountability Model, Part II

Key Performance Indicator: California Assessment of Student Performance and Progress Dr. Kennon Mitchell, Assistant Superintendent, Educational Services, provided Part II of the overview of the State's new accountability model; projected outcomes for elementary and middle school CAASPP English Language Arts/Literacy and Mathematics (grades 3-8); gap analysis for African American and English Language Learner student groups; and strategies for student improvement. (Attach. A)

Overall the District improved in English Language Arts and Mathematics, but still below the state's "Meets Standards". The Board discussed the progress District has made and the need to build off those successes; reasons for those gains; African American and Special Education student groups' decline in Mathematics from last year; whether additional funding at sites was working; accountability; strategies used by sites that have improved; number of Opportunity Gap Specialists (OGS) and the cost to get at other sites; need for progress monitoring; data review quarterly or by semester; 11th grade testing scores will be available in December; visit districts that are doing better than us; principals visit high-performing sites; collaboration with colleges for their students to earn credit by working with our students in math; test scores of students that come to school regularly versus those students that do not; older students possibly working with elementary students; funding for IB; other elementary IB's in California that are making same gains; ensure we are funding the Equity & Targeted Student Achievement Department at the right level.

Luis Chavez, Holcomb ES principal spoke on tactics their site used to make significant gains at Holcomb, including focusing on the whole child; positive behavior strategies; students set goals for themselves, develop critical thinking skills; students collaborate with other students. Teachers collaborate weekly; they get to know their students; they learn, plan, instruct, reflect and revise.

Next steps were shared with the Board, including continuing to provide technical support, training, and coaching, capacity in data literacy, structured opportunities for site leaders to collaborate together. Grow capacity of early literacy and elementary math teachers; expand math consulting support and continue to provide professional development, training and coaching support to all secondary math teachers; provide targeted focus on TSSP schools that are not demonstrating significant growth; strengthen the Multi-Tiered System of Supports with focus on African American, Special Education, and English Learners student groups.

8.5 Comments by Board Members

Member Flores shared that the California Latino School Boards Association (CLSBA) conference was very successful; Board president Medina was part of a panel, Women of Power, and she did an excellent job and represented the District well. Several of our partners and

community members also presented at the conference and San Bernardino was well represented. She thanked Cabinet for the Board correspondences, including the update on pathways, stating that the electrical workers' union, IBEW, has told her that they would like to partner with the District on possible student apprenticeships and she would like the District to reach out to them. Dr. Flores asked how the additional funds, approximately \$800,000, that were allocated for pathways and academies were being distributed and based on what criteria; Board correspondence on the charter school renewal process and asked about their periodic audit criteria and if there was a manual. She questioned if charters were being monitored as the Board has not received any reports; Board correspondence on bullying and reported that Dr. Wyatt, Mrs. Medina and she met with Drs. Marsden, Vollkommer, and Perez, Linda Bardere, and Chief Paulino to review policies on bullying, sexual misconduct and harassment. Last, Dr. Flores asked to agendize the topic of a District Mariachi band, stating she has asked for the past three years for this band.

Member Hill reported it was a great day at the Clean Air Day event at E. Neal Roberts Elementary School and she and Mrs. Rodgers attended the Pacific High assembly for Jade Maldonado. Dr. Hill also participated in the Believe Walk and she was proud to have the Pacific High cheerleaders present; attended the Chavez Middle School's new furniture unveiling, with desks that raise and lower, and said she hopes desks like this could be at all our schools. Dr. Hill congratulated Linda Bardere, Communications director and her staff on designing and producing business-size cards with the saying "throw love like confetti" on them. These were given out to Pacific High students in honor of their head counselor, Ms. Prutsman, who recently passed away and was her favorite saying. She thanked Cabinet and staff for all the good work they are doing.

Vice President Rodgers commented that she was able to attend Jade Maldonado's memorial service along with other District staff. At the service it was mentioned that a memorial scholarship in Jade's name would be created for a Pacific High student, starting at \$1,500 for the class of 2022. She reported that she attended the Hispanic Association of Colleges and Universities and it was a wonderful event. She found out that other District staff were also there, San Bernardino Valley College and Cal State, San Bernardino had students attend and she commented that Cal State would be going to look into Hispanic-Serving Institutions (HSIs) for K-12 districts whose total Hispanic enrollment is a minimum of 25% and they presented on colleges who are raising awareness of the "15 to Finish" campaign; by encouraging students to take at least 15 credits per semester in order to graduate on time. She said that many students are taking only one or two classes a semester, which can take them possibly 5 – 6 years to graduate, and ultimately many drop out. Mrs. Rodgers reported that she attended the WHO Awards, where Chief Paulino was honored and several District cadets also attended. She asked that the Counseling report under On-Going Initiatives, be looked at as a strategic plan and not just quarterly reports.

Member Wyatt had no comments.

Member Tillman reported that he spoke to someone from Options for Youth who told him that because they start school on July 1 they might be able to offer summer school at some of our campuses, we would pick the subjects, and students could earn 10 credits. Mr. Tillman spoke with Mrs. Christakos who said she would start the conversation. He would like to hear back on

whether this is actually possible to do.

President Medina reported she enjoyed attending the WHO Awards and congratulated Chief Paulino for his recognition; she also attended the Clean Air Day event and it was great to see so many students taking the Clean Air pledge; and she attended CLSBA along with her mother and daughter and commented it was the first time they heard her speak in public and they were surprised as she had always been a quiet, shy person.

8.6 Comments by Superintendent and Staff Members

Superintendent Marsden provided an update on Lankershim Elementary School's racially motivated incident reported that the District has launched an independent third party investigation in partnership with the FBI and additional parent informational meetings will be held later this week. Dr. Marsden also reported that the Policy Sub-Committee is currently reviewing existing policies regarding conduct, hate crimes, and discrimination and a first reading of revised policies is planned for the November 6th Board meeting. He said it is the commitment of the Board and himself that this behavior will not be tolerated in the District and we are actively pursuing efforts to find the individual or individuals responsible, prosecute and terminate them.

Dr. Marsden reported that a meeting was held last week with District City partners to discuss pedestrian safety concerns throughout the City of San Bernardino and to develop best solutions. District staff is also planning an upcoming safety committee meeting to further review safety needs. He provided an update on Arrowhead Grove stating he met with Sierra High School staff last week to share that no District decision had been made regarding this project. He shared that under the leadership of Dr. Mitchell, 75 principals and 150 teachers participated in two days of instructional rounds facilitated by Dr. Richard Elmore. He thanked Dr. Perez for coordinating the District's first Wellness Symposium. He reminded the Board of the upcoming Fall Joint-County Meeting with Riverside and San Bernardino County School Board associations on October 29.

Dr. Marsden congratulated the students that participated in the Latino History Bee and thanked the coordinators for a successful event. He congratulated Arroyo Valley High School teacher Laura Gallardo for being selected by the San Bernardino County Superintendent of Schools as the San Bernardino County Teacher of the Year and congratulated Board Member Hill for being selected as the recipient of the Bennie Newman Award at this year's Community Action Project gala.

Dr. Marsden asked and received Board consensus to move the December 4 Board meeting to December 11 due to Education Code requirement that the organizational meeting be held within fifteen days beginning with the first Friday in December, which falls on December 7th this year.
