4.5 <u>Public Hearing to Receive Comments on the San Bernardino City Unified School</u> <u>District's Intent to Grant to the City of San Bernardino an Easement for the</u> <u>Sunrise Lane Cul-de-sac on the District's Emmerton II Elementary School</u> <u>Campus</u> (Prepared by Business Services Division)

At its regular meeting on August 16, 2005, the Board of Education adopted a Resolution of Intent to grant an easement to the City of San Bernardino in order for the Sunrise Lane cul-desac to be constructed and to be maintained by the City of San Bernardino.

The Sunrise Lane cul-de-sac will be located at the corner of the Emmerton II Elementary School site adjacent to the intersection of Sunrise Lane (formerly known as Roca Street) and McKinley Street. The purpose of constructing the Sunrise Lane cul-de-sac is to provide a turning area for public vehicular traffic.

Pursuant to the Resolution of Intent, a public hearing upon the question of granting the above referenced easement is required to be held at the regular Board of Education meeting on September 20, 2005.

In order to adjust the program budgets, it is necessary to have Board of Education approval.

At the August 2, 200, Board meeting, the Board approved a distribution of 80 percent of the estimated carryover and fund balances from fiscal year 2004-2005. The fiscal year 2004-2005 books are officially closed. The actual final carryover and fund balance amounts have been determined. The following represents the final adjustments to the current year program budgets that result from the carryover of these funds.

The unrestricted program, Bleachers (AVHS) Program (047), was not included in the 2005-2006 approved budget. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$618,000.00 in expenditures and decrease of \$618,000.00 in the unrestricted fund balance will result in a revised total of \$618,000.00 in expenditures.

The unrestricted program, Textbook Adoptions Program (097), was included in the 2005-2006 approved budget in the amount of \$4,250,000.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$1,872,414.22 in expenditures and decrease of \$1,872,414.22 in the unrestricted fund balance will result in a revised total of \$6,122,414.22 in expenditures.

The restricted program, RDA Mt. Vernon Entitlement (120), was included in the 2005-2006 approved budget in the amount of \$192,900.00. Based on the final restricted fund balance from fiscal year 2004-2005, an increase in the amount of \$76,904.00 in expenditures and decrease of \$76,904.00 in the restricted fund balance will result in a revised total of \$269,804.00 in expenditures.

The restricted program, RDA Highland Entitlement (121), was included in the 2005-2006 approved budget in the amount of \$721,600.00. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$485,438.00 in expenditures and decrease of \$485,438.00 in the restricted fund balance will result in a revised total of \$1,207,038.00 in expenditures.

The unrestricted program, Information Technology Deferred Maintenance Program (153), was not included in the 2005-2006 approved budget. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase in the amount of \$186,046.05 in expenditures and decrease of \$186,046.05 in the unrestricted fund balance will result in a revised total of \$186,046.05 in expenditures.

The unrestricted program, E-Rate Phone Technology Program (172), was included in the 2005-2006 approved budget in the amount of \$815,982.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase in the amount of \$150,683.22 in expenditures and decrease of \$150,683.22 in the unrestricted fund balance will result in a revised total of \$966,665.22 in expenditures.

The unrestricted program, INAP (203, 204, 205), was included in the 2005-2006 approved budget in the amount of \$5,540,084.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$21,326.00 in expenditures and decrease of \$21,326.00 in unrestricted fund balance will result in a revised total of \$5,561,410.00 in expenditures.

The restricted categorical program, School Library Materials Entitlement (210), was included in the 2005-2006 approved budget in the amount of \$86,900.00. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$29,825.00 in expenditures and decrease of \$29,825.00 in restricted fund balance will result in a revised total of \$116,725.00 in expenditures.

The restricted categorical program, Instructional Material Funding Realignment (211), was included in the 2005-2006 approved budget in the amount of \$1,556,820.00 for revenue and \$3,180,620.00 for expenditures. The difference of \$1,623,800.00 is funded from the previous year's estimated fund balance. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$643,817.00 in expenditures and a decrease of \$643,817.00 in restricted fund balance will result in a revised total of \$3,824,437.00 in expenditures and \$1,556,820.00 in revenues.

The restricted categorical program, Classroom Library Materials K-4 (219), was included in the 2005-2006 approved budget in the amount of \$2,100.00. Based on the final restricted fund balance from fiscal year 2004-2005, a decrease of \$2,100.00 in expenditures and an increase of \$2,100.00 in restricted fund balance will result in the deletion of the program.

The restricted categorical program, Williams Case-School Facilities Needs Assessment (241), was not included in the 2005-2006 approved budget. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$449,510.00 in expenditures and a decrease of \$449,510.00 in restricted fund balance will result in a revised total of \$449,510.00 in expenditures.

The restricted categorical program, Williams Case-Instructional Materials (242), was not included in the 2005-2006 approved budget. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$2,923,224.00 in expenditures and a decrease of \$2,923,224.00 in restricted fund balance will result in a revised total of \$2,923,224.00 in expenditures.

The unrestricted program, Furniture and Equipment Program (246), was included in the 2005-2006 approved budget in the amount of \$939,258.78. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase in the amount of \$1,109,983.78 in expenditures and decrease of \$1,109,983.78 in the unrestricted fund balance will result in a revised total of \$2,049,242.56 in expenditures.

The restricted categorical program, Class Size Reduction-Facilities (263), was included in the 2005-2006 approved budget in the amount of \$102,700.00. Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$27,436.00 in expenditures and a decrease of \$27,436.00 in restricted fund balance will result in a revised total of \$130,136.00 in expenditures.

The unrestricted program, 2000-2001 Governor's Performance Award (270), was included in the 2005-2006 approved budget in the amount of \$256,800.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$49,436.00 in expenditures and decrease of \$49,436.00 in unrestricted fund balance will result in a revised total of \$306,236.00 in expenditures.

The unrestricted program, One Time Site Carryover (272), was included in the 2005-2006 approved budget in the amount of \$120,300.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$23,709.00 in expenditures and decrease of \$23,709.00 in unrestricted fund balance will result in a revised total of \$144,009.00 in expenditures.

The unrestricted program, Governor's Performance Award (276), was included in the 2005-2006 approved budget in the amount of \$106,200.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$24,852.00 in expenditures and decrease of \$24,852.00 in unrestricted fund balance will result in a revised total of \$131,052.00 in expenditures.

The unrestricted program, Prior Years One Time Site Block Grant (277), was included in the 2005-2006 approved budget in the amount of \$30,400.00. Based on the final unrestricted fund balance from fiscal year 2004-2005, an increase of \$4,178.00 in expenditures and decrease of \$4,178.00 in unrestricted fund balance will result in a revised total of \$34,578.00 in expenditures.

Based on the final restricted fund balance from fiscal year 2004-2005, an increase of \$6,408.00 in expenditures and a decrease of \$6,408.00 in restricted fund balance will result in a revised total of \$95,251.00 in revenue and \$101,659.00 in expenditures.

> 9.38 <u>Payment of Settlement in Case No. SCVSS 121193, Michael G. Fischer, dba</u> <u>Fischer Plumbing v. San Bernardino City Unified School District, a Public Entity,</u> <u>and Does 1 through 30, Inclusive</u> (Prepared by Business Services Division)

On October 7, 2003, the San Bernardino City Unified School District entered into a written agreement with Fischer Plumbing for plumbing work set forth in Bid Package No. RA-12 at Roger Anton Elementary School.

A dispute arose between Fischer Plumbing and the District regarding the scope of work to be performed by Fischer Plumbing pursuant to the Contract. On December 16, 2003, Fischer Plumbing submitted to the District a request for extra work authorization and a notice of delay damages. Concurrently, the District asserted that Fischer Plumbing was delaying the project and was not entitled to an extra work authorization. The District advised Fischer Plumbing that it was terminating the Contract for convenience, as described in the General Conditions, Section 1.18 of the Contract.

On January 14, 2004, Fischer Plumbing submitted a claim to the District in which it alleged that the District wrongfully terminated the Contract for convenience and that Fischer Plumbing suffered damage in an amount of \$317, 538.00. On February 17, 2004, the District rejected the claim of Fischer Plumbing. Fischer Plumbing filed a Complaint against the District in the Superior Court for the County of San Bernardino, on November 15, 2004, alleging that the District had breached the Contract and breached the implied covenant of good faith and fair dealing. On March 14, 2005, the District filed an answer to the complaint in the lawsuit, denying any liability to Fischer Plumbing.

On July 19, 2005, Fischer Plumbing made a settlement offer to the District in the amount of \$10,000.00, in full and final satisfaction of all claims of Fischer Plumbing relating to the Contract, the project and the lawsuit.

It is recommended that the following resolution be adopted:

BE IT RESOLVED that the Board of Education approves payment of the Settlement in Case No. SCVSS 121193, Michael G. Fischer, dba Fischer Plumbing v. San Bernardino City Unified School District, a Public Entity, and Does 1 through 30, Inclusive, in the amount of \$10,000.00, charged to Fund 35, Account No. 9707.

BE IT FURTHER RESOLVED that the Board of Education authorizes Mohammad Z. Islam, Assistant Superintendent, Business and Finance, to sign necessary documents related to the settlement and payment thereof.

The pupil and his/her family stipulate the facts of the case as presented by the school, accepting one of the following consequences: * (S) suspended expulsion, **(S) expulsion one semester, suspended expulsion one semester, (S) expulsion two semesters.
