# NOTICE OF AVAILABILITY AND PUBLIC HEARING FOR THE PRELIMINARY ENVIRONMENTAL ASSESSMENT (PEA) PROPOSED HIGH SCHOOL NO. 8, PARCEL B

Pursuant to the California Education Code Section 17213.1(a)(6)(A), the San Bernardino City Unified School District (SBCUSD) hereby gives public notice that a PEA has been prepared for the proposed High School No. 8, Parcel B project. The SBCUSD has submitted the PEA to the California Department of Toxic Substances Control (DTSC) for review and approval pursuant to the California Education Code Section 17213.1(a)(5). The PEA is available for public review and comment, and the SBCUSD will hold a Public Hearing on the PEA.

**Project Location:** The subject property is the existing Curtis Middle School, located at 1472 East 6th Street, in San Bernardino, California 92410 (Site) (Figure 1). The Site consists of approximately 19 acres and is part of the land proposed for use in the construction of San Bernardino City Unified School District High School No. 8. This portion of the proposed High School No. 8 project is referred to as Parcel B.

**PEA Status:** The DTSC is currently reviewing the PEA prepared for the proposed school site. Pursuant to the California Education Code requirements, the DTSC must consider and approve the PEA in order for the SBCUSD to proceed with the project.

**Public Review:** The SBCUSD has elected to make the PEA available for public review and comment pursuant to the California Education Code Section 17213.1(a)(6)(A). The public review period begins on January 9, 2006 and ends on February 8, 2006. During this period, the SBCUSD will receive written comments on the PEA. The DTSC will review the PEA concurrently and must either approve or disapprove the PEA within 30 days after the close of the public review period. PUBLIC HEARING AND NOTICE OF INTENT TO ADOPT A PRELIMINARY ENVIRONMENTAL ASSESSMENT FOR THE PROPOSED MUSCOY MIDDLE SCHOOL (No. 48) SAN BERNARDINO, CALIFORNIA

The San Bernardino City Unified School District (School District) is interested in building a new middle school on a site located between Darby, Duffy, Blake, and Macy Streets, in Muscoy, California. State laws require that all proposed public school sites undergo a comprehensive environmental assessment and review. This notice is to inform you that an environmental assessment has been completed and of its availability for public review and comment.

The San Bernardino City Unified School District has prepared a Preliminary Environmental Assessment (PEA) in accordance with the California Education Code (CEC) Section 17213.1(a)(4)(B). The PEA was prepared under oversight of the California Environmental Protection Agency, Department of Toxic Substances Control (DTSC) and the PEA was forwarded to DTSC for its review on January 9, 2006. The School District has also chosen to make the PEA available for public review and comment pursuant to CEC Section 17213.1(a)(6)(A).

Project Site Location: The site is located between Darby, Duffy, Blake, and Macy Streets, in Muscoy, California. The site has not yet been assigned an address.

Project Site Description: The site is approximately 25 acres and is currently developed with residential housing, a fire station, a church, and the Muscoy Grange. Some limited agricultural production may have occurred on the northwest side of the Site through 1977. A number of power poles with transformers are located on Darby and Duffy Streets, and these transformers may have been filled with polychlorinated biphenyl (PCB)-containing fluid in the past. The site was investigated for organochlorine pesticides and metals to determine the potential impacts from pesticides associated with past agricultural activities. The Site was also investigated for potential PCB contamination associated with the pole-mounted transformers. In addition, the site was investigated for total petroleum hydrocarbons, volatile organic compounds, semivolatile organic compounds, PCBs, and metals in an area where empty 55-gallon drums were observed. The results of the PEA indicate that no chemicals are present at the Site in concentrations that are considered likely to cause adverse health effects. The PEA concludes that no further action is warranted for the Site for the areas investigated. Existing structures on the Site that were constructed before the ban of lead-based-paint (LBP) in 1978 may contain LBP. In addition, records indicate a battery manufacturing business may have been located on the Site in the past. LBP on existing structures and the potential past presence of a battery manufacturing business will be investigated by the School District after acquisition of the property.

District Eligible State Programs
(Prepared by Business Services Division)

California Education Code Section 41500 specifies that the governing boards of school districts may expend in a fiscal year up to 15 percent of the amount apportioned for the block grant set forth under Education Code Section 41500 for any other programs for which the school district is eligible for funding, including programs whose funding is not included in any of the block grants established under this code section. Before a school district or county office of education may expend the funds, it is required to discuss the matter at a noticed public meeting.

The transfer of these funds is intended to enhance the development of district programs to more fully meet the goals of the district and the needs of our students.

This public hearing is being held to enable additional input by parents, teachers, members of the community, and bargaining union leaders in order to comply with Education Code 41500.

6.2 <u>Proposed Associated Student Body Policy (First Reading)</u> (Prepared by Business Services Division)

### ASSOCIATED STUDENT BODY

The Superintendent or designee shall have the responsibility and authority to implement all policies and procedures pertaining to supervision and administration of student activity funds. The Superintendent or designee shall periodically review the organizations' general financial structures and accounting procedures. The site principal, as trustee, shall have ultimate responsibility for the conduct of student financial activities and the overall operation of the fund.

A) The constitution and bylaws of each student body organization shall contain a budget philosophy, and general rules and regulations for management of student body funds, including provisions for an annual budget. Student organizations may raise and spend money in order to promote the general welfare, morale, and educational experiences of the students. Student funds shall finance worthwhile activities, which go beyond those

provided by the District. Minutes shall be kept of student organization meetings and shall properly reflect all financial activities.

Student funds shall be managed in accordance with sound business procedures designed to encourage the largest possible educational return to students without sacrificing the safety of funds or exposing students to undue responsibility or unnecessary routine.

Student funds shall be disbursed according to procedures established by the student organization. All disbursements must be approved by a Board-designated official, the certificated employee who is the student organization advisor and a student organization representative.

- 1. Projects and activities of student bodies shall have only two purposes:
  - a) to promote the general welfare, education, and morale of the majority of students; and
  - b) to finance approved extracurricular activities
- 2. With Governing Board approval, student funds shall be held or invested in one of the following ways:
  - a) Deposited or invested in a federally insured bank or savings and loan or in a state or federally insured credit union.
  - b) Invested in U.S. savings bonds or obligations.
  - c) Loaned to other district student organizations or invested in district property improvements pursuant to Education Code 48936.
- B) All student clubs shall be composed entirely of students enrolled in schools of the District. Any group of students shall apply for permission to form a club by submitting for approval to the Board authorized authority, a proposed constitution which specifies among other things, a) the title, power and duties of various officers, and how elected, b) the scope of proposed activity and c) the name of the advisor. The class or club accounts shall be subject to the same standard procedures for cash receipting and disbursement as the general associated student body and shall be handled through the associated student body bookkeeper. Proper records shall be maintained and minutes showing approval for all transactions shall be kept.
  - 1. No disbursement shall be made from class or club accounts that will result in a deficit of the club account.
  - 2. All club funds shall be for the benefit of the club and shall not be used for any purpose other than established in the charter of the club.
- C) Fund-raising activities held at a school for the benefit, in whole or in part, of that school, or of any organization directly under control of school authorities, must be sponsored by an organization directly under the control of school authorities.

# 1. Solicitation of Funds From and By Students

The Governing Board recognizes that student participation in fund-raising activities of the schools and nonprofit, nonpartisan charitable organizations can help develop a sense of social responsibility in students, enhance the relationship between the school and community, and contribute to the improvement of the school program.

Whether solicitations are made on behalf of the school or on behalf of a charitable organization, students shall not be barred from an event or activity because they did not participate in fundraising. Potential donors, including parents/guardians and members of the community, should not be unduly pressured to contribute to the school system or charitable organization. Staff is expected to emphasize the fact that donations are always voluntary.

The Superintendent or designee shall ensure that parents/guardians are informed of the purpose of the fund-raisers.

#### 2. Solicitations on Behalf of the School

With the prior written approval of the Superintendent or designee, official school-related organizations may organize fund-raising events involving students.

After the fund-raiser has been held, parents/guardians shall be informed how much money was raised and how it was spent.

#### 3. Solicitations on Behalf of Charities

When approved in advance by the Superintendent or designee, nonprofit, nonpartisan organizations that are properly chartered or licensed by state or federal law may solicit students on school grounds during school hours and within one hour before school has opened and one hour after school has closed.

- D) The Board of Education policies and guidelines govern food sales by student organizations on school premises, including vending machine sales.
- E) Books and accounts of associated student body funds shall be audited in conformance with legal and district requirements. Auditing cost shall be paid from district funds.

#### F) Fraud Prevention and Investigation

The Board expects all employees, Board members, consultants, vendors, contractors, and other parties maintaining a business relationship with the District to act with integrity and due diligence in duties involving the District's fiscal resources.

The Superintendent or designee shall be responsible for developing internal controls, which aid in the prevention and detection of fraud, financial impropriety, or irregularity within the district. Each member of the management team shall be alert for any indication of fraud, financial impropriety, or irregularity within his/her area of responsibility.

An employee who suspects fraud, impropriety, or irregularity shall immediately report those suspicions to his/her immediate supervisor and/or the Superintendent or designee. The Superintendent or designee shall have primary responsibility for any necessary investigations in coordination with legal counsel and other internal or external departments and agencies as appropriate.

The Board of Education adopted manuals: Associated Student Bodies Legal Aspects for Hands On Accounting for Organized Associated Student Bodies and Associated Student Bodies Legal Aspects and Hands On Accounting for Unorganized Student Bodies shall be the established procedures for operating the ASB funds of the District. (Approved 11/15/2005.)

10.2 <u>District Consolidated Application for 2005-2006 (Part II)</u> (Prepared by Deputy Superintendent's Office)

At a meeting on July 12, 2005, the Board of Education approved the submission of the 2005-2006 District Consolidated Application-Part I to the State Department of Education. Part I of the application declared the District's intent to apply for 2005-2006 funding of Consolidated Aid Programs and consisted of the District's assurances regarding the addition of programs into the District's ranking and/or a list of schools to be funded under various state and federal programs included in the Consolidated Application.

At this time, formal approval to submit Part II of the Consolidated Application is requested. The application was reviewed by the District Compensatory Education Advisory Council on January 18, 2006, and by the District English Learner Advisory Committee Board on January 6, 2006. Part II consists of the budget portion of the application. The total entitlement for all programs included in the application is \$43,066,107.00. The application included funding for Economic Impact Aid Programs (State Compensatory and Limited English Proficient programs); PAR (Peer Assistance and Review Program); TUPE (Tobacco Use and Prevention Education); Title I, Part A (Improving the Academic Achievement of the Disadvantaged); Title II, Part A (Teacher Quality); Title II, Part D (Technology); Title III, Part A (LEP); Title IV (Safe and Drug Free School Communities); and Title V (Innovative Programs).

It is recommended that the following resolution be adopted:

BE IT RESOLVED that the Board of Education approves submission of the District Consolidated Application-Part II for Categorical Funds in the amount of \$43,066,107.00.

#### 10.3 Approval of Instructional Improvement Plans, 2005-2006 (Prepared by Deputy Superintendent's Office)

The State Education Code requires each school that operates with categorical funds annually submit a Single Plan for Student Achievement to be approved by the local school board. When funded by Title I, schools may operate as Targeted Assistance Schools where specific Title I students are identified to receive Title I services, or they may operate as Schoolwide Programs where funds are focused on a program that ensures academic achievement for all students. Schools also have the option to become School-Based Coordinated Programs. Under this option, the school gains flexibility in the use of categorical support services. All plans are reviewed for quality and legal compliance and are recommended for approval as submitted.

# 10.10 <u>Sale of Used District Computer Equipment and Peripherals</u> (Prepared by Business Services Division)

The Purchasing Department requests Board of Education approval to sell surplus obsolete computer equipment and peripherals, including but not limited to, CPUs, monitors, keyboards, mice, printers, servers, and storage devices, in accordance with Education Code Section 17545. Most of the computers and printers are not complete working systems.

These computers and peripherals are no longer of use to the District and not suitable for donation, due to their age and lack of software support. During the recycling process, all computer equipment will be destroyed.

Bid 09-05 was awarded by the Board of Education on May 17, 2005, to E-Recycling of California, Paramount, CA, as the highest responsible bidder for the purchase of used District computer equipment and peripherals for recycling.

All plan costs for the PARS 457(b) Deferred Compensation Plan will be paid for by plan participants. Proposals were received from the following vendors:

The TDS Group/American United Life, Carmichael, CA; The TDS Group/Security Benefit Carmichael, CA; Public Agency Retirement Services Irvine, CA; Orange County Teachers Federal Credit Union Santa Ana, CA; Mass Mutual Financial Group, Houston, TX.

A selection committee reviewed the proposals and recommends Public Agency Retirement Services (PARS) as the successful vendor.

Public Agency Retirement Services (PARS) is a leading specialist in retirement plans for school districts. Under the program, PARS will provide the following: (1) customized plan design services; (2) plan administration services; and (3) participant and customer services.

All plan costs for the PARS 457(b) Deferred Compensation Plan will be paid for by plan participants. Based on the established fee schedule the total fee that will be applied to participants will be 1.50% of plan assets in the first year. As assets grow, this asset fee percentage will decrease based on the fee schedule. It is estimated that an employee contributing the current maximum amount of \$14,000.00 for the year in equal monthly contributions would incur approximately \$115.90 in fees for the year. There is no cost to the District. All plan costs will be disclosed by PARS to District employees prior to their entering into the plan.
